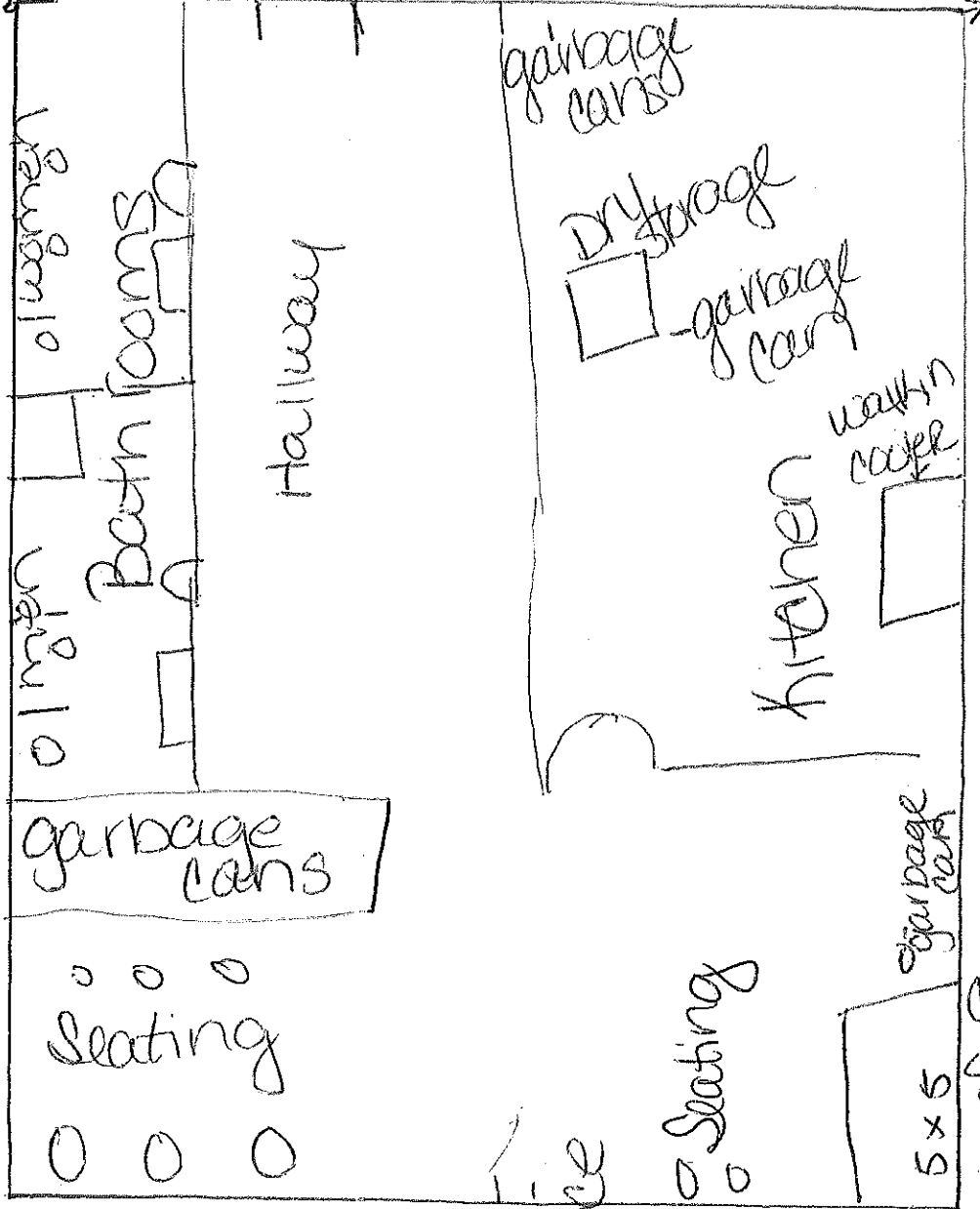

8. On 01/21/07 at 1:56 am, Milwaukee Police were dispatched to 7607 W Hampton for a shots fired complaint. As squads were responding, the call was updated to a shooting. Officers checked the area for a shooting victim and could not find one. Officers asked the security guards for Diamonds who was shot and received no response from them. Officers entered the tavern and began asking if anyone was shot and observed employees picking up bar stools that were knocked over, sweeping the floors, wiping down tables and the bar. Officers were approached by the tavern owner, Humphrey Nangah, who stated that shots were not fired inside the tavern but outside. Nangah further stated that he believed the person who was shooting the gun was a subject who was refused entry into the tavern. Nangah could not provide a description of the actor. Officers then observed a broken window with a bullet hole. Security cameras were found in the tavern but officers were told they were not working.
9. On 02/22/07 at 10:28 pm, Milwaukee Police were dispatched to 76th/Hampton for a Battery Cutting complaint. Investigation revealed no victim but officers observed blood on the sidewalk and in the parking lot of Diamonds tavern. Further investigation revealed an argument between two patrons who were brothers, took place outside with one brother cutting the other with a box cutter. The victim suffered two lacerations that required stitches.

The owner, Humphrey Nangah, stated he was not there at the time of the shooting and didn't know anything about it. Officers were told by other witnesses that Nangah was in his vehicle with an unknown female, which was parked on the east side parking lot of Diamonds the entire time. Both the bartenders and Nangah were uncooperative with police and NO ONE called police when the shooting occurred. A patron inside the tavern called 911. The victim was deceased as a result of the gunshot wounds.

The applicant was on scene and stated that he was having a Christmas party that started at Noon. Something happened by the pool table and a patron started a fight. INITIAL INVESTIGATION

This report is written by Police Officer Andrew WILKIEWICZ, assigned to District 7, Late Power Shift.

On Wednesday, May 29, 2019, at approximately 8:30 P.M., Squad 7441, Police Officer Charles SCAIFE and I, responded to 7607 W. Hampton Ave., Diamonds Bar, for a shooting complaint. Upon arrival, it was discovered that shots were fired outside the front door of the tavern and that nobody was actually shot.

This incident was captured on the taverns security system in its entirety. The following is a synopsis of what I observed from the video footage.

A physical altercation began inside the tavern between several female patrons. Two security guards were observed working, one of which, Jeramlee T. MCFARLAND (B/M, 6/4/84), stated that he was working the door and checking each patron for weapons by conducting pat downs and searching purses and bags. Both MCFARLAND and the other security guard worked quickly to remove the fighting parties outside of the bar and prevented them from returning inside the establishment.

While outside, an unknown female, produced a firearm from a purse that was brought out by another female, who was later identified as Tomesha S. WARD (B/F, 7/9/85) while standing on the side walk in front of the tavern. MCFARLAND was standing right beside the unknown female with the firearm immediately took control of the females arm, who began firing shots from the pistol. MCFARLAND was observed fighting with the female who was firing rounds in several different directions with as many as 30 patrons were outside the tavern as well as other neighborhood traffic. I observed the unknown female break free from MCFARLAND and she still had the pistol in her possession. The unknown female began running eastbound on the sidewalk while firing the pistol in an easterly direction.

I was able to review security footage from 76th Street Steak and Potato, 7601 W. Hampton Ave. as the unknown female with the pistol ran into the parking lot between Diamonds and 76th Street Steak and Potato. The unknown female is observed still carrying a pistol and engages in a physical altercation with two other females, who at one point were pushed to the ground and the unknown female is seen pointing the firearm directly at the two female victims. It appears on the video that the unknown female attempted to pull the trigger of the firearm while it was pointed at the female, but was either out of ammunition or the firearm malfunctioned.

Another camera depicts the unknown female, still armed with the pistol, and WARD in the parking lot to the west of Diamonds enter a white Jeep Patriot. The security camera was able to capture a license plate of ACW-3564, which is registered to WARD and ultimately how WARD was identified. The owner of Diamonds, Humphrey F. NANGAH (B/M, 4/14/64), was able to positively identify WARD as the driver of the vehicle that left the scene with the unknown female with the firearm.

At the time this report was authored, a suspect alert has been issued for WARD and the Jeep has been found and a search warrant has been conducted on the Jeep. The unknown female with the firearm has not been identified at this time.

I spoke to MCFARLAND regarding an individual being able to bring a firearm into the tavern and MCFARLAND stated that he checks every individual who comes into the tavern. I did observe a full sized metal detector at the front door, but it did not appear to be operational.

All employees of Diamonds was fully cooperative during the entirety of the investigation.

This concludes my report.

Nangah stated that he has made it clear to his security that whomever is at the door has to check everyone and anyone every time they enter no matter what.
