Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

- 16. INCIDENT: On 03/18/2001 at 12:31 AM officers responded to the licensed premises at 1101 N Water St, The Water Street Brewery regarding a Battery complaint. Investigation revealed that a waitress, while working, was hit over the head with a ketchup bottle by a cook from the tavern, after that cook was suspended from work. The cook was arrested and charged with Substantial Battery. Incident Report Filed
- 17. On 07/16/2001 at 3:35 PM officers made a lawful inspection of the licensed premises at 1122 N Edison St, Ruby's, for which the applicant is the licensee. Officers discovered an unlicensed bartender working there and no other licensed person on the premises. The manager of the premises, Anthony HEROLD returned to the licensed premises about 10 minutes later. He was cited for Responsible Person Upon licensed premises.
- On 05/16/2003 at 10:50 PM a 19-year-old Police Aide, under the direction of Police Officers entered the licensed premises at 1101 N Water St, Water Street Brewery and purchased a wine cooler from a bartender without having her ID checked. The bartender was cited for Sale to Underage (Case Pending 07/09/2003). The applicant was not on the scene at the time and was not cited. Incident Report Filed.
- 19. Incident. On 9-14-2003 at 12:11am Milwaukee Police were dispatched to 1114 N Water St., Brew City Bar B Q regarding a fight. The General Manager of Brew City stated that 2 males were causing a fight inside the bar and were escorted outside of the premise. The officers talked to one of the fighters outside who stated that he was punched in the face by a male, grabbed around the waist, picked up and thrown to the ground. A Substantial Battery had occurred and a warrant was issued for the suspect.
- 20. Incident. On 9-28-2003 at 2:05am Milwaukee police responded to a call for a large crowd at N Water & E Highland. A call was made for additional squads by the squad that was initially sent. Observed was a large crowd letting out of Brew City Bar B Q, loitering about the outside and obstructing northbound traffic on Water St. Several squads had responded and people were moved out of the street to re-open it to traffic. One arrest for Disorderly Conduct and one arrest for Assault & Battery from 2 separate incidents occurring during this investigation.

- 21. Incident. On 10-18-2003 at 12:28am Milwaukee Police were flagged down regarding a person with a gun complaint. The complainant stated that while inside Brew City Bar B Q he became involved in an argument with another male. The bar staff observed the argument and escorted both persons off of the premise. Once outside, both males again became involved in an argument and one lifted his shirt and was observed by the other to have a small handgun in the waistband of his pants. The police were called. During the investigation, the suspect with the gun fled from the police, but in the process an officer observed a small caliber black handgun fall from the fleeing suspect. The suspect was subsequently arrested for Carrying Concealed Weapon and Disorderly Conduct While Armed.
- On 2-09-04, at 10:00PM, Milwaukee police, along with an Inspector from the Department of 22. Neighborhood Services, went to 1114 N Water St, Brew City Bar B-Q, to conduct a license and Fire Inspection. Robert C Schmidt is the licensee of this premises. The Certificate of Occupancy was not posted in a conspicuous place.

- INCIDENT On 4-25-2004, at 1:41PM, Milwaukee police investigated a battery complaint at 23. Police District #1. A Joseph Reichart stated that on 4-24-2004, between midnight and 1:00AM, at the Brew City Bar-B-Q, 1114 N Water Street, one of the bouncers forcefully pushed him to the ground just outside the business. He stated that he, Reichart, was intoxicated and did have additional drinks at Brew City. Security personnel from Brew City, later stated that they escorted Reichart from the tavern, but that 3 males went out of the tavern and got into an altercation with Reichart and that one of the males punched Reichart. Reichart was treated at Veterans Hospital for abrasions to his face and body and a fractured left arm. Robert C Schmidt is the licensee of these premises. Report filed.
- On 8-6-2004, at 10:30PM, officers, along with two underage police aides, conducted a 24. premises check at Rudy's Mexican Restaurant, 1122 N Edison Street. Robert C Schmidt is the licensee of these premises. The police aides, 19 & 20 yrs old, went into the above establishment and ordered two Corona beers. The bartender, Bernice Cruz, served them without asking for identification or verification of age.

26. On 10-10-04, at 2:25AM, officers were flagged down by a citizen near Brew City Bar B Q, 1114 N Water Street. They observed security from Brew City clearing the sidewalk of pedestrians after the bar closed. The citizen told officers he observed a male jump on one of the security, and then another male "got in the face of the security", and began yelling at them. He observed 5-6 subjects fighting, and he helped the bouncers break it up. At that time he was punched in the side of the head, and flagged down police. Officers spoke to another person, who said he was head butted by one of the bouncers, and wants his name, so he can sue him. The officers spoke to a Robert A Johnson, male/11-22-78, who works at Brew City as a manager. He was very uncooperative and intoxicated during the interview. He stated he did not known what was going on and why we were talking to him. He said he was not involved in any fights outside, and was not willing to give us any information regarding the incident. The officers spoke to Daniel J Van Roy, male/ 1-29-79, who works there as a manager, also. He said he saw a male pull a sign off the wall and instructed the subject to leave, but he refused. Van Roy attempted to escort the subject out, but observed 5-6 subjects coming at him, and with help of other bouncers were able to remove the subject from the bar. He said he did not go outside the bar and was not involved in any other fights. There were numerous conflicting stories. Report filed.

NOTE: The above information was submitted with previous Class B tavern renewals filed in 2005.

27. On 11/25/07, Milwaukee police were dispatched to 125 E Juneau for a Battery complaint. Police spoke to the doorman J Justin Van Meter who stated an injured subject tried to enter the tavern and appeared extremely intoxicated and was not able to provide Van Meter with any ID. The subject was asked to leave and the subject became disorderly and tried to enter the tavern. Van Meter grabbed the subject by the arm to escort him out of the vestibule area of the tavern when the subject punched Van Meter in the left eye. Van Meter then pushed the subject outside with the subject falling and hitting his head on the curb. Officers also spoke to a witness who confirmed what Van Meter stated. A citation was issued to the suspect for Assault and Battery.

29. On 08/14/10 at 1:50 am, Milwaukee police were dispatched to 125 E Juneau Avenue for a Theft complaint. Investigation revealed a patron was stealing purses inside the tavern and an employee observed her attempt to steal another when she was stopped from leaving the tavern and detained for police. The suspect was arrested and charged with theft.

- 30. On 11/10/2013 Milwaukee police responded to 125 East Juneau Avenue (Trinity Bars Night Club) for a Trouble with a Subject. Investigation revealed there was an argument between two of the patrons of the business. One of the patrons threw a glass at the other, resulting in the victim's mouth being injured.
- 31. On 04/27/2014 Milwaukee police observed a disturbance at 125 East Juneau Street. Investigation revealed a patron of the business had struck one of the business's security personnel with a bottle, causing a laceration which required 41 stitches. Officers later discovered the suspect in this offense was 19 years old. The suspect was arrested for Substantial Battery and the applicant was cited for Presence of Minor at Licensed Premise.

- 32. On 05/03/2014 a 20 year old police aide, working in conjunction with Milwaukee, attempted to gain entry at 125 East Juneau Street (Trinity). The aide was challenged at the point of entry and turned away when she could not prove she was of age.
- 33. On 05/03/2014 the applicant was cited at 1530 East North Avenue in the city of Milwaukee for Sale of Alcohol to Underage Person and Allow Underage on Premises.

- 34.On 12/13/2014 Milwaukee police were flagged down in front of Trinity Irish Pub regarding a disorderly subject. The victim, a bouncer for the business, told officers he was punched in the face by a subject for not allowing his friend into the bar. The subject was cited and released.
- 35. On 02/19/2015 Milwaukee police conducted a licensed premise check at Trinity Irish Pub (125 East Juneau Avenue) and provided the business with a packet of tavern related ordinances. The officer then discussed ways to prevent violations of these ordinances.
- 36. On 02/26/2015 a 19 year old Milwaukee police aide, working in conjunction with Milwaukee police, attempted to gain entry to Trinity (125 East Juneau Avenue) but was turned away when she could not provide proof she had attained the legal drinking age of 21.
- 37. On 05/22/2015 Milwaukee police, while on routine patrol, observed an altercation at the door of Trinity Irish Pub (125 East Juneau Avenue). Investigation revealed bar staff refused entry to a subject who became belligerent and argumentative. This subject was taken into custody and ultimately cited for disorderly conduct.
- 38. On 08/07/2015 District One officers conducted underage tavern enforcement. The underage police aid attempted entry to Trinity Irish Pub, 125 E. Juneau Av, but was challenged at the door and turned away when she could not produce ID.

- 39. On 09/13/2015 officers responded to Trinity Irish Pub for a fight. Upon arrival the officer observed security for Trinity push a subject into a car. The security officer stated "he bit me" pointing to the suspect. The suspect was arrested and security stated that he was trying to break up a fight inside when the suspect charged him and swung a fist at him. He was able to push the suspect away but he came back and bit him on the hand.
- 40. On 09/19/2015 officers responded to Trinity Irish Pub for an injured person. The investigation revealed the subject had been turned away at the door do to his level of intoxication. The subject then attempted to gain entry by jumping over the fence but fell on his face, causing a laceration.
- 41. On 11/20/2015 officers responded to Trinity Irish Pub for a battery complaint. Upon arrival they found the security guard outside, who pointed out a suspect stating that person had broken his (the security guard's) finger. The subject was arrested. The investigation revealed that the suspect was kicked out of the bar. He then returned and charged the bouncer. He grabbed one of the bouncer's fingers and bent it back breaking it. The bouncer was conveyed to the hospital which confirmed his finger was broken. Milwaukee Police Department IR #15-324-0176.
- 42. On 02/07/2016 officers were flagged down for a theft complaint at Trinity Irish Pub. The victim stated an unknown female bumped into him inside the bar. He stated he talked with her for several minutes then she left. After she left he checked his pocket for his wallet and found it missing. He stated she was the only person that could have taken his wallet. Milwaukee Police Department IR# 16-038-0021.

- 43. On 03/30/2017 officers conducted underage tavern enforcement in District 1. An underage Police Aid attempted to gain entry to Trinity Three Irish Pub, 125 E. Juneau St. There was no security at the door and the Police Aid ordered and was served a Miller Lite beer. The applicant was advised the bar failed the check.
- 44. On 10/28/17 at 12:50 am, officers were dispatched to 125 E. Juneau Avenue (Trinity Three Irish Pub) for a battery complaint. Investigation revealed that a fight occurred inside the establishment and a patron struck another patron in the head with a beer bottle causing a laceration which required treatment. The subject was arrested and an Incident Report was filed (133010010)
- 45. On 11/23/17 at 1:43am, an officer was flagged down for a fight outside 125 E. Juneau Avenue (Trinity Three Irish Pub). Investigation revealed that a patron became disorderly inside the tavern and was escorted out by security. While outside, the patron tried to punch one of the employees and had to be restrained by multiple individuals. The officer did observe that both, the employee and the unruly patron had to be physically restrained several times during the investigation and were extremely aggressive toward each other. After order was restored, employees of the tavern were helpful clearing the street and getting people back onto the sidewalk. The disorderly patron was cited for disorderly conduct.
- 46. On 03/03/18 at 1:30am, officers were flagged down at 125 E. Juneau Avenue (Trinity Three Irish Pub) for a theft complaint. Investigation revealed that a patron had her purse stolen earlier in the evening and security personnel alerted all the bartenders that someone may attempt to use a credit card in the patron's name. Later that morning, a bartender noticed the stolen credit card being used by a subject, alerted security, and the subject was detained until police arrived. Security was very helpful with the investigation and handled things in an appropriate, timely manner.
- 47. On 06/02/18 at 2:11am, officers were flagged down at 125 E. Juneau Avenue (Trinity Three Irish Pub) for a trouble with subject complaint. Investigation revealed that an employee and a patron got into an altercation because the patron was the ex-girlfriend of the employee and he was using his position to deny her entrance to the tavern. The patron was cited for disorderly conduct and the employee was cited for obstructing an officer.
- 48. On 09/29/2018at 11:05pm officers were flagged down by the manager of Trinity Irish Pub for a possible fight outside. The officers did not locate a fight but they returned to Trinity and the manager pointed out a victim. The victim stated he was waiting outside Trinity with two friends when a subject punched him for an unknown reason. The manager stated he did not see the punch but observed subjects running away that may be involved. He also stated there are no security cameras outside.
- 49. On 09/30/2019 at 1:41am an officer observed a subject exit Trinity Irish Pub, 125 E. Juneau Av, bleeding from the head. The victim stated he was battered inside the tavern and pointed out one of the subjects involved. The officer detained the subject and called for medical treatment for the victim. The victim received a total of 12 stiches for two lacerations to his forehead. The victim stated he was active military on leave and did not want to prosecute for this incident because he was being deployed overseas.

- 50. On 11/29/2018 officers conducted underage tavern enforcement in District 1. The tavern at 125 E. Juneau Av passed the check.
- 51. On 03/02/2019 at 11:52pm an officer was flagged down by staff at Trinity Pub, 125 E. Juneau Av, for a subject fighting with other staff members. The officer located the subject outside on the ground unconscious. The subject regained consciousness and the officer asked what happened and he stated he was being a jerk. The manager stated that the subject was found in employee areas of the tavern was escorted out. As they were escorting him out the subject struck the manager and another employee without consent. The manager stated after they were struck they pushed the subject away which caused him to fall on the snow and ice. The subject was issued Assault and Battery citation and released after he refused medical attention.
- 52. On 03/03/2019 at 1:00am officers observed security at Trinity, 125 E. Juneau Av, escorting a subject out. The officer observed both security and the subject fall to the ground when they got to the street. The officers interviewed the subject who stated an unknown female was causing problems on the dance floor and had punched his girlfriend. As he was confronting this female, she punched him to the head. Security then came up and kicked him out. Security stated the subject was upset and causing a disturbance and was escorted out. The subject did seek medical treatment for a headache but stated he did not know if it was from the punch or hitting his head when he fell.
- 53.On 04/21/2019 at 12:47am officers were dispatched to a Trouble with Subject at Trinity, 125 E. Juneau Av. The officers observed security escorting an unruly patron out without incident.
- 54.On 05/26/2019at 2:20am officers were flagged down for a Battery at 125 E. Juneau Av. The victim was leaving Trinity when a subject on the sidewalk began talking with him. The subject would not leave him alone so he called him a "Bum" and he was struck to the face. The subject was pointed out to the officer and he was issued a citation.
- 55. On 06/02/2019 at 2:00am officers responded to Trinity, 125 E. Juneau Av, for a fight on the patio. The officers interviewed security who stated that he was punched to the face, without consent, while trying to break up a fight. The subject who punched security was issued a citation. The officer met with the general manager on 06/07/2019 to discuss recent issues with security being punched. The officer suggested having Security printed on their shirts and having them announce that they are security while trying to break up fights.
- 56. On 10/26/2019 at 12:59am an officer was flagged down by a patron of Trinity, 125 E. Juneau Av, who stated he wallet was removed from her purse while she was on the dance floor. The patron stated the purse was around her neck in front of her when she felt a tug on her purse. She then felt her purse was lighter. She immediately checked her purse and found her wallet missing. The patron stated she did not see who took her wallet. The officer checked with Trinity but they do not have cameras.
- 57. On 12/14/2019 officers were flagged down by a citizen, who stated security at Trinity had her ID card. The officers spoke with security who gave the ID to the officers. The ID did not belong to that citizen and she was issued a citation for using a fake ID.
- 58. On 03/07/2020 officers were monitoring the Shamrock Shuffle on E. Juneau Av. The officers issued citations to two subjects that were kicked out of Trinity but refused to leave the area.

The business employees used the proper amount of force in escorting the subjects off the property.

59. On 02/19/21 at 11:44pm, Milwaukee Police conducted a license premise check at 125 E. Juneau Avenue. The manager was extremely helpful and very welcoming during the premise check and the tavern was found to be in compliance for the inspection.

- 60. On 03/06/21 at 11:25pm, Milwaukee Police were flagged down by the staff at 125 E. Juneau Avenue for a subject who was causing a disturbance and refused to leave the outside of the tavern. The subject was cited for Loitering-Tavern related by police.
- 61. On 03/06/21 at 11:45pm, Milwaukee Police were flagged down by staff at 125 E. Juneau Avenue for a battery compliant. Investigation revealed that a patron struck an employee in the face. The subject was cited for assault and battery.
- 62. On 04/22/21 at 1:03am, a subject was being escorted out of 125 E. Juneau Avenue who became aggressive and refused to let go of staff members escorting him out. When the subject let go of staff, he charged at police and had to be subdued by police and employees from the establishment. Tavern staff acted properly in escorting the subject outside.
- 63. On 09/10/21, Milwaukee Police Officers, while on the Code Red Deployment, observed two separate physical altercations that started inside the tavern and spilled out onto the street. Over the past three weeks, on Wednesday nights, the establishment holds a college night which officers have observed fights. The manager of the tavern has asked for a police presence on Wednesdays to help with altercations at tavern close. The manager has asked the owner to enforce a cover charge and dress code. The manager was very cooperative.
- 64. On 01/26/22 at 12:15am, Milwaukee Police observed a subject exit the tavern at 125 E. Juneau Avenue highly intoxicated. The subject was transported to the hospital because he was incapacitated by alcohol. Officers interviewed the staff who said they did not recognize the subject and did not know how many drinks he consumed.
- 65. On 01/29/22 at 12:42am, Milwaukee Police observed security escort a subject out of the tavern located at 125 E. Juneau Avenue. The subject attempted to regain entry into the tavern and tried to hit one of the security staff. Security carefully assisted the subject to the ground and flagged down police. The subject was arrested. Trinity staff had acted in accordance with police previous requests to not take any further action once the problem was outside the establishment unless there would be harm to others.
- 66. On 07/10/22 at 1:31am, Milwaukee Police observed a fight next to the side entrance of 125 E. Juneau Avenue. Investigation revealed that the fight originated inside the tavern and the subjects were escorted outside by security where the fight continued. The bar staff was cooperative with the investigation and assisted in any way they could.
- 67. On 07/13/22 at 10:14pm, Milwaukee Police conducted a license premise check at 125 E. Juneau Avenue. No violations were found.

- 68.On 07/21/22 at 1:00am, Milwaukee Police observed a subject getting kicked out of the tavern located at 125 E. Juneau Avenue. The subject kept causing a disturbance while outside the tavern, so he was arrested and cited. The manager on scene was cooperative with the police.
- 69. On 08/10/22, Milwaukee Police were monitoring the tavern located at 125 E. Juneau Avenue because their week day drink special draws a large crowd. During the course of the night there were several incidents that required police intervention. At tavern closing time, staff/security escorted the remaining 200 plus patrons out of the tavern but did not assist police with getting the crowd to leave the area.

- 70. On 09/04/22, Milwaukee Police were flagged down by security at 125 E. Juneau Ave. Investigation revealed a patron was in the bar and got angry when another patron bumped into them. The suspect then pulled a firearm from their waistband and held it with both hands, before placing it back in their waistband and exiting the bar. The officers were pointed to the subject as they exited and ordered them to the ground, recovering a firearm. The employees were cooperative and advised officers they would attempt to get video surveillance of the incident.
- 71. On 12/29/22 at 12:35a.m, Milwaukee Police were monitoring the crowd at 125 E. Juneau Ave., during their \$1 bomb drink night, when they were flagged down for an injured/sick person inside the bathroom. The officers were advised a patron slipped and fell in the bathroom, and possibly broke their ankle. The patron was transported to a hospital for medical treatment and the staff were cooperative with the investigation.
- 72. On 01/22/23 at 12:28a.m., Milwaukee Police were flagged down at 125 E. Juneau Av. Security advised officers they were attempting to break up an altercation between patrons, when they were struck in the face by another patron, causing minor injury. The patron was arrested and the staff were cooperative with the investigation.
- 73. On 03/05/23 at 10:15p.m., Milwaukee Police were flagged for a Trouble with Subject at 125 E. Juneau. Investigation revealed two subjects threw a drink in each other's face. One of the subjects was escorted out of the establishment. The staff were cooperative with the officers.
- 74. On 04/30/23 at 2:09a.m., Milwaukee Police were monitoring bar close in the area of 125 E. Juneau Av. Investigation revealed security was clearing out the sidewalks at bar close, when a patron began arguing with them, which led to the patron grabbing the security guard by the beard and slapping them in the face. Another patron got involved and struck the security guard in the face with a closed fist. Both patrons were issued citations and the staff were cooperative with the investigation.
- 75. On 07/24/23 at 12:04a.m., Milwaukee Police were flagged down by a citizen who stated subjects were breaking into cars in the area of 113 E. Juneau Av., and were now in an altercation with patrons and security. As officers approached the area, they heard gunfire and observed victims laying on the ground at 1122 N. Edison St. The officers rendered medical aid to two security officers who were shot by a suspect.

Further investigation revealed patrons and security heard car alarms going off in the parking lot and went outside to see what was going on. Two suspects were observed leaving the area and security gave chase and apprehended the suspects, when one suspect managed to get back to their feet and fired shots at security. Both security officers were conveyed to a hospital for medical treatment.

A female patron started an argument with CHAMBERS, which led to her grabbing CHAMBERS by the beard and slapping him across the face with an open hand.

The female patron's boyfriend then arrived on scene and punched CHAMBERS in the face with a closed fist.

Squad 1412, Sgt. SCHEURING, was on scene and separated the parties and obtained all their info. Please see his supplemental report regarding.

Squad 767, PO EDWARDS and PO VELAZQUEZ, assisted Sgt. SCHEURING and issued the female patron and her boyfriend both citations.

Let it be noted, all security staff working at Trinity all had it clearly marked on their outer-most garments that they were security staff.

Matt HOWARD (W/M DOB 08/26/1984), one of the managers at Trinity, was extremely helpful and cooperative with the investigation Sgt. SCHEURING led on trinity's property.

I was assigned to Squad 1421 with my partner PO Jason CHADWICK.

On July 24th, 2023, PO CHADWICK and I were flagged down by an unknown W/F who stated some unknown males were caught breaking into cars at The Harp (113 E. Juneau Ave.) and now were in a physical altercation with patrons and security.

PO CHADWICK rounded the corner to head South on N. Edison St. from E. Juneau Ave. and heard approximately 5-6 gunshots as soon as our turn was completed. PO CHADWICK and I continued South on N. Edison St. and observed two gunshot victims laying on the ground at approximately 1122 N. Edison St.

As I exited the squad car, I observed two B/M's (S1 approximately 6'00", slim build, wearing a white t-shirt and blue jeans, with short dreads / S2 approximately 5'09", wearing a black hoody and black pants) walking east on E. Highland Ave. approaching N. Water St.

I called out to the Black Males but was pulled away by the witnesses to tend to the victims. **None** of the witnesses informed me that the two Black Males were the suspects in the shooting. As I was pulled to the victims, I observed S1 turn and exclaim "Man they trippin'!"

I approached Victim #1, a bouncer at The Harp, Kyle T. CWIKLIS (W/M DOB 11-05-1989) laying on his stomach in a pool of blood. I applied gloves and asked Kyle where he was shot, and he stated he was shot in his stomach and under his left buttcheek on his left leg. I applied a tourniquet to Kyle and took over applying pressure to Kyle's stomach from PO CHADWICK.

I observed large amounts of blood coming from Kyle's left leg and entrance wound on his stomach. Kyle had what appeared to be an exit wound on the left side of his stomach from the gunshot.

Victim #2, also a bouncer at The Harp, Nathan A. BERRY (B/M DOB 09/10/1999) was tended to by other officers as they arrived on scene. BERRY was shot on his left upper thigh and on his mid back.

A witness on scene, Justin M. BOYLE (W/M DOB 08/28/2000), was briefly interviewed by PO Kara PLACZEK, Squad 1431.

During the interview, BOYLE stated he and other patrons, as well as the security of The Harp, heard multiple car alarms going off in the parking lot located directly south of The Harp.

BOYLE stated all that heard the alarm went outside and observed S1 and S2 walking east across the street away from the parking lot.

BOYLE stated once S1 and S2 saw the crowd coming outside, they started to run and the patrons plus security gave chase. BOYLE stated they caught S1 and S2 and multiple people held them down as they were going to call police.

BOYLE stated S1 stopped struggling, then had a sudden burst of energy and got up off the ground. BOYLE stated S1, once off the ground and on his feet, produced a firearm from his pants and then shot V1 and V2.
