There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

**Notice for applicants with  
warrants or unpaid fines:**

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

While in the back he attempted to kiss her and she pushed him away. The victim then left the bar and quit. An officer interviewed the owner, Antonio MARTINEZ, who stated he gives the victim "fatherly" advised and did hug her. He denied attempting to kiss her. The applicant was cited for Mashing.

2. On 05/02/24 at 6:00a.m., Milwaukee Police, members of the FBI, and other associated Law Enforcement entities executed a search warrant at 2000 W. Mitchell. This was in regards to an on-going investigation in which officers witnessed over 50 hand to hand narcotic transactions in front of the bar. Officers also conducted controlled buys of narcotics inside the location. One of which ½ kilogram of cocaine was sold. The officers seized 2.93 grams of cocaine salt

and \$31,904.00 US Currency. In total 13 search warrants were associated with the investigation in which multiple arrests were made, as well as evidence recovered and seized. The business was a drug trafficking hub.

3. On 06/07/24 at 1:43p.m., Milwaukee Police conducted a License Premise Check at 2000 W. Mitchell St. No violations were found.

This report is written by Milwaukee Police Department Police Officer Eulia Boyd assigned to District Two Early Power (Squad 2285), and currently assigned to the Federal Bureau of Investigation (FBI) Milwaukee Area Safe Streets Task Force (MASSTF) when the following occurred.

On Thursday May 2nd, 2024, at approximately 6:00am, members of the Federal Bureau of Investigation, Cudahy Police Department, Wisconsin State Patrol, and Federal Bureau of Investigation (F.B.I.) executed a warrant at the address of 2000 W Mitchell Street, located in the City and County of Milwaukee. The warrant was reviewed by AUSA Trish Daugherty and approved by Honorable Steven C Dries, U.S. Magistrate Judge on Wednesday, May 1st, 2024 at 9:45am.

I attempted to speak with the licensee Antonio Martinez (W/M, 09/10/1949) by calling phone number 414-429-4526. No one answered the phone call, however, I left a voicemail for Antonio Martinez regarding this incident.

There were no individuals on the premise during the search warrant. Sergeant Kathryn Anderer requested a board up for two doors that were damaged during the search warrant entry which was completed on 05/02/2024.

During the search warrant a large amount of US currency was located hidden in a room connected to the bar tending area including in a freezer and shelves. Officers on scene also located approximately 2.93 grams of cocaine salt near the US currency that was seized.

I observed there to be a surveillance camera within the bar, however, I was unable to determine if the camera was functioning.

While on scene, I observed the licenses posted and they were up to date. During the execution of the search warrant I observed the aforementioned cocaine salt which was seized as evidence and conveyed to Cudahy Police Department located at 5050 S Lake Dr, Cudahy, Wisconsin. The US Currency was also seized and conveyed to the Federal Bureau of Investigations building located at 3600 S

Lake Dr, St Francis, Wisconsin where a count of the US Currency occurred. There was a total of \$31,904.00 located in El Infierno Bar.

Over the course of the this investigation law enforcement officers have observed over 50 suspected hand to hand narcotic transactions occur directly in front of and near El Infierno Bar. At least four of the controlled buys conducted in this investigation involved meeting or deliveries at El Infierno's including during one of the controlled buys was exchanged approximately 1/2 of kilogram of cocaine inside the bar was later sold. Case agents know that nearly all of the targets of this investigation congregate at El Infierno on almost a daily basis.

MASSTF obtained 13 search warrants associated to this investigation. During this investigation: total 10 individuals were arrested;

Total evidence recovered and seized :

- 8 firearms
- 1,262.32 grams of Cocaine
- 1,744.86 grams of Methamphetamine
- 5,430.86 grams of THC
- 3,909 MDMA pills (429.9 grams)
- 71.9 grams Suspected Drug/Cutting agent
- 309.39grams of Philocybin Mushrooms
- \$207,894 US Currency

El Infierno tavern was a drug trafficking hub in this investigation.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

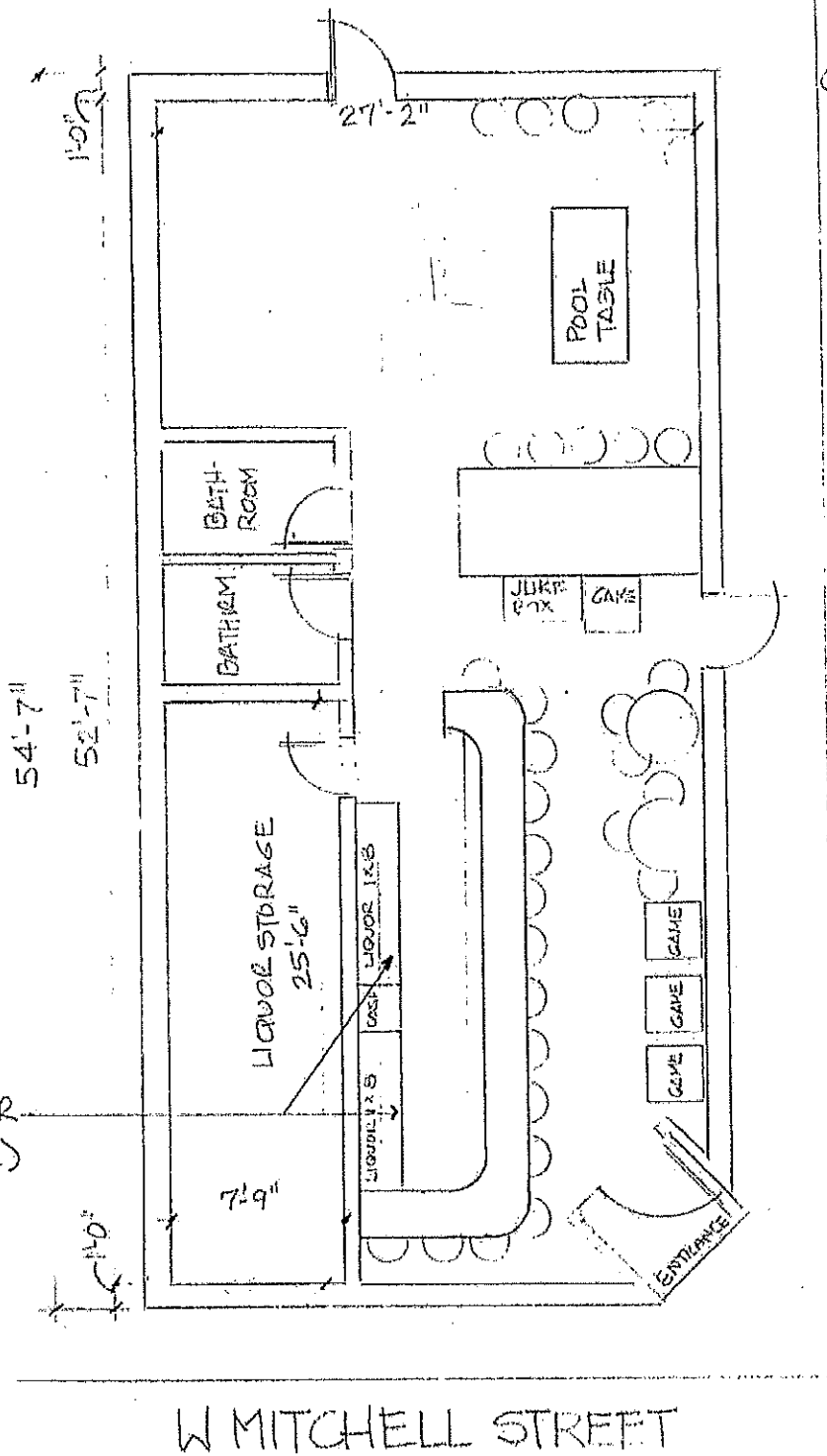

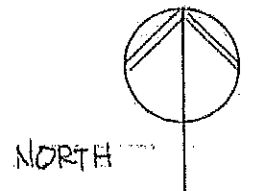

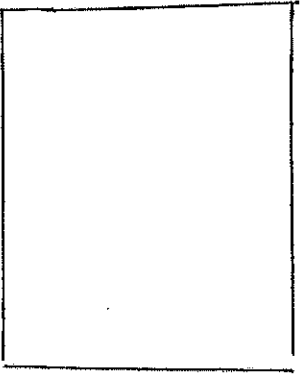
up Dated Floor Plan

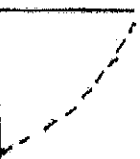
