This report is written by Police Officer Xavier Benitez, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 08/14/20 at 10:33pm, Milwaukee Police were dispatched to 4600 S. 6th St for an overdose complaint. Officers spoke with the night manager who stated that a female overdosed on the property. Officers met Milwaukee Fire Department medical who administered narcan to the subject, who then became responsive. Officers spoke with the female subject's friend who stated that he has not seen her since 9:30pm. The female subject was transported to St Luke's Hospital for further medical treatment.
- 2. On 10/02/20 at 8:58pm, Milwaukee Police were dispatched to 4600 S. 6th St for a fight complaint. Officers spoke with manger who stated that a guest came to the front desk and stated that she heard screaming coming from room # 106. Officers during investigating the complaint located a subject hiding in the closet. A record check of the subject revealed a valid warrant. The subject was placed in to custody and transported to MSDF.
- 3. On 10/06/20 at 8:35pm, Milwaukee Police were dispatched to 4600 S. 6th St, for a soliciting complaint. Officers spoke with the manager who stated that the female guest in room #206, has been having a lot of person traffic coming and going. The manager stated that this activity has been going on for a couple days now. The manger stated that upper management advised her to allow the guest to stay as long as payment for the room was made. Officers could not make contact with any one in room # 206. The manager was advised that person traffic does

not validate entering the room or removing the guest off the property. The manger was cooperative and stated that she understood.

- 4. On 01/25/21 at 1:36pm, Milwaukee Police Officers from District #6 conducted a Safety and Security check at 4600 S. 6th St. Officers spoke with the day manager who stated that his current concerns are vehicles that loiter on the property. The manager's concern is that these vehicles are conducting drug activities. The manger stated that due to the current Covid issues the business has blocked access to part of the parking lot. This allows staff to get vehicle information, of cars on the lot. The other concern covered was loitering problems from homeless individuals. The officers addressed the issues and advised the manager that officers would continue to conduct quarterly checks.
- 5. On 03/01/21 at 7:17pm, Milwaukee Police were dispatched to 4600 S. 6th St for a Battery DV complaint. Officers spoke with the victim who stated that the father of her 3 children in common struck her in the face, causing pain. The suspect then left the area. Officers investigated the complaint and filed the appropriate reports regarding.
- 6. On 03/09/21 at 11:32pm, Milwaukee Police were dispatched to 4600 S. 6th St for a trouble with subject complaint. Officers spoke with the front desk who stated that there was a person in the lobby, acting and talking strange. Officers talked to the subject who was stating he was the owner of the hotel, then stated that he wanted to be conveyed to the Mental Health Complex. Officers conveyed the subject off the property and to Mental Health.
- 7. On 03/10/21 at 5:56am, Milwaukee Police were dispatched to 4600 S. 6th St for a trouble with subject complaint. Officers spoke with the manager who stated that two subjects were in the hotel refusing to leave. Officers encountered one subject in the lobby who was stating he owned the hotel. The subject kept repeating that he was looking for his bag and appeared confused. The officers temporally detained the subject in a police squad, while the other officer looked around the hotel. The officers located the bag belonging to the subject. The officers did not locate another subject in the hotel. Officers then conducted a citizen conveyance of the subject removing him off the property.
- 8. On 03/12/21 at 11:13pm, Milwaukee Police were dispatched to 4600 S. 6th St for a trouble with subject complaint. Officers spoke with the manager who sated that there was a homeless person in the bathroom refusing to leave. Officers locate the subject and he was escorted off the property with no incident.
- 9. On 05/07/21 at 8:15pm, Milwaukee Police were dispatched to 4600 S. 6th St for a trouble with subject complaint. Officers spoke with the manager who stated that there was a subject in the hotel that was not guest. The subject then went to the 2nd floor and to the laundry room and has been there for 90 minutes. The manager asked officers to remove the subject off the property. Officers encounter the subject doing laundry, on the 2nd floor. The subject gathered his items and was escorted him off the premise with no further incident.
- 10. On 05/25/21 at 4:15pm, Milwaukee Police were dispatched to 4600 S. 6th St for a theft complaint. Officers spoke with the complainant regarding her friend taking property. Investigation determined the theft to be a civil issue. The hotel was cooperative with officers during the investigation.

This report was submitted by Officer Frederick TERRIQUEZ assigned to District 6, Early shift.

On Friday, August 14th, 2020 at 10:33pm, I, squad 6240 along with squad 6220, Officer Megan BROADNAX, were dispatched to an overdose complaint at 4600 S. 6th St.

The caller, Tyler, stated there is a female that overdosed on the property.

4600 S. 6th St is the address to the Sleep Inn and Suites Hotel located on the east side of S. 6th St and W Armour Av. The main doors are located on the west side of the Hotel with a side door located on the north end of the building. A parking lot surrounds the front of the hotel with access points off S. 6th St. The parking lot was on the north side of the hotel was poorly lit.

Upon arrival, I observed Milwaukee Fire Department (MFD) Engine 17 and Medical Unit 17 alongside the north side entrance of the hotel building. They were treating a female patient who was lying on the ground by the door.

I spoke to Shawanda M. SCHULTZ, b/f, 10-25-91. Shawanda stays at the hotel. She stated she was outside in the north parking lot with her boyfriend when she happened to observe the female outside. She stated she watched her stagger to the side door and then collapse.

I spoke to Kristopher J. SEIBEL, w/m, 06-14-82. Kristopher rents Apartment#210 with the victim who he identified as Stephanie F. BAILEY, w/f, 10-06-83. Kristopher stated he came outside to get something from his vehicle when he noticed the fire department working treating her. Kristopher stated he last saw Stephanie at 9:30pm, when he went to take a shower. He stated Stephanie was going to the gas station to by something to drink. Kristopher was wondering what was taking her so long.

A wanted check on Stephanie revealed a history of drug related offenses.

I spoke to Lieutenant ANDERSON from Med 17. He stated he administered two doses of Nalaxone (Narcan) on Stephanie who was breathing but unresponsive at the time. Once Stephanie was moved to the stretcher for transport she became responsive.

Stephanie was conveyed to St Luke's Hospital and was admitted at 11:17pm. She refused to speak with me. She was treated by Dr. Marcy NABRATIL for an overdose of heroin.

I spoke to Tyler K. KINDER, w/f, 02-27-96. Tyler is the night manager for Sleep Inn and Suites. She stated she was the one who called for police. She stated some notified her that someone was overdosing outside of the hotel. She stated she did not know where the licenses for the hotel were but believed it may be in the General Managers office. The General Manager's name is Tammy.

On Friday, October 02 2020, at 8:58PM, Squad 6230 (P.O. GRAP and Myself, both in full duty uniforms equipped with functional Axon 2 body-worn cameras and operating marked MPD car 428) backed up Squad 6241 (PO WALLICH, PO LAFOND) to 4600 S. 6th St. #106, which is located within the City and County of Milwaukee, for a fight call for service.

Upon arrival I made contact with Tyler K. TRINIDAD (w/f, 02/27/98), who stated a guest came to the desk and told her an unknown female was screaming for help from room 106. When we arrived to the room, I could hear a conversation between what I perceived as two females.

We then made contact with the resident, Destiny M. JACKSON (w/f, 10/27/98), who stated she was alone and she was fine. Due to hearing other voices and the fact there was a female screaming for help, we checked the room for anyone who may be in need of police assistance. We then located Yahaira L. MELENDEZ (b/f, 09/05/97), who was hiding in the closet. A DOT check of MELENDEZ revealed a warrant for felony VOP. She was taken into custody and conveyed to MSDF.

I asked TRINIDAD for the business license who stated that it is in the General Managers office and her name is Tammy. She stated that she work M-F 9-5.

No other violations were observed.

INITIAL INVESTIGATION

This report is written by P.O. Joshua YANG, assigned to District Six, Late Power Shift. On Tuesday, October 6, 2020, I was assigned to the License Premise Car (Squad 6468). I was operating a marked black and white Milwaukee Police Department squad car, equipped with red/blue emergency lights and audible siren. I was in full MPD uniform, with badges and nameplates affixed to my outermost garments. I was equipped with a body worn camera, which was activated and captured this incident.

At approximately 8:35 pm, Squad 6250, P.O. Harold ALMAS and P.O. Ryan LAFOND were dispatched to a soliciting complaint at 4600 S. 6th St. room 206, located in the City and County of Milwaukee.

At approximately 8:53 pm, I responded to assist Squad 6250. Upon arrival, I was debriefed by P.O. ALMAS who stated that the front desk employee, later identified as *Tyler K. TRINIDAD (W/F, 2/27/96)*, advised them that the female in room# 206 had a lot of traffic coming and going from it. P.O. ALMAS stated him and P.O. LAFOND attempted to make contact with the subjects inside of room# 206 but were unable to make contact with anyone. P.O. ALMAS stated they spoke with TRINIDAD who stated that this activity has been going on the last couple of days and she wanted to remain anonymous. I advised TRINIDAD that we don't have any exigent circumstances and we could not enter room# 206. TRINIDAD stated that she has contacted her boss/corporate and they have basically advised her to keep allowing the subject in room# 206 to stay there as long as that customer is paying for her hotel room. I advised TRINIDAD that at this time, we do not have any reason to have the person in room# 206 leave the hotel. TRINIDAD stated she understood and was cooperative.

I later observed that the location has hotel license# 398 and it is up to date.

SAFETY AND SECURITY MEETING

Ward, Michael S 024624

This report is written by Police Officer Michael WARD, assigned to District 6, Early Power, and the Community Liaison Office.

On this day I was assigned to Squad 6264, with Police Officer Fabian GARCIA.

On Monday, January 25th, 2021, we conducted a Safety and Security check of the Sleep Inn Hotel, located at 4600 S. 6th St., which is in the City and County of Milwaukee.

The scene is described as a Hotel, with three floors and 82 rooms for rent. The hotel has a pool, gym, and a Business Center on the first floor. The Hotel also has a dinning area that holds 41 people for their Continental Breakfast. This area is currently closed at this time due to Covid 19. The hotel has one ATM located on the first floor. The Hotel's main entrance faces west, with parking on the north, south, and west side of the building. There are three additional doors located on the property for guest located on the north side of the building, east side of the building off the patio, and south east corner of the building. All doors our accessed by a key card and were secured during the time of our check.

Police Officer Garcia and I spoke with Hotel Manger, Lamont L. CRUMP (B/M,4-26-1973) who was on scene during our check. CRUMP was advised we will be conducting quarterly meetings in regards to the safety and security of the Hotel.

CRUMP advised us that one of their main issues at the location is unknown vehicles pulling into the lot and loitering on the premise. CRUMP believes that the vehicles are conducting illegal business (drug sales) on the property.

CRUMP advised us due to the lack of normal business due to Covid 19, the management decided to block off the south entrance to all customers. CRUMP stated this has helped with identifying what cars should be on the lot. CRUMP also advised us that they log in vehicle information during check in and provide a slip for all guest to place in the windshield of their vehicles.

CRUMP advised us the only other concern at this time is homeless subjects who loiter in the lobby. CRUMP sated the Hotel is willing to be a complainant regarding the issue. CRUMP advised us that the Hotel has a Do Not Rent List for guest who have created issues on the property in the past.

We observed the security system. The property has 28 cameras located throughout. 8 exterior cameras that capture the parking lots and outside patio. 20 interior cameras that capture the halls of each floor(

north and south placement), first floor vending, laundry room, pool, dinning room, entrance and exit points, front desk, and office space. CRUMP stated there has been discussion to update the security surveillance system in 2021. CRUMP stated currently the video is stored for 30 days.

The parking lot has pole lighting. Lighting was not observed at the time of the safety check.

The office area for the staff has additional locker space for personal items and a lunch room for the staff separate from their guest.

CRUMP stated the location does not have a security guard at this time, but utilizes their shuttle service staff to conduct checks of the parking lot and hallways at night.

Overall the exterior of the property was well kept and clean. No abandoned property located in the lot.

CRUMP was advised this report would be filed and issued a Community Contact Card.

This concludes my report.

On Monday, March 1st 2021 at 7:17 p.m. I was dispatched to 4600 S 6th St, Sleep Inn & Suites, room 215 for a Battery DV call.

Upon arrival I spoke with Shelly L. GUSTAFSON (w/f 04/19/87). GUSTAFSON stated this incident involved Bruce A. HANDEL (w/m 01/11/93) her live-in boyfriend and father of three of her children. HANDEL was no longer on scene upon my arrival. GUSTAFSON stated that while they were staying at the hotel she and HANDEL got into a verbal argument. GUSTAFSON stated the argument was regarding \$100 from her monthly benefits that HANDEL took without asking. GUSTAFSON stated the argument culminated with HANDEL slapping her in the face an then trying to leave the hotel. GUSTAFSON stated she did not give permission to HANDEL to strike her and that it caused pain. GUSTAFSON stated she followed HANDEL outside because she was still upset about her money and wanted it back. GUSTAFSON stated HANDEL got into the passenger seat of his friend's car. GUSTAFSON stated in an attempt to stop HANDEL and his friend, she jumped on the hood of the car. GUSTAFSON stated the car drove away and she fell off the car.

GUSTAFSON stated she had rented out the hotel room to try and do something fun with her children. GUSTAFSON had five of her children with her on scene, all of which were present when this incident occurred. Of the five children, three of them are HANDEL's. The five children are Elijah L. CALDERON (b/m 04/22/12), Avianna L. GUSTAFSON (b/f 10/19/16), Ezra J. HANDEL (w/m 09/27/17), Kaidyn L. HANDEL (w/m 11/16/18), and Azriel C. HANDEL (w/m 03/09/20). GUSTAFSON stated HANDEL was not physically abusive to the children, but she had concerned about how verbally aggressive and mean he was towards E.CALDERON.

On scene I took seven photos at 7:42 p.m. of the location and the victim.

I issued a pink PD-33 DV Referral Notice and indicated the phone number to call to start the process to obtain a restraining order and informed GUSTAFSON they could help start the process of separating from HANDEL and finding other living arrangements for her. I issued a green PV-17 Crime Victim Resource form. GUSTAFSON circled where she was injured on the diagram and answered questions on the yellow PO-15D DV Supplementary Incident Report. I asked the Lethality Assessment questions, to which GUSTAFSON gave a positive answer to questions 2, 5, 6, and 10.

I finished answering questions and getting initial information from GUSTAFSON and returned to my squad car. At this point I noticed more information had been added to the CAD report and HANDEL had called and wanted to speak to officers. I called HANDEL back. HANDEL's voice was elevated for the

duration of the conversation and he continually yelled and spoke over me. HANDEL stated he was in the hotel room "exchanging words" with GUSTAFSON. HANDEL stated during the verbal argument both GUSTAFSON and a friend of her's attacked him. HANDEL stated when they attacked him he decided to leave the hotel. HANDEL stated he did not strike GUSTAFSON. I asked if I could speak with HANDEL in person. HANDEL did not like that idea. I asked where HANDEL was or was heading to, HANDEL said he would not tell me because he feared I would arrest him. HANDEL stated he wanted to press charges on GUSTAFSON and her friend if they were going to try and press charges on him. I informed HANDEL I would have to speak to him in person and HANDEL still did not want to tell me where he was. HANDEL stated he was willing to come into District 6 to report this. I asked HANDEL when he was planning on coming in, HANDEL stated not today. Throughout the course of this conversation, HANDEL kept repeating that he was a good father, takes care of his kids and that he was attacked, but would not meet in person. HANDEL did state that he was going to his family's home, but would not tell me where that is. HANDEL stated that GUSTAFSON and her friend were both drunk and under the influence of illegal drugs. While speaking with GUSTAFSON I did not observe any behavior or indicators that she was under the influence of anything that would alter her state of mind.

GUSTAFSON stated she did not wish to speak to someone from the DV hotline at the moment due to being alone with five children, but did request that I pass on her information and wanted to speak to someone soon. I contact the DV hotline at 8:48 p.m. and spoke to Tanya. Next I called the Bureau of Child Welfare to inform them of the situation and to pass on the information for GUSTAFSON, HANDEL and the five children who were present.
