On Monday, 03/10/25 at 11:48 AM PO Joel BUNKELMAN and I were dispatched to 6030 W Oklahoma Ave, Walgreens, for a Trouble with Subject (CAD/Event # P2503100649). PO BUNKELMAN and I were in a marked squad (Vehicle 65621), in full uniform, and equipped with body worn cameras.

Upon *our arrival* I observed the store appeared clean and orderly and the subject the manager called about was no longer on scene.

I spoke to the caller, Bryan M. KRENTZ, who is employed by Walgreens as the store manager. KRENTZ called police at 11:47 AM to inform us of an incident that occurred at approximately 7:15 AM. KRENTZ stated an unidentified customer briefly placed a large knife in a sheath and other items which he described as "Satanic" on the counter while paying for the items he was purchasing. KRENTZ stated the customer had purchased \$403.79 worth of merchandise, which included a large amount of ZzzQuil sleep aid. KRENTZ stated the subject did not say anything while making the purchase, did not steal anything, did not threaten anyone with the knife, and no threats were made. KRENTZ stated he was not on-scene when this occurred.

The business was *cooperative* with the investigation. KRENTZ was able to immediately show us video of the store's interaction with the subject.

PO BUNKELMAN and I reviewed video surveillance footage. The footage showed *the subject approach the front counter/register at approximately 7:15 AM. The subject then began checking his jacket's inside pockets, removed what appeared to be a large knife in a sheath on the counter briefly, remove a cross and place it on the counter, then immediately place the knife back inside of his jacket pocket. The subject then paid for all of the items he was purchasing, then left without incident.*

This Walgreens location has the following licenses: Food Dealer Retail (Expires 10/24/25), Cigarette and Tobacco (Expires 10/24/25), and Class A Malt and Class A Malt and Class A Liquor License (Expires 10/14/25); the licenses were posted in the manager's office. During my investigation for the Trouble with Subject, I did not observe any violations in the licensed premise.

On Thursday, March 27th, 2025, at 11:24AM, I was dispatched to bomb threat complaint at the location of 6030 W Oklahoma Ave (Walgreens), which is located in the City and County of Milwaukee.

Upon arrival, I spoke with the caller/victim, **Bryan M. KRENTZ (W/M 04/22/1981)**. KRENTZ stated at 11:11AM he received a phone call from an anonymous number and the caller stated he did not want to hurt anyone. KRENTZ stated he immediately hung up the phone call and received another call at 11:14AM from an unknown number (801)930-3458. KRENTZ stated he answered this call, and the caller stated he was going to blow up the store. KRENTZ stated he hung up and believed it was a scam. KRENTZ began to clarify by stating he was informed that there has been multiple Walgreens in the Madison area and Cedarberg, which received similar calls. While I was at this location regarding this investigation another bomb threat type incident was being reported at the location of 3233 S 27th St (Walgreens). KRENTZ stated these callers are trying to scam employees into giving them money. KRENTZ stated he does not believe he is in danger and will proceed to open the store for regular business. I Issued a PV-17 and a Community Contact card to KRENTZ.

Sgt. Logan JEFFERY (Squad 6111) was on scene and contacted the K9 Shift Commander. The K9 Shift Commander spoke with Sgt. JEFFERY and concluded that it wasn't necessary to send a K9 Unit to our location.

I contacted the District Six Shift Commander, Lt. Joseph HALL, who advised me that the Detective Bureau would not be responding, and the case was to be filed accordingly. I contacted Milwaukee Police Fusion regarding the aforementioned phone number that was used to make this threat. I was advised that the number originated from a business called CHG Company, located in West Jordan, Utah. I was advised that they would continue to seek more information regarding this phone number and would contact me with any other pertinent information.

Store was cooperative and all store employees were cooperative.

On Sunday August 3, 2025 at approximately 11:27AM, I was dispatched to Walgreens located at 6030 W. Oklahoma Ave (which is located in the City and County of Milwaukee, WI). regarding a Theft complaint.

Upon arrival, I spoke with the manager identified as Kayla L. SKODOWSKI (W/F, 11/05/1993) who stated a known shoplifter, later identified as Terrance A. BOOKER (B/M, 04/25/1984) came into the store, reached over the counter and grabbed 2-3 packs of cigarettes and fled the store without paying for them.

SKODOWSKI called from the phone number of (414) 544-9246, she observed the above listed subject, BOOKER, reach over the register counter and grab 2-3 packs of Malboro cigarette packs. SKODOWSKI then observed BOOKER run out of the store without paying for the items.

Walgreens and SKODOWSKI did not have any violations and SKODOWSKI was very cooperative with police while on scene.

There were no security guards on scene.

SKODOWSKI showed me the video surveillance which shows BOOKER walking towards the first register near the entrance at 10:00am, then BOOKER is observed reaching/jumping on top of the register counter then reaches to the cigarettes and grabs 2-3 packs. BOOKER is then seen running out of the store. SKODOWSKI provided me a USB with video surveillance - after looking at the USB, there was no video on it.
