Dear Alderman Henningsen:

As part of a continuing plan to convert one-hour meter parking to two-hour meter parking, we are introducing Metered Parking Time Restriction changes within your district. We are recommending the following changes:

The removal of:

“One-Hour Meter Parking, 8 AM to 6 PM Monday – Friday, One-Hour Parking 8 AM to 6 PM Saturday” at the locations listed below:

- The east side of North Old World Third Street from West Kilbourn Avenue to West State Street
- Both sides of North Old World Third Street from West State Street to West Juneau Avenue
- Both sides of West State Street from the Milwaukee River to North Old World Third Street
- The north side of West State Street from North Old World Third Street to North 4th Street
- Both sides of West Highland Avenue from the Milwaukee River to North 4th Street
- The south side of West Juneau Avenue from North 4th Street to North 5th Street

The installation of:

“Two-Hour Meter Parking, 8 AM to 6 PM Monday – Friday, Two-Hour Parking, 8 AM to 6 PM Saturday”, One-dollar per hour at the locations listed below:

- The east side of North Old World Third Street from West Kilbourn Avenue to West State Street
- Both sides of North Old World Third Street from West State Street to West Juneau Avenue
- Both sides of West State Street from the Milwaukee River to North Old World Third Street
- The north side of West State Street from North Old World Third Street to North 4th Street
- Both sides of West Highland Avenue from the Milwaukee River to North 4th Street
- The south side of West Juneau Avenue from North 4th Street to North 5th Street


Dear Alderman Pratt:


Dear Alderman Henningsen:
