Dear Mr. Loving:

We have received your claim for the amount of \$4,437.14 in relation to the motor vehicle accident that occurred on June 8, 2013 in the 1200 block of North Alois Street.

The Fleet Services Division reports you were traveling southbound on North Alois Street, making a left turn to enter U.S. Highway 41-South. The city vehicle was traveling northbound on North Alois Street. The city vehicle collided with the passenger side rear of your vehicle while you were completing your left turn. Based on this information, you failed to yield to oncoming traffic and would be the proximate cause for the accident. The damage to your vehicle was not the result of any negligence of the City of Milwaukee, and the city is not legally liable for your damage. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, WI 53202, requesting a hearing.
