All work will be done according to attached drawings. Sign will replace existing sign which will be removed.

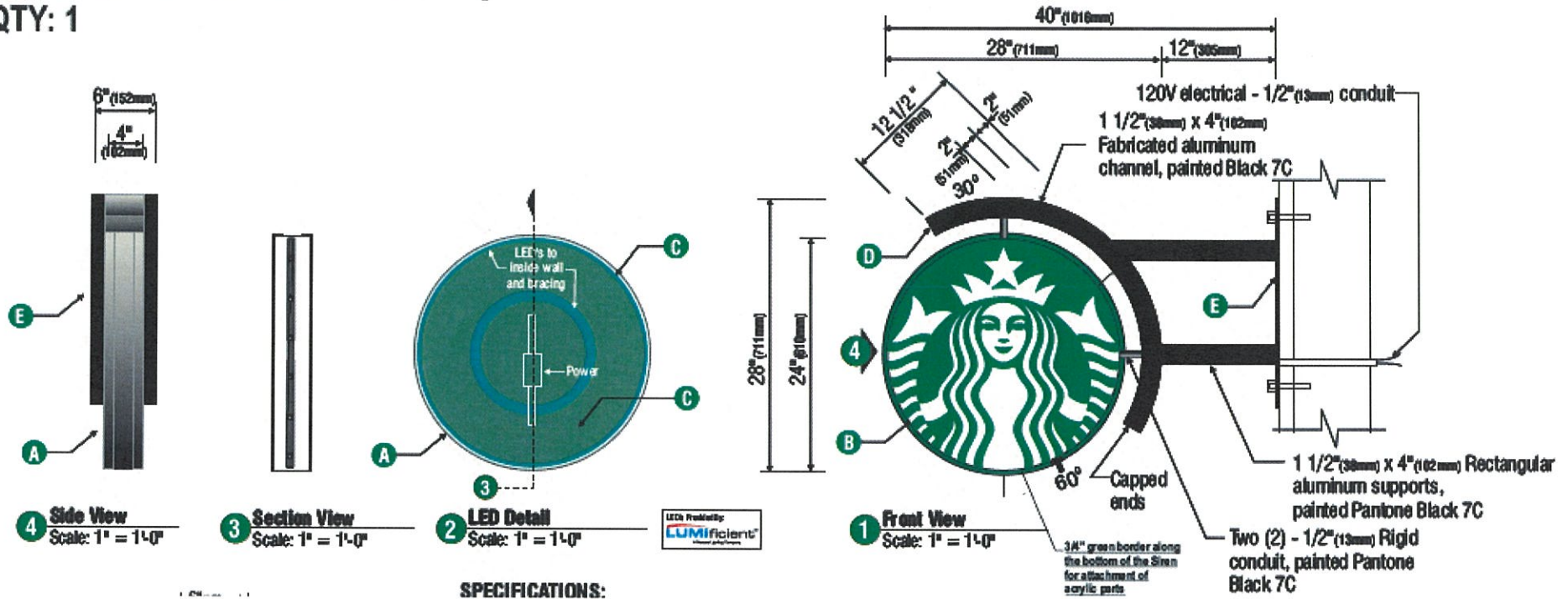

SPECIFICATIONS:

- A** 24" (610mm) Double faced internally illuminated blade sign logo. Logo disk cabinet to be 4" (102mm) deep, fabricated from 1/8" (3mm) aluminum, painted satin finish black. Returns to be painted satin finish black.
- B** Faces to be routed aluminum painted PMS 3425C, w/ clear acrylic push-thru. White vinyl applied to 1st surface. 3/16" White acrylic diffuser 2nd surface.
- C** Internally illuminate logo disk with Lumificient™ white LED's inside return perimeter. Power with self contained Lumificient™ power supply covered with white vinyl film.
- D** Radiused logo surround to be 1/8" (3mm) aluminum, fabricated as a 1 1/2" (38mm) X 4" (102mm) channel, painted Pantone black 7C. Support arms to be 1 1/2" (38mm) X 4" (102mm) rectangular aluminum tube, painted Pantone black 7C. Cabinet supports to be 1/2" (13mm) rigid conduit and aluminum pipe, painted Pantone black 7C.
- E** Wall plate to be 16" (406mm) X 6" (152mm) X 1/4" (6mm) aluminum, painted Pantone black 7C. Fasten securely to wall with 3/8" (10mm) bolts.
