

Martha Freeman was born July 20th 1938, in Gainesville, GA; mother of 5 children who are very supportive. Their lives have changed, as many of ours have.

Mama Freeman, as everyone calls her, was educated the Milwaukee Public School (MPS) system. She also attended the University of Wisconsin-Milwaukee. As an adult, she has always worked more than one job at a time. She worked best at jobs helping others: crossing guard, middle school teacher for emotionally disturbed and delinquent children, director of a residential treatment center, private detective for a criminal defense attorney, and finally retiring after 20 years as an officer/sergeant from the Milwaukee County House of Correction.

Martha (Mama) Freeman moved to the Garden Homes neighborhood in 1969. Many of us remember her bringing pillow cases from her house for our sack races, buying watermelons for contests; we made a stage and the runway was from her house to the park, where we would have talent shows and style shows. Summer evenings, she would make peanut butter and jelly sandwiches after we had prayer and bible study. Her porch became our outdoor theatre. She would also read and act out stories. She knew an instructor who owned a ranch. The instructor would let her bring us to West Bend to ride the horses and see all the animals. Only those who had homework and chores completed, and didn't fight were allowed to go. She would always take groups of us with large bags through the neighborhood to clean up. There were times when we would help elderly people clean their yards and go to the store for them. Today, she provides donated bread, doughnuts, and cakes from Sara Lee along with prayers to people in the neighborhood and she continues to try and keep us in line.

When some of us were sent to The House of Correction, we were ashamed to let her see us. I can remember times when she would take guns and car keys. One young man, who is now

a minister and goes to many institutions, was going to shoot a man. She took his gun and talked to him about Jesus. Another young man was sharing story about how he was on his way to shoot someone; she took his keys and gun. She is famous for driving her car in the middle of crap games and fights. The street named Port Sunlightway was known as "Prostitute Way," is empty now. She would sit in a chair on that street and turn their customers away.

By naming Port Sunlight Way after her, we hope, will remind those of us who continue to live here and those who have moved away that someone cared enough to help get our neighborhood back together. Hopefully, some of us will want to follow in her footsteps and help to make our Garden Homes neighborhood the best it can be. Good people=Good families=Good communities.

Black women speak at YWCA conference

"The Black Woman Speaks ...
to Everyone," an all-day conference, sponsored by the YWCA

Measles, polio shots offered

On Sunday, March 15, the Milwaukee Health Department measles-oral polio clinics at Keenan Health Center, 300 N. 36 street, and at the Northwest Health Con-

ter, 7630 W. Mill road, will offer measles and oral polio immunizations to city children. The clinics will be open from 10 a.m. until 2 p.m.

Measles immunizations are offered to city children one through nine years of age who have not had measles immunizations. This immunization prevents measles but not German measles which is a different disease.

Children six weeks through seventeen years of age who have not been immunized to prevent polio may receive the oral polio immunization.


Only one immunization may be received on one day. There is no charge for immunizations at the Sunday clinics although donations will be accepted.



Chapter One - Take a Look At His Children & Pray (continued)

THE VANGUARDS

TROUBLED YOUTH IN THE CITY

"I feel like a Jeremiah weeping for them. I love them." Martha Freeman has a burden and call from the Lord for troubled youth and families in crisis, working with some of the toughest kids in the city. A teacher since 1974, for the past five years, she's been the program director of a continuing education program at Juneau Academy which houses youth who have been convicted of an offense, but haven't been sent to a reformatory.

A 50-year-old mother of 5, grandmother of 11, and great-grandmother of 1, Martha's house in the central city has been a place of refuge and comfort since she became a Christian 14 years ago. Nightly she leads family devotions for her kids and grand kids as well as the neighborhood children. Sometimes as many as 20 youth congregate in her living room, and the backdoor is always open to them.

There was a time when I couldn't have a dirty house. I put all my energy into keeping it clean. Now my heart is a house of prayer, and that's where the housecleaning is done so I can be effective in my prayers.

As a young Christian, I was pretty bold about sharing my faith with the kids at the Academy. I not only took them to church on Sunday and WVCY youth rallies, but even used the bible once as a textbook in the classroom, reading the Gospel of John. In fact, I got fired for teaching kids to pray. However, the director said he didn't feel right about firing me for loving kids, so he gave me 6 weeks leave of absence with pay. In the meantime, MPS wanted the Academy to start a day treatment center and my boss said my name was the only one that came up for program director. That was five years ago.

When I was fired from the job, I told the kids to pray for me, and they saw the fruit of their prayers. The whole incident was a witness to them that the Lord provides for His children, because I got a better job from the firing and never had financial loss. Since then, I've found ways of lifting up the Lord and yet respecting the people I work for.

I don't think these kids want to be in trouble. In their minds, the whole world is against them and no one cares. When you grow up that way, it's hard to see the truth. These kids are children of fear. Many of them are bedwetters and thumb suckers, but the Lord can erase those fears. I tell these hurting children about His love. He sends His Word and heals us.

I have a prayer ledger where I keep the list of kids to pray for, and record as the Lord answers my prayers. Whenever I can, I pray with the kids and their families. Sometimes they come to me at midnight. I told one girl who came into my house, defiant and cocky, that "from this day forward I am going to wage a war against you. I am going to pray for you." The girl kept coming back and I told the Lord that it seemed He was doing more work in me than her as I prayed, giving me a heart to love her. When she got in trouble a few years ago, I went to court and testified for her. She was so surprised that I would do that for her.

God is faithful in the midst of the hurt and trouble. Sometimes it's pretty close to home, when my own kids have gotten into serious trouble. There's so much spiritual warfare, and the evil one has brought mighty attacks against us. The woman Martha had been praying for came in during our second visit, and talked about why she keeps coming back. She said, "I've come in here often out of severe madness in the streets, and I know it's a place of comfort. I've been coming since I was 9, and now I'm 26.

Everybody knows this is God's house, and most of the time I don't want to come in here. Someday I think I won't be able to get out and return to my life. I know she doesn't approve of the choices I've made, but she never turns me away."

TROUBLED YOUTH IN THE SCHOOLS

"Social change won't work. They must become a new creation."

Odell White and Mike Shaw, Christian ex-offenders, talk with troubled youth in the Milwaukee schools as special seminar speakers, working under the auspices of Project Focus, a program of Self-Help of Wisconsin. They talk "straight" to youth involved in gangs, drug dealing or using, getting them to realize the cons of the bad life. Both of them also work as counselors with adjudicated youth at the Ultra School, a day treatment program for Lad Lake Home for Boys. Below Odell talks about their ministry.

We're not counselors when we go into the schools, but living testimonies of changed lives. We've been the gamut of the bad life and we know what these kids have waiting for them.
