Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.



## Confrontation

What we know: The video appears to show a confrontation between a man in his 80s and employees from DT2 Towing. In the video, you can see tow truck employee appear to push the door of the truck, knocking the man down.

Another angle of the video, which appears to show the initial interaction, shows what looks to be a knife in the man's hand.

Eventually, the employees of the tow truck company drive away with the man's vehicle.

## New video

Dig deeper: All drivers for DT2 Towing wear body cameras, which showed a new angle of the incident. The man, who has identified himself to FOX6 News as "Erby," was holding a knife during the confrontation.

Erby, who wouldn't share his last name, did tell FOX6 he was parked in the same spot he's used for 30 years and thought his car was being stolen.

What they're saying: "Someone hollered, 'Somebody's Cadillac is being stolen.'

That's when I ran out," the man, identified as Erby, said. "I didn't know what was going on."

He said he was picking up medication for his wife at the Walgreens on 35th and Wisconsin when things took a turn.

That's why he says he ran out with the knife.

He said no one from the tow company identified themselves.

The other side: The employees who work for DT2 Towing told FOX6 they have signs all over the lot.

They say they were towing Erby because he was parked illegally. But they said they didn't have time to tell him anything because he was running toward them with a knife.

## **MPD response**

What they're saying: The Milwaukee Police Department said they responded to a report of a fight at approximately 1:28 p.m. on Monday, March 3. When police arrived at the scene, they did not locate the complainant or the tow truck.

The incident was called in by a third party, police say.

What's next: On Tuesday, Erby walked out of DT2 Towing company with his car and without any further incident.

FOX6 News has reached out to the tow truck company for more information. So far, we have not heard back.



Mr. Thurmond,

At approximately 12:30 pm, on Sunday, May 11, 2025 I exited Save A Lot located at 4821 N 76<sup>th</sup> St (Hampton) to two young men attempting to connect my Mercedes Benz GLA to the tow truck pictured below – only one of my truck's tires was chained. A young man not pictured, but appears to be one of the young men in the video from a previous incident (<https://www.fox6now.com/news/confrontation-man-tow-truck-driver-milwaukee>) told me that in order for him to disconnect the one tire from the chain that I had to pay him \$80. I only had a one hundred dollar bill so the young stated that he did not have change and asked if he could keep the entire \$100, I told him "no." He told me that I could go and

get change, but I had to pay him \$80. I advised the young that I was a City employee and that I would be reporting the violation to the alderperson for Save A Lot's district (Alderman Chambers) and that I would also be contacting the alderperson for the district to which the tow trucking company was located (Alderwoman Pratt).

As per our verbal discussion earlier today, you are aware that in Wisconsin, including Milwaukee, a towing company can legally charge up to \$150 for a non-consensual tow from private property. This includes the actual towing and any standard procedures. Additionally, there may be a special equipment fee of up to \$150, but only if specific circumstances exist. There's also a potential drop fee of \$50 if the owner arrives before the vehicle is fully hooked up – I arrived before my vehicle was fully hooked and was illegally charged an \$80 drop fee.

As per your request, I am sending you the photos below for your reference.

I hope this message finds you well.

I am reaching out as a concerned Milwaukee County resident regarding an ongoing issue with a towing company that operates within your district. Although I do not reside in District 1, the business in question DT2 Towing LLC who also works with Always Towing & Recovery is located there and appears to be engaging in predatory towing practices that affect individuals citywide.

Upon investigation, I believe the tow was conducted in violation of both Milwaukee ordinances and Wisconsin statutes. Specifically:

- Milwaukee Code of Ordinances § 105-67.5 requires that towing signage on private property be clearly visible at each entrance and posted at eye level. In this case, no such signage was visible when entering or parking in the Walgreens lot.
- Wisconsin Statute § 349.13(3m) prohibits non-consensual tows from private property unless signage meets the requirements of local ordinances such as the one mentioned above.
- Wisconsin Administrative Code Trans § 319.04(2)(c) further mandates that towing companies comply with all local laws and cannot excuse noncompliance due to alleged theft or removal of signs.

When I contacted the tow company, they acknowledged that the sign was placed unusually high, claiming it was due to repeated theft. While that may be a challenge, it does not exempt them from compliance. Businesses are responsible for ensuring that required signage remains visible and lawful. If a sign cannot be maintained in accordance with legal standards, the property should not be subject to towing until the issue is resolved.

I'm deeply concerned that this company is continuing to profit from questionable practices and is unresponsive to valid legal concerns raised by the public. Their refusal to even acknowledge these violations raises broader concerns about consumer protections and equitable treatment.

Given that the business operates within District 1, I am respectfully asking your office to look into this matter and consider advocating for enforcement, review of their practices, or policy reform to prevent further harm to Milwaukee residents and visitors. I personally paid \$377.65 to get my car back.

I would be happy to provide photographs, documentation, and further details if helpful.

The driver stated the vehicle, when he arrived on scene to tow it, did not have the proper placard displayed in the window. The driver stated that he hooked the vehicle up to the tow truck and while he was loading the car onto the flatbed, the owner of the vehicle came out of the Dollar Tree and got into the vehicle and refused to get out. One short video is titled." They towing people car for no reason save a lot Walgreens". Four people are standing around a white flat-bed tow truck. An older male is standing between the open driver's side door and cab. A second male wearing a dark color uniform slams the door into the older male causing him to fall to the ground and strike his head and back on the truck.

A second short video: Shows the white flat-bed tow truck with a DT2 identified on the driver's door. Two males in dark uniforms matching the first video are lifting a vehicle onto the flat-bed and driving away.

A third video, which is 1:22 minutes: Starts with someone wearing a dark uniform seated in driver's side of a vehicle, but all that is seen is an arm on the interior door handle. A male's voice is heard saying, "That's an old man", and they start to open the driver's door. Next that same voice is heard telling someone, "Nah close my door", and they attempt to hold the door, but it's pulled open by a person wearing a gray jacket and red t-shirt. The person in the gray jacket is identified as the older male in the previous video, and later identified as Cornelius Erby.

Erby tells the driver that's his car and to get out, which the driver refuses while attempting to close the door. Erby reaches into the open door of the truck grabbing the driver, but stumbles back. Erby approaches the driver in an aggressive manner, at which time the driver states, he has a pocket knife, so second tow operator can hear it. Shortly after the door is slammed on Erby causing the fall.

On March 7, 2025, at 9:47AM., I conducted follow up with Erby at 1509 N. 18th St. He stated that he was physically okay. Erby stated he went to Walgreen's at N. 35th Street to pick up a prescription and parked in the same spot he has for over 30 years. While he was in the store an unknown male walked in and yelled someone's Caddy was being towed. Erby believe his car was being stolen, because of all the stories about tow trucks stealing cars. Erby ran out to check and seen his car on the back of a white tow truck. Erby stated he approached the truck with a small knife in hand, which he knows he shouldn't have done. Erby did not want to follow through with any additional police services, I advised Erby I would follow up with DT2 Towing and confirm everything was done within city ordinances. I ended my contact with Erby and advised him to call me if he had any additional questions.

At 11:13 AM., I conducted follow-up at 2620 W. Silver Spring Dr. DT2 Towing / KIT Express. I spoke to owners/ Agents (DT2) Don Thumond and David McElrath (KIT Express) regarding the incident. Thumond explained they have a contract with Walgreen's at 35th and Wisconsin Ave. During the morning of the incident his driver observed Erby's car parked in a restricted spot, which is posted. As the driver was loading the car, Erby approached his driver. The driver was attempting to talk to Erby, but observed Erby had a knife displayed. The driver was concerned for his and a second employees' safety. The driver attempted to defuse the situation, but due Erby being armed they could not. Once it was safe the driver and second employee fled the scene in the truck. The incident went viral, and the next thing he knew the owner, a news crew and alderperson were at the lot questioning the tow. Thumond explained what occurred and showed video that was captured on the driver's body camera, which helped answer everyone's questions. The car was released to Erby, with a discount, which Thumond explained is given to every elderly person.

McElrath showed me the video from the body camera, and explained they are used by all drivers to help in any disputes a customer may have. All of the drivers have uniforms they provide, so the public can see it is a legitimate company. McElrath stated that lot has multiple signs provided and posted from their company, and additional signs owned by Walgreen's advising of towing. I advised him that I was at the property earlier and confirmed signs are posted. McElrath stated the contract is to tow vehicles that are parked without consent, in fire lanes, handicap, or spot designated for online shoppers, which Erby was parked in. I advised McElrath to save the video encase it's needed in the future.

I spoke to the driver identified as Markell S. Love. He stated, the car was parked in a posted spot. He hooked the car up and as he was going to drive away he heard someone yelling and seen Erby running out towards him. Love stated, "That's an old man", and thought he would give him the opportunity to pay for the drop fee. When Erby approached the truck, he attempted to open the driver's door. Love observed the knife and attempted to calm Erby down, as he crawled out the passenger's door. As Love was talking to Erby and he refused to put the knife away, and a second employee pushed the door striking Erby in attempt to make it safe. Love and the second employee entered the truck and fled the area. Love was not hurt and did not want any additional police enforcement.
