I was turning left from 76th street onto Chambers St.

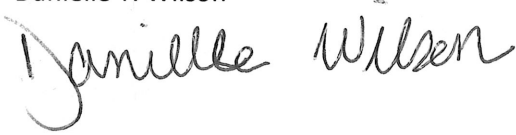
There were several pot holes and I drive into one and my tire blew.
