THE BUDGET SHOULD INCLUDE RETHINKING OF THE TRUE NEEDS OF EACH DEPARTMENT THAT SUBMITS A BUDGET. WHAT EACH DEPARTMENT DOES NOW IS ACCEPT THE PAST NEEDS AND AUTOMATICALLY ADD ON A % TO INCREASE VERSUS STARTING FROM SCRATCH TO DETERMINE THE REAL NEEDS OF THAT PARTICULAR AREA.

THE BUDGET SHOULD BE BASED ON WHAT EACH AREA/DEPARTMENT NEEDS AND THEN A COST SHOULD BE APPLIED. NOT AS THEY DO NOW WHICH IS TAKING WHAT WAS DONE IN THE PREVIOUS YEAR, WHETHER NEEDED OR NOT, AND ADDING/SUBTRACTING TO SHOW EXISTING NOT PRESENT / FUTURE NEEDS BUT PROJECTED PAST NEEDS.
