This report is written by Police Officer Kristyn Kukowski, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 03/30/2002 at 1:47am Milwaukee Police were sent to 2714 S 13th St., Camelot Show Lounge to investigate a subject with a weapon complaint. The bartender stated that there was fight in the downstairs dressing room between 3 female employees. The fight moved upstairs to the bar area and others became involved in the fight. The bartender closed the business. One of the fighters stated through the closed door to open the door so he could shoot the place up. Bartender then called the police. Officers issued 7 Municipal Court citations for Disorderly Conduct. Incident Report Filed

2. On 10/11/2002 at 12:18 AM officers responded to the licensed premises at 4730 N 76th St (Tommy's Goodtime) regarding a theft from auto. Investigation revealed that the theft victim had two handguns taken from the auto. The victim related that he had them concealed on his person when he tried to enter the licensed premises, but security discovered them and made the victim return the weapons to his auto. Security did not call police regarding the armed patron. The victim further related that he feels like he got set-up by security because there were no other autos in the lot. Incident Report Filed

3. On 04/25/2003 at 12:28 AM officers investigated a fight at Tommy's Goodtime, 4730 N 76th St. A drunken male was upset about having to pay a cover charge to get into the tavern, and then was upset while seated at the bar because he was refused to be served alcohol. Then the patron bumped other patrons a fight ensued. Incident Report Filed

4. On 12/16/2003 at 6:50 PM officers were dispatched to 4730 N 76th St, Tommy's, for a complaint of Reckless Endangering Safety. The bartender stated that a patron got into an altercation with a dancer on the stage. When the bartender attempted to pull the patron from the stage, the patron took out a handgun and began to wave the gun around. The suspect was not apprehended. Incident Report Filed

5. On 02/24/2005 at 1:40 AM officers responded to the licensed premises at 4730 N 76th St (Tommy's Goodtimes) regarding a Shooting, which occurred in the parking lot on the south side of the licensed premises. Employees of the tavern denied any knowledge of a shooting and could provide no additional information. Incident Report Filed

6. On 6-28-2005 at 10:30pm Milwaukee police were sent to 2714 S 13th St, Camelot Show Lounge, for a fight in progress. They spoke to a bartender, Joel Hall who stated that at about 10:15pm, an entertainer employed by the Camelot, started yelling at patrons and wanted to fight. The entertainer, stated that she believed that someone put something in her drink that made her sick, she knew that something wasn't right.

7. On 3-24-2006 at 9:20pm while investigating a man with a gun complaint in the area of 2600 S. 13th St., police were conducting tavern checks in the area. As they approached the Camelot, a male ran back into the tavern. Officers interviewed him and he later was arrested for Possession of Controlled Substance W/ Intent To Deliver THC.

8. On 10/20/06 at 11:39 pm, Milwaukee Police were dispatched to 2710 S 13th Street for a Shots Fired complaint. Investigation revealed that one shot was fired inside of Camelot Lounge. The bullet had traveled through the wall of the bar as well as the wall of the house next door. Officers did recover the bullet. Officers arrested the subject who fired the shot and recovered and inventoried the gun. The arrested subject blew a .10 on the intoxilizer that was administered and was charged with ESBUODW and CCW.

9. On 02/20/07 at 10:08 pm, Milwaukee Police were dispatched to a Battery Complaint at 13th and Cleveland. Investigation revealed there was an argument between two dancers at the Camelot Dance Club that resulted in one stabbing the other.

10. On 6-15-07, Detectives assigned to the Vice Control Division, investigated complaints of prostitution at the Camelot Lounge, 2714 So 13th Street. A dancer offered to perform an act of sexual intercourse with the officers, in exchange for money. On 6-18-07, she met the officer at the Hospitality Inn, 4400 South 27th Street, where she again offered to perform acts of both non-marital sexual intercourse and sexual gratification with the officer in exchange for \$150.00. She told officers she meets with customers at the Camelot Bar and engages in prostitution with them on a regular basis, when the opportunity presents itself.

On 6-15-2007, another Detective assigned to the Vice Control Division, investigating complaints of prostitution at the Camelot Lounge, 2714 So 13th Street, observed a dancer publicly and indecently expose her genitals while making eye contact with him. On 6-19-07, the officer returned to the Camelot Lounge, and found the dancer again, and arrested her Lewd/Lascivious Behavior.

11. On 7-25-07, at approximately 1:58AM, officers were dispatched to Club Camelot, 2714 South 13th Street, for an armed robbery complaint. The officers were told both victims were robbed at gun point by three masked individuals. Both victims are workers of the Club. One victim is a dancer and the other one is a bouncer at the club. The robbery occurred outside of the club while the employees were awaiting a ride.
12. On 10/11/07 at 8:25 pm, Milwaukee Police were investigating complaints of dancers/strippers at the Camelot Lounge. Uncover officers entered the tavern after being searched and frisked by the doorman. Officers observed a female dancing topless on a small stage behind the bar as she walked across the top of the bar. She would then solicit "tips" from the male patrons as music played from the jukebox by performing body gyrations close to the patrons until he/they offered her money. Officers further observed that nothing was covering her breasts and her thong underpants did not cover the cleavage of her buttocks. Officers recognized this woman from a previous prostitution arrest originating from the Camelot Lounge. Officers also observed three other female dancers/strippers in the same area, none of whom wore costumes that covered either the cleavage of their buttocks or the nipple and areola of their breasts. A citation was issued to the licensee, Terry Cullen, for Certain Costumes Prohibited.

13. On 10/16/07, Milwaukee Police were investigating complaints of prostitution of dancers and men soliciting prostitution at the Camelot Lounge. At 10:45 pm, an undercover officer entered the Camelot Lounge and shortly there after was approached by a dancer/stripper who engaged the officer in conversation. This woman offered to have non-marital sexual intercourse with him in exchange for \$100.00. The woman was taken into custody at 3915 S Howell, where she agreed to meet to complete the act of prostitution. A search of the woman revealed she was in possession marijuana. The licensee, Terry Cullen, was issued a citation for Certain Costumes Prohibited. The woman was charged with Prostitution and POCS-Marijuana.
