If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. This report is written by Police Officer Penny Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 07/18/21, officers were dispatched to 1407 S. 1st., for a Fight. Officers were advised a fight broke out in the parking lot, however, staff were able to separate the two groups. There were a few subjects remaining in the lot, who denied being involved in the fight, however, were asked to leave. Employees were cooperative throughout the investigation.
- 2. On 07/20/21, officers were dispatched to 1407 S. 1st., for a Battery. Officers were advised by the victim that on 07/18/21, a bunch of friends were in the bar watching a game together, when one of the friends became aggressive with the victim. A fight broke out and the victim was struck with a closed fist, a chair, and a beer bottle to the back of the head. Video surveillance was retrieved of the incident and employees stated they did not call the police, due to the fact they knew they were all friends and believed they would work it out themselves.
- 3. On 08/08/21, officers were dispatched to 1407 S. 1st St., for a Shooting, that was later determined to be a Fight. Squads were advised a male was laying on the ground outside of the restaurant and appeared to be shot, however, on arrival officers could not locate a victim. Multiple subjects advised officers a fight broke out inside the bar, however, employees in the bar were very uncooperative with the investigation refusing to answer officers questions, interrupting and yelling over officers.

On Sunday, July 18, 2021 at approximately 11:33 PM, we were dispatched to Fiesta Cafe (1407 S. 1st St.) regarding a fight complaint.

Upon arrival, Daniel CRUZ-CRISPIN (W/M, 5-17-92) stated there were two group of males (one group of approximately two males and a group of approximately five males) that were fighting in their parking lot, CRUZ-CRISPIN stated they called 911 for police assistance. CRUZ-CRISPIN stated they were able to separate the two groups of males that were physically fighting. CRUZ-CRISPIN stated they told both groups to leave the premise.

Upon arrival, we spoke with a group of five unknown males in the parking lot which stated they were not involved in any physical altercation. CRUZ-CRISPIN stated if we could ask the group of males to also leave the premises. The group of approximately five males left the premises.

CRUZ-CRISPIN was advised that a licensed premise report would be filed.

CRUZ-CRISPIN was cooperative throughout our investigation.

This report is typed by P.O. Misael VASQUEZ, Assigned to District Two, Squad 2323, Late shift.

On Tuesday, July 20, 2021 P.O. Kevin FREY and I Were dispatched to 1719 S. 36th St to a battery compliant, that was determined to be a sub battery.

Upon arrival, I spoke to the victim who identified himself as Oscar M. CAMPA (M/W 05-15-74) who provided me the following statement verbally. CAMPA stated that on 07-18-21 at approximately 11:00 pm and 1:00 AM on 07-19-21 he had gone to 1407 S 1st ST. to (Cafe Fiesta) who watch the soccer game with some friends. CAMPA stated while at Fiesta Cafe, some friends of his Miguel.V, Adrian.V, Mario.V, and an unknown fourth male arrived to the location as well. CAMPA stated while there Adrian.V kept coming up to him and putting his hands around his neck and squeezing it. CAMPA stated after the third time he told Adrian.V to stop and get away from him. CAMPA stated Adrian.V became aggressive with him and Miguel.V then came to see what the problem was. CAMPA stated he did not want any issues and wanted to end the altercation. CAMPA stated he shock Adrian's hand when he was hit but was not sure by who. CAMPA stated he began to get beat up by all four suspects. CAMPA stated they hit him with a closed fist, a chair, and a beer bottle to the back of his head. CAMPA stated he left the location and went home.

Follow up was not completed right away, because I was off the following two days and a buck slip was completed for follow up to be done by another shift. It was not done till days later after the incident occurred.

Squad 2425 P.O. PICENO and P.O. GUSTAVO went an conducted follow up by retrieving video from inside of the restaurant, which captured the incident. When they asked the employee why police were not called. the employee stated they knew the victim and the suspects were friends and believed it was just a disagreement and they would work it out. Employee had nothing further to say

INITIAL INVESTIGATION

This report is being written by PO Jacob TOMASZEWSKI assigned to District Two, Late Shift, Squad 2320. On August 8, 2021 at approximately 2:19 AM, my partner PO SOSA JR and I, were dispatched to 1407 S 1ST ST (Fiesta Cafe), which is located in the City and County of Milwaukee, WI to investigate a Shooting that was later determined to be a fight that originated inside of Fiesta Cafe, which no individuals were injured. No Shooting occurred.

Responding squads were advised that a male subject was lying on the ground outside of the restaurant and appeared to have been shot. Upon arrival, we observed dozens of intoxicated customers running in the middle of the street, on the sidewalk, and still inside the restaurant. Multiple subject outside the bar stated that a bar fight had broken out inside the restaurant. Responding Squads could not locate any subject that was said to have been lying on the ground shot. I then entered the restaurant, which was in disarray, where I attempted to speak with management. I identified the manager as, Melissa G. ESCOBAR (W/F 06-16-1993). ESCOBAR stated that her mother-in-law, ROSA I. REAL PEREZ (W/F 02-10-1969), was the licensee holder for the establishment.

I asked ESCOBAR what had happened prior to our arrival, however she was hesitant to answer any questions. ESCOBAR then stated that nothing had happened inside the restaurant and wanted to know why POLICE were at the restaurant. I attempted several times to explain why we were at the restaurant, however I was constantly interrupted by the highly uncooperative restaurant employees, who were yelling at me. I then stated that I needed the see the restaurant's Tavern License which angered the restaurant staff. After several minutes an employee showed me an active, up-to-date, Class B Tavern License (License# 020313) with an expiration date of 07-18-2022.

ESCOBAR was provided with my Community Contact Card.

The hearing before the Licenses Committee will take place virtually on 06/28/2022 at 10:50 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
