I object to the recommendation of the Licenses Committee decided on October 17<sup>th</sup>, 2023, for the approval of the Applicant's applications for the above-stated licenses. This matter is scheduled to be heard by the full Common Council of the City of Milwaukee for approval October 31<sup>st</sup>, 2023.

The Licenses Committee overlooked possibly by mistake, the fact that there are three Family Day Care Centers and one Group Day Care Center directly across the street from the proposed applicant's location.

An application for a Class A or Class B license for the sale of intoxicating liquor requires that a report of the Commissioner of Neighborhood Services shall include a statement as to whether the main entrance of the premise is less than 300 feet from the main entrance of any church, school, DAY CARE CENTER or hospital. (emphasis added)

A report of these findings was given by Mr. Cooney of the City of Milwaukee License Division to the License Committee at the hearing stating that three of the four Day Care Centers were less than 300 feet from their premises.

Therefore, I am asking that the Common Council of the City of Milwaukee and my Alderperson, to please move to return this matter to the Licensing Committee for further review on the day care issue before the granting of these licenses.
