On Monday, January 25th, 2025, at approximately 9:16 PM, I conducted a license premise check at the address of 2237 N. Holton St., located in the City and County of Milwaukee (WI). This address is a place of business called Holton Gas and Food Mart (CITGO).

I arrived on scene at approximately 9:16 PM, in a marked Milwaukee Police Department (MPD) vehicle and in full duty uniform. I was equipped with my Axon Worn Body camera, which was activated during portions of this investigation.

Upon arrival, I met with the clerk, who later verbally identified himself as Baljinder SINGH (W/M 01-23-94). I introduced myself and explained to SINGH that I would be conducting a license premise check and ask a variety of questions regarding this location. SINGH brought me to the licenses, which were posted behind the counter on a door. I observed the following licenses:

I began to ask SINGH questions regarding this location and it appeared there was a small language barrier. SINGH did ask if I wanted him to call his boss and I stated that would be fine. I spoke with a male subject, who verbally identified himself as Punit JAISWAL (W/M 12-06-77), who also stated he was the agent for this location. I explained to JAISWAL why I was at this location and asked him some questions regarding the location. JAISWAL stated that he recently took ownership of this location.

I informed JAISWAL that I noticed that he has a license for extended hours at this location. Before conducting this license premise check, I looked up the listed hours of operation and observed the following on the City of Milwaukee License Search Website:

I asked JAISWAL if there were any security officers employed at this location and JAISWAL stated no.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.


