Mr. Barlow and Mr. Cushing addressed the following concerns:

The report of 15 citations issued to Pinnacle Security between May 2, 2007 and August 9, 2007 for unverified burglar alarm calls to the Milwaukee Police Department.

Concerns that Pinnacle Security, LLC has installed alarm systems that can be used as "panic alarms" which are illegal in the City of Milwaukee.

Pinnacle Security representatives have misrepresented to the general public information that the Milwaukee Police Department will be sent when alarm systems are activated, when in fact, no response will be made unless a private security firm verifies the existence of an actual alarm first.

Members of the Public Safety committee requests Pinnacle Security submit a corrective plan of action to address the issues identified prior to the time that the Common Council is scheduled to meet on January 15, 2008 to consider this application for renewal of its Private Alarm System Business license.

This matter was forwarded to the Common Council without recommendation as to the renewal of the Private Alarm System Business license held by Steven P. Zolman as agent for Pinnacle Security, LLC.
