That I have surveyed, divided and mapped Lot 19, Lot 20, Lot 21 and Lot 22, Block 255, Continuation of Brown's Addition in the Northeast 1/4 of the Northwest 1/4 of Section 19, Town 7 North, Range 22 East, in the City of Milwaukee, Milwaukee County, Wisconsin, which is bounded and described as follows:

Commencing at the Northeast corner of said Northwest 1/4 of Section 19; thence North 89°06'36" West along the north line of said Northwest 1/4 of Section 19, 996.81 feet to the centerline of N. 23rd Street; thence South 00°34'26" West along said centerline, 503.47 feet; thence South 00°39'31" West continuing along said centerline, 501.77 feet to the centerline of W. Lloyd Street; thence South 89°19'41" East along said centerline of W. 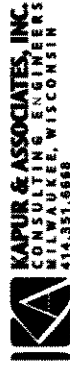
That I have made the survey, land division and map by the direction of The Redevelopment Authority of the City of Milwaukee.
