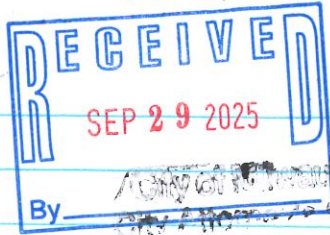

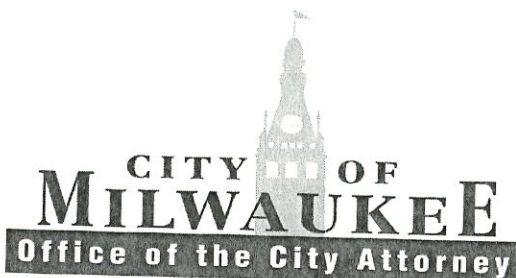

Dear Mr. Clemons:

We have received your claim for the alleged damage to your vehicle that occurred on February 1, 2025.

According to the Milwaukee Police Department's and the motor vehicle crash report, you were involved in a single vehicle accident. The motor vehicle report also states that you collided with the median curb and sidewalk curb while traveling westbound on W. Villard Avenue. In addition, video footage shows your vehicle on the curb when the Milwaukee Police Department arrived on scene to assist you after they received a 911 call. Since the Milwaukee Police Department did not cause the damage to your vehicle, the City of Milwaukee is not liable and your claim is denied.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.
