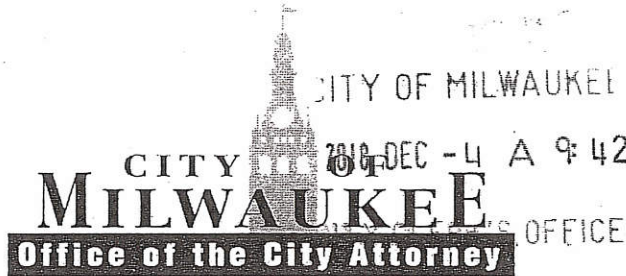

Dear Mr. Quigley:

We have received your claim in the amount of \$3,100.00 from a loss on July 4, 2018.

The Infrastructure Services Division records indicate that a reconstruction of the roadway project on Greenfield Avenue started in this area in April 2018 and resulted in construction debris being left in the City's sewer main. This is a State of Wisconsin project, WisDOT Project ID 2230-00-74. Their address is State of Wisconsin Dept. of Transportation, Waukesha Transportation District 2, 141 NW Barstow Street, P.O. Box 798, Waukesha, WI 53187-0798. The contractor involved is Zignego Company, Inc. Their address is W226 N2940 Duplainville Road, Waukesha, WI 53186. Since the City of Milwaukee is not involved in this, it cannot accept liability. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.
