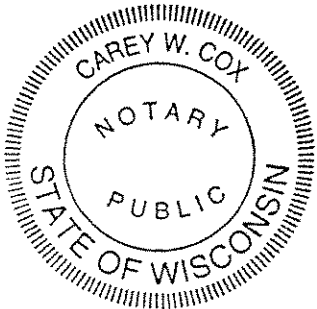

060617 . . . Substitute ordinance relating to the change in zoning from Two-Family Residential to Local Business, on land located West of North Farwell Avenue and South of East Greenwich Avenue, in the 3rd Aldermanic District.

060705 . . . Substitute ordinance relating to the change in zoning from Local Business and Multi-Family Residential to General Planned Development, on land located generally on the East Side of North Downer Avenue and South of East Park Place and land located generally on the West Side of North Downer Avenue and the East Side of North Stowell Avenue, North of East Webster Place, in the 3rd Aldermanic District.

061038 . . . A substitute ordinance relating to taxicab meter rates.

061141 . . . Substitute ordinance relating to the change in zoning from Industrial Heavy to General Planned Development, on land located on the South Side of West Mount Vernon Avenue and West of North 16th Street, in the 8th Aldermanic District.

061158 . . . An ordinance relating to the zoning code technical committee.

061192 . . . A substitute ordinance relating to parking controls in various Aldermanic Districts.

061193 . . . A substitute ordinance relating to traffic controls in various Aldermanic Districts.

061194 . . . Substitute ordinance to further amend the 2007 rates of pay of offices and positions in the City Service under control of the Common Council.
