Returned herewith is a document filed by Attorney Laurie Eggert for attorney's fees for representing Police Officers Branko Stojsavljevic, Daniel Dzievit and Matthew Goldberg. The claim is in the amount of \$1,417.03 including \$20.03 in disbursements for 12.70 hours of service billed at the rate of \$110.00 per hour. We ask that this matter be introduced and referred to the Committee on Judiciary & Legislation.

We have reviewed this claim and advise that in our opinion, the time spent was reasonable. Legal representation was occasioned by a criminal investigation. No criminal charges were brought against the Police Officers on whose behalf this claim was filed.

SIR:

This report was dictated by Detective Glenn ZIRGIBEL, of the Internal Affairs Division/Criminal Investigation Unit (IAD/CIU), day shift.

ALLEGATION:

The complainant Morris KELLY alleges that he was beaten by several unknown City of Milwaukee police officers on February 19, 1999. Mr. KELLY states that he suffered three broken ribs as a result of his beating by the City of Milwaukee police officers.

INVESTIGATION:

Mr. Morris KELLY first filed his complaint in writing on June 16, 1999 and it was assigned to be investigated by Det. Glenn ZIRGIBEL by June 25, 1999. Numerous attempts to interview Mr. KELLY regarding this matter met with negative results and he was a noncooperative complainant until November 18, 1999, at which time he finally did appear at the IAD offices and give a statement in regards to this matter. In his complaint Mr. KELLY alleges that he was arrested by City of Milwaukee police officers on February 19, 1999, at approximately 11:30 p.m. as he was leaving a bar at 4322 W. Fond du Lac Avenue. Mr. KELLY indicates he was arrested for no reason at all and was beaten, kicked and maced by

and was standing in the front door. She states that she observed police officers arrest numerous people in the two groups that were fighting and she stayed in the door the entire time the incident was going on. She stated at no time did she observe the officers act in any type of an unprofessional manner toward Mr. KELLY or any of the other people they arrested. Miss POWELL was very candid in her statement and stated that none of the officers struck anybody that she could see and she again stated the officers appeared to be very professional in their conduct while making these arrests. Mr. KELLY was charged by the City Attorney's office with Obstructing and Disorderly Conduct. He pled guilty to Disorderly Conduct on September 3, 1999, and was fined \$115.00.

CONCLUSION:

Mr. KELLY alleges that he suffered broken ribs at the hands of City of Milwaukee police officers, however there is no direct evidence other than Mr. KELLY'S statement to support his claim. Mr. KELLY further states that there were four to five friends and relatives of his who were present when this occurred, yet none of those people would come forward to be interviewed by detectives nor would they appear at the District Attorney's office regarding this matter. There is therefore no evidence to support Mr. KELLY'S claim that he was battered by City of Milwaukee police officers on February 19, 1999 and this complaint is being cleared with a "warrant refused" by Assistant District Attorney Gerald FALK.
