Dear Mr. Horning:


This office is in receipt of your claim in the amount of \$560.61, relating to damage sustained to your vehicle on February 7, 2002 when you allegedly drove over an unmarked Median Island at West North Avenue & North Humboldt Boulevard.

The Infrastructure Services Division records indicate there were 2 Median Islands signs reported missing in the 1800 block of East North Avenue on March 12, 2002. They were subsequently replaced by a sign crew on March 12, 2002 at 12:00 PM. A third sign marking a third Median Island in the area was found to be in place. When the Division was made aware of the missing Median Island signs, a crew was sent to replace said sign. Prior to the report on March 12, 2002 the division did not have any knowledge of a missing signs along the 1800 block of East North Avenue and because the City had no prior notice we cannot accept liability for your loss. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
