The Milwaukee Police Department's investigation regarding this application revealed the following:

The following items pertain to Raunak Petro located at 2242 N. 12th Street.

1. On 03/26/25, at 10:16 p.m., Officers were dispatched to an Armed Robbery. The victim was approached inside of the business by two masked armed suspects. The suspects demanded and took the victim's gun, jewelry, and wallet. Security video footage was available of the incident.
2. On 05/13/25, at 7:54 p.m., officers conducted a Business check. An employee stated they were having problem with loitering, but did not know how the manager wanted it handled. No violations observed.
3. On 06/16/25, at 10:38 p.m., officers were dispatched to a Welfare check. An intoxicated subject was found lying on the ground near the door. Milwaukee Fire Department provided medical attention and the subject was transported to a local hospital. No police services were needed.

On Wednesday, March 26, 2025 at approximately 10:16 pm P.O. Brandon BUELOW and I (Squad 3450 in full duty uniform, operating a marked MPD squad, and equipped with Axon body worn cameras affixed to our outermost garment and recording at the time of this incident) were dispatched to 707 W. Somers St., which is located in the City and County of Milwaukee for an armed robbery call for service that occurred at 2242 N. 12th St. (Clarke Gas Station), which is also located in the City and County of Milwaukee.

Call Notes:

Prior to our arrival we were advised by dispatch that the caller stated he was robbed of his jewelry, gun, and wallet by subjects in a black Nissan at a Citgo gas station at N. 12th St. and W. North Ave. Caller stated he was now home and was not hurt.

Initial Investigation:

Upon arrival to 707 W. Somers St. we made contact with our victim/caller who identified himself as Cameron J. MCBRIDE-SHELBY (b/m, 12-15-98). MCBRIDE-SHELBY stated that around 10:00 PM he went to the gas station at N. 12th St. and W. North Ave. across the street from American Subs. MCBRIDE-SHELBY stated that he parked his vehicle near a pump and went into the gas station to get some snacks and then he was going to go home. MCBRIDE-SHELBY stated that he was near the drink cooler grabbing a drink. MCBRIDE-SHELBY stated that as he turned around to go to the cashier he was approached by what he thought was 2 subjects with black ski masks on as well as had a gun pointed at him. MCBRIDE-SHELBY stated that the subjects demanded his property and took his wallet, firearm, and jewelry. MCBRIDE-SHELBY stated that the subjects then walked him outside and told him to stay there and if he went to his vehicle they would shoot him. MCBRIDE-SHELBY stated the subjects walked back to a black Nissan possibly a Maxima, but before leaving one of the subjects took a picture of his vehicle plate. MCBRIDE-SHELBY stated that the subjects then fled in the black Nissan eastbound on W. North Ave. MCBRIDE-

Upon our arrival I observed several cars next to the self-serve gas pumps along with some patrons inside the convenience store.

I spoke to licensed premise employee who identified himself via WI driver's license as Ait PAL (A/M, 04/14/76) who did not speak English very well. On scene I also spoke with another worker who refused to identify himself who stated they were having trouble with loiterers but did not know how his manager would like to handle them.

The business had no security officers on scene at the time of our arrival.

While on scene, I observed the licenses posted and they were up to date. During my investigation for the business check I did not observe any violations in the licensed premise.

Initial Investigation:

Upon arrival, we observed a small number of customers at the establishment who were conducting standard business. We made contact with the gas station clerk, who was identified as Syederif A. QUADRA (u/m 5/16/1978). QUADRA called in and reported an incident that occurred today. QUADRA was cooperative with the investigation.

The establishment had no security officers at this time.

Video surveillance footage was observed, and follow-up was requested to obtain the video and upload it to evidence.com

Officers observed a black female, approximately 30 years old, thin build, approximately 5'05, short black hair, dark complexion, observed wearing pink zip up hooded sweater, pink leggings and pink slip-on shoes on at the establishment from approximately 4:40pm to 5:00pm, the subject began tipping the garbage cans near the pumps. She then begins to strike the windows with a closed fist. She later obtains a black box and tosses it to the window, causing the box to break. She finally obtains a large rock and smashed the two-pane window before fleeing on foot west from the location.


