Re: Report of the Renewal Application of Eric Streff, as agent for "Noodles on North, LLC" for a Class "B" Tavern and Record Spin license, for the premises located at 1000 East North Avenue in the City and County of Milwaukee, Wisconsin ("Crooners Nightlife").

FINDINGS OF FACT

1. Eric Streff (hereinafter the "Licensee") is the agent for "Noodles on North, LLC" doing business at 1000 East North Avenue in the City and County of Milwaukee, Wisconsin ("Crooners Nightlife"). Said license expires at midnight, October 9, 2001.
2. An untimely application to renew said license was filed with the Office of the City Clerk on September 18, 2001.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On September 20, 2001 the Milwaukee Police Department responded with a report which could form the basis for non-renewal or suspension of the Class "B" Tavern and Record Spin license held by "Noodles on North, LLC" for 1000 East North Avenue ("Crooners Nightlife"). There were also neighborhood objections to loitering, littering, underage patrons, fighting, after-hours parties, dances on the premises without proper licenses, traffic problems, suspected drug activity and conduct detrimental to the health, safety and welfare of the neighborhood.
4. On September 25, 2001, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of a report of the Milwaukee Police Department that could form the basis for suspension or non-renewal of the licenses of the Licensee, and included therewith a copy of the Milwaukee Police Department report and notice of neighborhood objections. The matter was scheduled for a hearing on the police department report on October 2, 2001, commencing at 9:00 a.m. in Room 301-B of the third floor of City Hall. At said date, time and place, the Licensee appeared at the hearing and admitted receipt of the notice of hearing together with a copy of the Milwaukee Police Department report. The Licensee was represented by Attorney Bruce B. Jacobson, 250 West Coventry Court, Suite 108, Milwaukee, WI 53217.

5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
- A. On June 4, 2000, the applicant was arrested for operating his vehicle under the influence of an intoxicant at 5052 North 81st Street, in the City and County of Milwaukee, Wisconsin. On April 6, 2001, he was found guilty and fined \$682.50.
 - B. On March 9, 2001 at 1:45 a.m., officers of the Milwaukee Police Department made a lawful inspection of the licensed premises at 1000 East North Avenue in the City and County of Milwaukee, Wisconsin ("Crooners Nightlife") and found an underage patron. The licensee was cited for presence of underage person. On July 2, 2001, he was found guilty and fined \$346.00.
 - C. On April 21, 2001 at 2:34 a.m., officers of the Milwaukee Police Department responded to the licensed premises at 1000 East North Avenue in the City and County of Milwaukee, Wisconsin ("Crooners Nightlife") regarding a tavern violation. While there, the officers discovered 9 patrons after the legal closing time. The licensee was cited for patrons after hours, and on July 11, 2001 was found guilty and fined \$336.00.
 - D. On April 27, 2001 at 1:11 a.m., officers of the Milwaukee Police Department responded to the licensed premises at 1000 East North Avenue in the City and County of Milwaukee, Wisconsin ("Crooners Nightlife") regarding a neighborhood complaint of loud music. During the investigation, officers discovered 10 underage patrons in the tavern. All underage patrons were cited, as well as the applicant. On June 21, 2001, the licensee was found guilty and fined \$346.00.
 - E. On May 11, 2001 at 1:00 a.m., officers of the Milwaukee Police Department responded to the licensed premises at 1000 East North Avenue in the City and County of Milwaukee, Wisconsin ("Crooners Nightlife") regarding a neighborhood complaint of loud music. While there, officers observed the front door open and loud music coming from the tavern. The licensee was cited for door to be kept closed after 10:00 p.m. and noise nuisance. He was found guilty on both citations and fined \$336.00 on the citation regarding open doors after 10:00 p.m. and fined \$206.00 regarding the noise nuisance all on August 23, 2001.
 - F. On May 22, 2001 at 1:25 a.m., officers of the Milwaukee Police Department responded to the licensed premises at 1000 East North Avenue in the City and County of Milwaukee, Wisconsin ("Crooners Nightlife") regarding a neighborhood complaint of loud music. The

officers observed loud music coming from the premises. The agent of the licensee was cited for noise nuisance and on August 16, 2001 was found guilty and fined \$213.00.

- G. On August 20, 2001 at 5:10 p.m., officers of the Milwaukee Police Department made a lawful inspection of the licensed premises at 1000 East North Avenue in the City and County of Milwaukee, Wisconsin ("Crooners Nightlife"). The officers observed that the tavern license was not displayed. The agent of the licensee stated that he was advised "by the City" that the licenses could be kept in an envelope. The agent of the licensee was cited for display of license which is pending for October 11, 2001.
- H. On August 21, 2001 at 6:50 p.m., offices of the Milwaukee Police Department made a lawful inspection of the licensed premises at 1000 East North Avenue in the City and County of Milwaukee, Wisconsin ("Crooners Pub"). They observed that the tavern license still was not being displayed. The licensee was cited for display of license which is pending for October 11, 2001.
- I. On August 22, 2001 at 12:55 a.m., officers of the Milwaukee Police Department made a lawful inspection of the licensed premises at 1000 East North Avenue in the City and County of Milwaukee, Wisconsin ("Crooners Nightlife"). The officers observed that the tavern license still was not being displayed. Agent of the licensee was cited for display of license which is pending for October 11, 2001.
- J. On September 11, 2001 at 12:25 a.m., officers of the Milwaukee Police Department responded to the licensed premises at 1000 East North Avenue in the City and County of Milwaukee, Wisconsin ("Crooners Nightlife") to investigate a "man with a gun" complaint. Upon entry to the premises, officers observed the person who was described in the complaint as the man with the gun. The officers observed that the man was holding a semi-automatic handgun. The investigation revealed that he was a convicted felon, also in the possession of cocaine. The person was also 19 years of age. There was also another underage person in the tavern at that time. The applicant was not on the scene nor was there a licensed bartender on the scene. The agent of the licensee was cited for presence of an underage person, no responsible person upon the licensed premises and obstructing officers. The foregoing matter, citations are pending for November 1, 2001.
- K. On September 18, 2001, the License Investigation Unit received a complaint from a neighbor regarding the licensed premises at 1000 East North Avenue in the City and County of Milwaukee, Wisconsin ("Crooners Nightlife") regarding sales from the upper level of the tavern.

The neighbor observed eight to ten people drinking alcohol in an unlicensed part of the premises. The investigation regarding that matter was pending at the time of the hearing in this matter.

- L. On September 18, 2001, at 200 East Wells Street, Eric C. Streff submitted a renewal application for this premises which was sworn before a Notary Public. The application asks in questions 5a and 5b if the applicant has been convicted or is pending or whether there are pending cases from other places. Mr. Eric C. Streff answered "no" to that question. Mr. Streff, however, has been convicted six times in municipal court in case numbers 01033422, July 2, 2001; 01041963, conviction date July 11, 2001; 01052585, conviction date June 21, 2001; 01058192, conviction date August 23, 2001; 01058193, conviction date August 23, 2001; and 01060924, conviction date August 16, 2001. Additionally, Mr. Streff also has six pending cases in municipal court for citations issued on August 20, 2001, August 21, 2001 and August 22, 2001, and three citations on September 11, 2001. As a result, Mr. Streff was cited for truth of statements which is pending for November 14, 2001.
- M. Mr. Streff has been the licensee for this location for one year and amassed the foregoing record.
- N. There were neighbors prepared to testify, but the Committee determined their testimony was not necessary because of the police report.


CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based upon the above facts found, the Committee concludes that the Licensee, Eric Streff, as agent for "Noodles On North, LLC" d/b/a "Crooners Nightlife" at 1000 East North Avenue has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of his Class "B" Tavern and Record Spin license. The Committee finds the police report to be true.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Utilities and Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Class "B" Tavern and Record Spin license held by Eric Streff, as agent for "Noodles on North, LLC", for the premises located at 1000 East North Avenue in the City and County of Milwaukee, Wisconsin ("Crooners Nightlife") based on police objections.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes recommends that the Class "B" Tavern and Record Spin license for the premises at 1000 East Lincoln Avenue ("Crooners Nightlife") in the City and County of Milwaukee, Wisconsin not be renewed.

Re: Report on the Renewal Application of the Class "B" Tavern and Tavern Dance License of Juan J. Sendejo, Sr., for the premises located at 2325 South 13th Street in the City and County of Milwaukee, Wisconsin ("Johnny's Yellow Rose").

FINDINGS OF FACT

1. Juan J. Sendejo, Sr. (hereinafter "the Licensee") is the holder of a Class "B" Tavern and Tavern Dance License for the premises located at 2325 South 13th Street in the City and County of Milwaukee, Wisconsin ("Johnny's Yellow Rose "). Said license expires at midnight on November 3, 2001.
2. An application to renew said license was filed with the Office of the City Clerk on September 10, 2001.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On September 12, 2001, the Milwaukee Police Department responded with a report that could form the basis for suspension or renewal of said license.
4. On September 24, 2001 the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police department report on October 2, 2001, commencing at 2:00 p.m in Room 301-B of the third floor of City Hall. At said date, time and place, the licensee appeared but was not represented by counsel.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. City Ordinance 90-4-1-b states: "Applicable to Family Members. Any member of the immediate family and household of the licensee, 21 years or older shall be considered as holding a class D operators license so long as he or she is working on the family premises." Carmen Sendejo, wife of licensee, was cited for responsible person upon a licensed premises and advertising prices in the window. On August 12, 1987 she was found guilty of each and fined \$75.00.
 - B. Carmen Sendejo, wife of licensee, was also cited for sale to underage person and no responsible person upon a licensed premises, found guilty on sale to an underage person and a one-year hold on no responsible person upon a licensed premise and fined \$139.00 on March 20, 1993.

- C. Carmen Sendejo, wife of licensee, was cited for sale to an underage person and presence of underage person upon a licensed premises. The citation with respect to sale to an underage person was dismissed, but she was found guilty of presence of an underage person upon licensed premises and fined \$325.00 on July 19, 1994.
- D. On July 5, 1996 at approximately 10:00 p.m. Carmen Sendejo was arrested by Milwaukee police officers while they were attempting to arrest her son for battery. Carmen Sendejo interfered with the arrest by yelling profanities at the officers and trying to hit and kick them. She had to be removed and handcuffed and transported to District 1 to be booked. In route to the jail she continually screamed and kicked at the sides of the patrol wagon and door. She was cited for disorderly conduct and obstructing officers. She was found not guilty with respect to disorderly conduct on September 23, 1996. She was sentenced to a six-month hold open on the obstructing officer charge on December 17, 1996.
- E. On March 1, 1997 at 10:00 p.m. Milwaukee police officers conducted a lawful tavern check of the "Club Carnival" located at 2394 South Kinnickinnic Avenue, Milwaukee, Wisconsin. One patron was found to be underage and drinking an alcoholic beverage. The bartender, Linda Pelnar, stated she did not card this person because she was told by a regular that this person was 21. The licensee, Carmen Sendejo, was not on the premises. Carmen Sendejo was cited for presence of an underage person (licensee responsibility) and sale to an underage person (licensee responsibility). Neither citation was issued on March 24, 1997, however, because the bartender Linda Pelnar, was cited for presence of an underage person and sale of alcohol to an underage person and pled guilty to presence of an underage person in exchange for non-issuance of the citation with respect to sale of alcohol to an underage person and fined \$332.50, on June 27, 1997.
- F. On January 10, 1998 at approximately 11:00 p.m. Milwaukee police officers responded to a shooting at the licensed premises at 2325 South 13th Street ("Johnny's Yellow Rose"). The investigation revealed that David Cherry (dob 12/19/76) was attending a birthday party at the location when he saw a window break and heard six gunshots. Mr. Cherry then noticed that he had been shot. Mr. Cherry stated that he did not see the shooter but stated that he knew it was a member of the Mexican Posse Street gang. A 17-year old witness stated that the suspect came into the hallway entrance with several other individuals, and at that point thought they were going to end up fighting. The 17-year old stated to a suspect "If we're going to fight let's just fight and get it over with." At that time the suspect stated "MP-C-14 Killers" and pulled out a pistol, pointed the gun in his direction and fired 2 or 3 times. The bullets struck Mr. Cherry. The suspect was identified and a warrant was issued for his arrest. The suspect turned himself in to police.
- G. On March 1, 1997 at approximately 11:58 p.m. Milwaukee police officers were dispatched to the licensed premises at 2325 South 13th Street ("Johnny's Yellow Rose") regarding a loud music complaint. As officers approached the premises, they could hear music from approximately one block away. The officers entered the tavern and spoke to Juan Sendejo who immediately turned down the music. Mr. Sendejo stated that his business is a tavern with a dance hall and that in the dance

hall there was a rave-style dance in progress which was the source of the loud music. Two citizen witnesses were interviewed, both of whom stated that the music coming from the tavern was loud and disruptive. One of the citizens stated that she was experiencing other problems associated with this tavern, specifically people leaving the tavern and fighting or being otherwise loud and boisterous and also people leaving the tavern with beer bottles and littering on the sidewalk and the alley next to her house. This individual also state that people leaving the tavern were urinating in the alley next to her residence. Upon checking for a posted licenses, they were found by the bartender in a closed envelope on the side of the cash register. The licensee was cited for display of license and noise nuisance. The display of license citation was dismissed without prejudice because of error and the citation on June 29, 1999. The City Attorney refused to issue the noise nuisance citation on June 3, 1999.

- H. On October 5, 1999, the Milwaukee Common Council voted to grant renewal of the Class "B" Tavern license with a ten-day suspension and non-renewal of the tavern dance license.
- I. On February 29, 2000, the Milwaukee Common Council again granted this premise a Tavern Dance License.
- J. On April 29, 2001, Milwaukee police officers investigated two battery complaints which occurred at the licensed premises at 2325 South 13th Street ("Johnny's Yellow Rose). The investigation revealed that a reputed members of the Mexican Posse Street gang were at a party at the licensed premises and a fight occurred. The licensee stated that he remembered the fight and that the police were called though there was no record of him calling the police. The licensee related that it was a "baptism party" and the fight occurred outside. The Milwaukee Police Department filed an incident report.

CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based upon the above facts found, the Committee concludes that the Licensee, Juan J. Sendejo, Sr. has not met the criteria to allow renewal of his Class "B" Tavern and Tavern Dance license without undergoing a ten (10) day suspension of said license.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Utilities and Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew with a ten (10) day suspension of the Class "B" Tavern and Tavern license of Juan J. Sendejo, Sr. for the premises located at 2325 South 13th Street in the City and County of Milwaukee, Wisconsin ("Johnny's Yellow Rose ") based upon his past activities a Licensee and for the danger that


the continued operation of the premises poses to the health, safety and welfare of the citizens of the City of Milwaukee.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes, one (1) noes and one (1) excused, recommends that the Class "B" Tavern and Tavern Dance License of Juan J. Sendejo, Sr. for the premises located at 2325 South 13th Street ("Johnny's Yellow Rose") in the City and County of Milwaukee, Wisconsin be renewed with a ten (10) day suspension.

Said suspension is to be in effect from midnight on November 3, 2001 through midnight, November 13, 2001.

FINDINGS OF FACT

1. David Karpinski, II (hereinafter the "Licensee") is the holder of a Class "D" Bartender License in the City and County of Milwaukee, Wisconsin. Said license expired at midnight, December 31, 2000.
2. An untimely application to renew said license was filed with the Office of the City Clerk on September 13, 2001.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On September 14, 2001, the Milwaukee Police Department responded with a police report that created a basis for renewal of said license.
4. On September 21, 2001, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report on October 2, 2001, commencing at 10:00 a.m. in Room 301-B of City Hall. At said date, time and place, the Licensee appeared at the hearing and was unrepresented by counsel.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On October 8, 1999 at 1:55 a.m., the licensee was cited for disorderly conduct outside of the licensed premises at 1225 North Water Street (Luke's Sports Bar Spectacular"). He was found guilty and fined \$115.00 on December 23, 1999.
 - B. On March 24, 2001, the licensee was arrested in a motel at 8060 South 27th Street, Milwaukee, Wisconsin for possession of a controlled substance-

cocaine. The matter was adjudicated on October 1, 2001 and he was found guilty.


CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based upon the above facts found, the Committee recommends that the Class "D" Bartender license of David Karpinski, II not be renewed.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes to two (2) noes, recommends that the Class "D" Bartender License of David Karpinski, II not be renewed based on police objections.
