Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 07/16/22 at 10:14pm, Milwaukee Police conducted a license premise check at 1209-13 N. Water Street. No violations were found and the manager was cooperative.
- 2. On 12/28/22 at 1:13am, Milwaukee Police spoke with the general manager who was cooperative and stated an unknown subject caused property damage in the basement.
- 3. On 02/23/23 at 11:39pm, Milwaukee Police conducted a license premise check at 1209-13 N. Water Street. The General manager and manager were cooperative and showed officers around the establishment and gave them everything needed to generate a tavern report. The only problem officers had was one of the security staff refused to give officers his personal information because he, "doesn't give his information out to police".

4. On 08/12/23 at 9:35p.m., Milwaukee Police were dispatched to a Fight at 1213 N. Water St. Investigation revealed a patron was disorderly inside the premise and asked to leave. Once outside the patron begins to swear at security and threw a punch at a security guard, causing security to briefly fight back. The patron then begins spitting at security and attempts another punch, when security throw the subject to the ground, causing the subject to bleed. The patron was issued citations for Disorderly Conduct and Battery. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

5. On 08/21/23 at 5:00p.m., Milwaukee Police were dispatched to a Trouble with Subject at 1213 N. Water. Investigation revealed a patron order food and upon payment, provided credit cards that were declined. The patron then refused to pay for the food. The patron was subsequently issued a citation for the violation. The business was cooperative with police.

6. On 06/22/24 at 12:51a m. Milwaukee Police were dispatched to a Battery at 1213 N. Water St

6. On 06/22/24 at 12:51a.m., Milwaukee Police were dispatched to a Battery at 1213 N. Water St. Investigation revealed three suspects jumped a patron, causing visible injury to the face and head. The business was cooperative and assisted police in identifying the suspects, who were cited for the violation.

- 7. On 06/28/24 at 1:12a.m., Milwaukee Police were monitoring the business, when they observed subjects being escorted out for fighting in the bar. The subjects continued to cause a disturbance outside, resulting in a ticket being issued to one subject.
- 8. On 08/09/24 at 145a.m, Milwaukee Police were dispatched to a Fight at 1213 N. Water St. Investigation revealed as a crowd was leaving the establishment, a fight broke out in the street, causing MPD to request additional squads due to the size of the crowd. Officers interviewed the manager and advised them when closing, they need to have security outside assisting with clearing the area. The manager stated moving forward they will have the security team help with patrons, add No Loitering Signs, and is willing to listen to any suggestions MPD has.
- 9. On 08/16/24 at 12:15a.m., Milwaukee Police were dispatched to a Trouble with Subject at 1213 N. Water St. investigation revealed a patron was involved in a verbal altercation with staff, as they were being escorted out of the business, for causing a disturbance and trying to take an alcoholic drink outside. The patron then threw the drink at security, at which time they were arrested and issued a citation. The business had 10 security officers on scene and all appeared to be doing their job.
- 10. On 12/01/24 at 4:44p.m., Milwaukee Police were dispatched to a Battery at 1213 N. Water St. Investigation revealed three juveniles refused to leave and one of the juveniles punched the manager in the stomach. All three were taken into custody and conveyed to the District. The business was cooperative.

On Saturday, June 22nd, 2024, at approximately 12:51 AM, I responded to 1213 N. Water St (Brother's Bar and Grill) for a Battery.

Upon arrival I observed Detective Andrew MOLINA and Detective Donald GAGLIONE with a group of individuals. Per Detective GAGLIONE:

At approximately 12:10am, Det. Donald Gaglione and Det. Andrew Molina were flagged down by Aiden M MCKEAG outside of 1213 N Water St (in the City and County of Milwaukee) who had visible apparent injury and small amounts of blood on his face and head. MCKEAG reported that he was physically assaulted by multiple suspects while inside of Brother's Bar and Grill without consent. Det. Gaglione was able to review surveillance footage that corroborated MCKEAG's complaint and identified that there were three suspects who assaulted MCKEAG. In conjunction with staff from Brother's Bar and Grill, the three subjects were identified based upon the review of video, physical descriptions, and clothing descriptions and were identified as Jose A VELAZQUEZ II (W/M 12/25/2000), Jacob A HILL (W/M 05/20/2002), and Bishara H HINNAWI (W/M 07/23/2000). HILL and HINNAWI were taken into custody as they exited from the establishment, and VELAZQUEZ was taken into custody on the nearby sidewalk. VELAZQUEZ, HILL, and HINNAWI were all cited on scene and released from the Police Administration Building. MCKEAG was treated by ambulance on scene for complaint of pain on his face and head.

I spoke to licensed premise manager, who was cooperative and was able to identify the individuals involved from video surveillance that captured the entire incident. The manager on duty was able to point out the three individuals involved and deliver two of the three to Officers and Detectives waiting outside the location.

I reviewed video surveillance footage. The footage showed the three subjects physically assaulting the victim. The primary suspect, VELAZQUEZ, was seen acting as if he was going to punch the victim at which time the victim flinched. This occurred several times before the second suspect, HILL, swung on the victim from a different angle striking the victim. VELAZQUEZ is then seen striking the victim several more times before the third suspect, HINNAWI, jumps on his back and puts his arm around the victim's throat. The video show the victim getting taken to the ground and the suspects continuing to strike the victim while on the ground. After being struck several times security from Brother's Bar and Grill get to the area of the fight.

While on scene, I observed the licenses posted and they were up to date. During the investigation for the battery, I did not observe any violations in the licensed premise.

On Friday, June 28th, 2024, I was assigned to Squad 1441 with PO Leon WOODS. At approximately 1:12 AM, PO WOODS and I were monitoring the bar, Brothers Bar & Grill, located at the address of 1213 N. Water St., which is located within the City and County of Milwaukee, WI. I observed two individuals being escorted out by the security at brothers for fighting inside the bar. I observed the two subjects were yelling at each other and trying to continue fighting each other. Once the security got the two subject outside on the sidewalk, they closed the doors and did not allow them back in. PO WOODS and I attempted to break up the fight. Both of the subjects were being loud and causing a disturbance. PO WOODS tried to speak with one subject while I spoke with the other subject, later identified as Maiya M. WHITE (w/f, 02-21-2002). I told WHITE to stop walking towards the other subject and to leave. WHITE ignored my orders and continued walking towards the other subject. WHITE then attempted to strike the other subject again and that is when I took WHITE into custody. WHITE was then issued a citation under citation #J981HBGSGF. The other subject then left the area. I spoke with WHITE who stated the other subject attacked her first inside of the bar and she said that it was self defense when she went to strike them. WHITE stated she did not know who the other subject was.

I observed several security guards on scene and they did what they were supposed to. The security got the individuals out of their establishment with no incident.

I will attempt to obtain video surveillance footage at a later date.

While on scene, I observed the licenses posted and they were up to date.

This report is written by P.O. Richard MICHALAK, assigned to DISTRICT One, Power shift, squad 1420.

On Friday, August 9th, 2024, at approximately 1:45 A.M., P.O. DELANEY and I responded to a fight at Brother's Pub & Grill located at 1213 N. Water St.

P.O. DELANEY, P.O. KENNER, and I were monitoring the crowd leaving from Brothers Pub & Grill. As the patrons were leaving the bar a crowd started to gather in front of the main entrance and along the sidewalk. I did not observe any of the security team from Brothers outside helping push the crowd away from the main door. As the crowd was leaving someone yelled fight. I turned around and observed a crowd of people fighting in the northbound lane of N. Water St. With only three officers there we were able to separate the people from fighting. As we were separating the fight P.O. DELANEY was struck in the head with a closed fist.

As that fight stopped another fight began in the middle of N. Water St and E. Juneau Ave. I had to call for additional squads to break up the fight and for crowd control. There was approximately ten to twenty people fighting. All the people that were involved in the fight came from Brothers Pub & Grill.

I conducted follow up on Friday, August 9th, 2024, at approximately 7:45 P.M. I spoke with the manager Gavin B. NEDLAND (w/m, 5-13-97). I stated to NEDLAND when the patrons are leaving at the end of the night, he needs to have two to three security guards outside the main entrance asking the patrons to leave the area. NEDLAND was unaware that BROTHERS is responsible for the crowd outside at that his security team needs to help with getting the patrons out of the area.

NEDLAND stated that moving forward he will have some of his security team outside to help get the patrons out of the area. NEDLAND stated that he will get "NO LOITERING" signs posted outside. NEDLAND stated that he will work with Milwaukee Police Department and willing to listen to any suggestions we might have.

NEDLAND and I did view video from the incident. Unfortunately, at nighttime the video is very grainy and impossible to tell who was all involved in the fight. I stated to NEDLAND that I will be filing a tavern report and the reasons for the report.

Upon my arrival I observed an individual later identified as Imani E FIELDS (F/B 7-29-03) that was involved in verbal altercation with one of bar security staff outside the front entrance of the business. FIELDS was trying to leave the business with an alcoholic drink in her hand. The bar security later identified as Cole BRENNAN (M/W 5-12-01) attempted to grab the drink and a struggle between FIELDS and BRENNAN started. FIELDS took the drink and tossed the liquid towards BRENNAN causing him to get his work uniform wet from the alcoholic drink. BRENNAN was doing his Job and making sure no one eft the business with an open container since it is prohibited outside the business.

I spoke to licensed premise manager, later identified as Gavin B NEDLAND (M/W 5-13-97) who stated that FIELDS and the group she was with have been causing problems there for months NEDLAND stated that FIELDS and her group are banned from the business and are not welcomed back.

The business had up to 10 security officers on scene. They were all unarmed. The security officers were doing their job and kicking out anybody that was causing a disturbance at the business and made sure no one left with any open alcoholic drinks.

While on scene, I observed the licenses posted and they were up to date.

On Sunday, December 1, 2024, I, Officer Kevin Becker and Officer Lorenzo Hernandez were assigned to Squad 1240 in full duty uniform, a marked Milwaukee Police Squad, and affixed with AXON worn body camera.

At approximately 4:44 PM we were dispatched to a battery call for police at the address of 1213 N. Water St. which is located in the City and County of Milwaukee. This particular location is the Brothers Bar and Grill establishment which is a bar and restaurant that was open during normal business hours.

The caller, victim, and manager of the establishment; Michael S. LAWLER (M/W 10/25/1992) stated that three juvenile subjects came into the establishment and refused to leave after striking him three times.

Squad 1240 arrived on scene and observed the three subjects leaving the area which were later confirmed to be the same three subjects from the incident. The subjects were identified as Shauncey L. MCGOWAN (M/B 08/23/2010), Henry E. TYLER (M/B 02/23/2012), and Donshea L. TROTTER (M/B 04/18/2012). LAWLER explained that all three were asked to leave the establishment after they were rough housing within the vestibule of the establishment. All three refused to leave and MCGOWAN then struck LAWLER three times in the body/stomach area causing minor pain. Once MCGOWAN was located, MCGOWAN refused to obey Squad 1240's lawful commands to stop and surrender and was eventually decentralized as a result.

Both I and Officer Hernandez are acting in official capacity and with lawful authority. All three subjects were placed into custody and conveyed to District One regarding.
