This report is written by P.O. Damian RAINEY, assigned to District Four, Early Power Shift.

On Thursday, September 9, 2021 at approximately 3:22 Pm squad 4235w (myself) responded to a shooting at the address of 5430 N Lovers Lane Rd (Domino's Pizza), located in the City and County of Milwaukee.

Upon arrival squad were allowed to enter the business by the crew members working and I located Dominic A. CARTER (b/m 8/8/86) who appeared to be shot in the heard and unconscious.

I was later informed by a black female who identified her self as CARTER's girlfriend but did not want to provide her information because she was upset, that CARTER was inside of the business picking up her food, and she was notified by someone that her boyfriend was shot in the head. She stated she rushed to the business and observed CARTER bleeding on the floor.

Estelle C. COCKCROFT (b/f 10/24/63) is a witness and stated she was driving through the parking lot and heard 2 gun shots. She stated she stopped and observed a black male wearing all black clothing running out of the business southbound through the parking lot. She stated she then noticed that the victim was laid out on the business floor.

Med 16, (Lt SHEPARDSON, blue shift) arrived at 3:29 PM and pronounced the victim.

Corey MOYE (b/m 12/31/75), who is the assistant manager, was cooperating with officers during the investigation and allowed officers to view video surveillance of the incident as well. MOYE and other employees stayed on scene and provided helpful statement to the detectives and officers on this case.

The hearing before the Licenses Committee will take place virtually on 3/08/2022 at 10:55 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.
