I don't understand what the claim adjustor was saying?


Just because they caught the suspect and the police officer damaged my fence.

I fully disagree.


The owner should not have to pay for damages that someone else caused. The someone else is the Milwaukee police department.





We are in receipt of your claim regarding damage sustained to your fence at 6539 N. 84th Street by the fleeing suspect and the Milwaukee Police Department on August 1, 2025.

Our investigation reveals that your damage was caused while police attempted to subdue a suspect after pursuit of a vehicle that refused to stop, and continued to elude/flee police on foot into your backyard and jumped over your fence. The suspect was apprehended and taken into custody. Since the police were acting within the sphere of their responsibility, the City of Milwaukee would not be liable. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.
