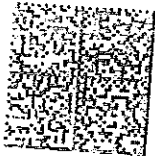

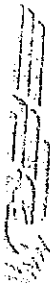

Dear Attorney Andriusis:

We have received your settlement demand for the amount of \$56,514.28 in relation to the injuries sustained by Flor M. Vazquez in relation to a motor vehicle occurring on July 20, 2021 at or near 4502 West Wisconsin Avenue.

Our investigation determined the City vehicle was traveling westbound on Wisconsin Avenue. Your client, Flor M. Vazquez was exiting the highway, and conducted a left turn when it struck our vehicle. The police report indicates your client failed to yield the right of way to traffic.

It is our position that the City of Milwaukee has no negligence in this matter, and cannot accept liability for your client's injuries. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.
