Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. No petitions can be accepted by the committee, unless the people who signed the petition attend the virtual hearing and are willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. This would be OK at 8 p.m., but it is not at 2 a.m. and it is really not at 3 a.m. or 3:10 a.m., well after closing time, when the loud music and talking still were going on. At 4 a.m., there were still four or so people gathered around a car in the parking lot, talking. They set off the car alarm once, then again.

I wrote before about the early-morning noise coming from Caliente, but obviously my request that Caliente staff have more consideration for restaurant neighbors went unheeded. I am repeating that request now.

The Caliente restaurant, 5108 W. Bluemound, habitually plays extremely loud music on Friday and Saturday nights. I have filed numerous complaints with the police (non-emergency number). I was hopeful that today being Christmas, I may get a reprieve from the noise.

This isn't the case, and the music started up a while ago. I went out with my dog about an hour and made a recording. You can hear everything, but the recording doesn't compare to the actual sound in person—it's so incredibly disruptive.

I invite you to join me on any given Friday or Saturday so you can hear it yourself and understand exactly what I and my neighbors deal with every weekend.

I am now trying to sleep and the sound from Caliente is making it nearly impossible. I tried calling the restaurant but there is no answer. I would contact the proprietor but I have heard from several sources that they are not receptive to conversation.

Can you please help? I'd be happy to discuss this situation with you if you'd like.

I appreciate your time, and Merry Christmas.

An "anonymous" caller stated there was 4-5 underage subjects inside of the bar.

Upon arrival we were approached by the owner Jesse FONSECA (W/M 7/6/83). FONSECA stated that they check everyone's Identification Cards. We advised FONSECA that the caller said one of the underage subjects is a Hispanic female wearing red. FONSECA then walked around the bar attempting to locate the female. FONSECA and officers could not locate a female matching the description.

PO. MARX called the caller.

PO. MARX could hear the music from the bar coming from the caller's phone. P.O. MARX heard the music from the caller's phone was the same that the bar was playing. We observed a male sitting at the bar on his phone. That male got up and went into the bathroom while on the phone with PO. MARX. PO. MARX could hear the music getting quieter when the male was inside the bathroom.

When the male came out of the bathroom we asked if he was the caller. The male stated he was not the caller. The male was the only one in the bathroom and was holding his phone.

FONESCA asked the male and the rest of his group to leave the bar for the night.

The owner was cooperative with the investigation.

The hearing before the Licenses Committee will take place virtually on 3/08/2022 at 01:25 PM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
