Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. The officers told the subject to leave and he left without incident.

Investigation revealed that a subject attempted to steal items from the filling station but the employee locked the exit door so the suspect could not leave. The employee then exited the safety of his work area, with a stick, and approached the suspect. Police arrived and no action was taken.

This report is written by *Police Officer Drew MOODY-PETZ*, assigned to *DISTRICT 5 AND Late Power SHIFT*, *SQUAD 5446*.

On Sunday May 5th, 2024, 7:23 PM, I was dispatched to 122 W Capitol Dr, for a Battery Complaint.

#### **INITIAL REPORT AS FOLLOWS:**

Upon arrival, P.O. WELCH observed a male subject standing in front of the entrance of the BP gas station located at 122 W CAPITOL DR. Subject was our caller/victim identified as Dilpreet SINGH (W/M 12/25/1998). SINGH appeared to be in distress and upset of the incident that occurred, SINGH did not show any indication that he was hurt or needed medical attention.

P.O. WELCH spoke with SINGH who stated on Sunday, 05/05/2024, at approximately 07:08PM at the location of 122 W CAPITOL DR. he observed four male black subjects walking westbound on Capital Dr. SINGH stated subject 1 was a B/M 15-21 years of age, medium build wearing a Black hooded sweater, Black pants, White/Black Nike Shoes. SINGH stated subject 2 was a B/M 15-21 years of age, medium build wearing a Red Mask, Gray Camo Jacket, Gray Pants. SINGH stated subject 3 was a B/M 15-21 years of age, medium build wearing a Red, White, and Blue Hooded Sweater Gray Jeans and Black Shoes. SINGH stated subject 4 was a B/M 15-21 years of age, medium build wearing a Red Hooded Sweater Black Pants Blue Shoes.

SINGH stated that he has been having problems with the four subjects in the past and he wanted to confront them before the subjects entered the business. SINGH stated while he was confronting the subjects he yelled that he knows they have been shoplifting at the store in the past and he told them to go away. SINGH then stated after he walked towards the store, and an empty cup was thrown by one of subjects towards his location with the intent to hit him. SINGH stated that he told the subjects to leave again. SINGH stated that subject 1 then stated to him he was going to come back and mess it up.

SINGH stated that the 4 subjects began to throw stones at him intentionally and without his consent causing SINGH to pain to his back and neck. SINGH then stated that the 4 subjects began to make threats about coming back to the store and damaging his property.

SINGH stated that the 4 subjects then left the location and went westbound on Capital Dr.

SINGH stated that he did not know the subjects and he does not know why they caused the incident.

P.O. MOODY-PETZ sent SINGH a link for evidence.com to upload evidence of the incident.

SINGH refused medical treatment and wanted officers to document his injuries on our body AXON camera.

SINGH was issued a PV-17 and a Community Contact Card.

Officers will patrol the area and P.O. WELCH advised SINGH to get security to deter subjects from coming back to location.

The business was *cooperative* with the investigation and uploaded the video surveillance to "evidence.com". The business had 0 security officers on scene.

I reviewed video surveillance footage. The footage showed the four juveniles throwing stones at SINGH, as SINGH was walking to return inside the business.

While on scene, I observed the licenses posted and they were up to date.

This report is written by PO Delia CARRILLO assigned to District, Late Power.

On Tuesday, July 30th, 2024, at approximately 7:12 P.M. Squad 5426 (PO Robert BREMER and I) were dispatched to a Subject with Weapon complaint at the address of 122 W Capitol Dr., located in the City and County of Milwaukee.

Upon arrival I observed the front door of the gas station had been damaged, the two front doors had been shattered.

I spoke to the caller, who was identified as Nirvair SINGH (I/M 12/10/1982), who was on the phone with the manager. Officers waited for the manager to arrive.

I spoke to the manager of the location who was identified as Dilpreet SINGH (I/M 12/25/1998). D. SINGH stated two juveniles were the ones who busted the front door, by throwing rocks at it. D. SINGH stated the juveniles are repeat offenders and constantly shoplifting from the store.

The business was cooperative and did not have armed security on scene.

I reviewed video surveillance footage and photos submitted by D. SINGH to Evidence.com. The photos are of two juveniles who are repeat offenders at the store. The first subject is juvenile black male half wearing a black sweatshirt (with the hood up and not wearing the left sleeve), navy blue Adidas pants and light blue crocs. The second subject is a juvenile black male with dreadlocks wearing a red sweatshirt, black pants and black Jordans with the word AIR across the sides. The video footage shows the male in the red sweatshirt carrying a medium sized rock and slamming it against the door, the juvenile walks away and picks up the rock again and slams it into the door again. The juvenile is then seen walking eastbound until he is no longer in the view of the cameras.

While on scene, I observed the licenses posted and they were up to date.



Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
