Dear Service Director:

The Wisconsin Department of Health Services is pleased to send you your state EMS Funding Assistance Program check based on your ambulance service's application for state fiscal year (SFY) 2019.

According to Wis. Stat. §§ 256.12(4) and (5), we are providing funding based on two separate calculations. The first amount fulfills § 256.12(4) and includes the base amount of \$3,588 plus .03 cents per capita. Your ambulance service may use these improvement funds for the purchase of ambulance vehicles, vehicle equipment, emergency medical service supplies, and equipment not in your annual budget.

The second amount fulfills § 256.12(5) and is distributed under the current formula of 1/3 EMTs on the roster, 1/3 per capita, and 1/3 call volume. This allotment is to be used only for EMT-Basic or EMR expenses related to initial and refresher training, as well as examination costs.

Aids and training per § 256.12 (4)	Amount: \$ 21553.44
EMT-Basic EMR training costs per § 256.12 (5)	Amount: \$ 28891.99

Please remember that EMS-FAP dollars may not be used to reduce existing local EMS funding or to supplant allocations in your budget. The next expenditure report will be split into two sections to better track how each of the allocations are being spent.

As a reminder, all future EMS-FAP application processes will be administered electronically through E-Licensing. The notice will be emailed to the designated service director at the address in their E-Licensing account.

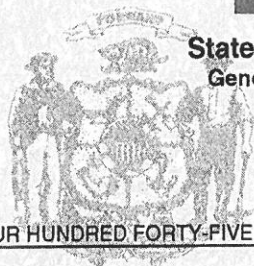
