You are hereby notified that the Milwaukee Common Council will hold a hearing on April 17, 2007, commencing at 9:00 a.m., or as soon thereafter as this matter may be heard, in the Common Council Chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin to consider the report of the Public Safety Committee to revoke your public passenger vehicle-luxury limousine permit for the entity known as Airport Service.

Attached you will find a copy of the Report of the Public Safety Committee which includes its Findings of Fact, Conclusions of Law and Recommendation, recommending revocation of the license. The recommendation is the result of a public hearing before the Committee held on March 29, 2007 and a verified complaint filed by Richard Pfaff, Assistant Manager of the License Division of the Office of the City Clerk.

You may file a written objection to the report of the Public Safety Committee. If you file a written objection to the report you may also appear before the Milwaukee Common Council to make oral arguments supporting your written objections and present oral arguments supporting that objection to the Common Council. Any written objections to the Committee's Report must be filed with the City Clerk at least three (3) working days prior to the above-mentioned date set for hearing by the Common Council. You or a legal representative may then also appear at the Common Council meeting and request an opportunity to address the Common Council for approximately five (5) minutes to present an oral argument on your own behalf.

Re: Report of the Public Safety Committee of the Public Passenger Vehicle-Luxury Limousine Permit held by Pamela S. Olecik, Agent for Airport Service located at 3460 South Cari Adam Court, New Berlin, Wisconsin ("Airport Service").

FINDINGS OF FACT

1. Pamela S. Olecik, Agent for Airport Service (hereinafter the "Licensee") is the holder of a Public Passenger Vehicle-Luxury Limousine Permit No. 209 in the City and County of Milwaukee, Wisconsin ("Airport Service"). Said license expires on April 30, 2007. The licensee has not filed an application for renewal of this license, and such an application would now be untimely.
2. A verified complaint seeking the revocation of said license was filed with the Office of the City Clerk on March 9, 2007 by Richard Pfaff, Assistant Manager, License Division - Office of the City Clerk. The complaint alleged that the Licensee has failed to maintain insurance for limousine permit number 209 which expired on April 7, 2006 for a 1995 Lincoln Town Car, bearing the identification number of 1LNLM82WXS719290.
3. On March 15, 2007 the complaint was served upon the Licensee with a summons and the verified complaint of Richard Pfaff seeking revocation of this license and also containing a copy of Chapter 100-53 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes.
4. Said summons commanded the appearance of Pamela S. Olecik on March 29, 2007 at 9:00 a.m. in Room 301-B of City Hall. On said date, time and place Pamela S. Olecik did not appear, nor was she represented by counsel.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:

- A. The licensee, Pamela S. Olecik is an adult resident of Waukesha County Wisconsin and is the holder of a Public Passenger Vehicle Permit No. 209, issued by the City of Milwaukee for a 1995 Lincoln Town Car Signature Series/Spinnaker Edition, Vehicle ID Number 1LNLM82WXS7190290.
- B. On June 16, 2006 the Common Council of the City of Milwaukee granted and the License Division of the City Clerk of the City of Milwaukee issued a renewal of the Public Passenger Vehicle Permit No. 209 for said vehicle.
- C. A condition of the maintenance of said Public Passenger Vehicle Permit No. 209 is the continuation of surety bond, insurance policy, or deposit in escrow a certificate of self insurance pursuant to Chapter 100-53-1, -a, -b, and -c of the Milwaukee Code of Ordinances.
- D. The licensee presented the License Division of the Office of the City Clerk of the City of Milwaukee a certificate of insurance (No. 73APN342620) dated April 7, 2005 to April 7, 2006 a copy of which is annexed to the verified complaint filed by Richard Pfaff.
- E. On January 30, 2006 and again on April 7, 2006 notice was sent to the licensee that the insurance policy for the vehicle has expired, and the licensee has failed to provide evidence of insurance, surety bonds, cash, or direct obligations to cover the requirements of Chapter 100-53-1-a-b-c of the Milwaukee Code of Ordinances.
- F. The licensee failed to renew the insurance policy or otherwise comply with the provisions of Chapter 100-53-1-a-b-c of the Milwaukee Code of Ordinances.

CONCLUSIONS OF LAW


1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to § 349.24 of the Wisconsin Statutes and Chapter 100 of the Milwaukee Code of Ordinances.
2. Based upon the above facts found, the Committee concludes that the request for revocation of the Public Passenger Vehicle-Luxury Limousine Permit No. 209 held by Pamela S. Olecik, Agent for Airport Service, for the premises located at 3460 South Cari Adam Court, New Berlin, Wisconsin should be approved based upon nonappearance and the verified complaint of Richard Pfaff, which has not been contested. The Public Safety Committee finds the verified complaint of Richard Pfaff to be true.

3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Safety Committee that the full Common Council of the City of Milwaukee should exercise its judgment to revoke the Public Passenger Vehicle-Luxury Limousine Permit of Pamela S. Olecik based upon the evidence presented by the complainant, and the refusal of the licensee to abide by the insurance, bonding, and surety requirements of the Milwaukee Code of Ordinances.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Public Safety Committee, by a vote of five (5) ayes and zero (0) noes recommends that the full Common Council of the City of Milwaukee exercise its discretion to revoke the Public Passenger Vehicle Permit held by Pamela S. Olecik as agent for Airport Service located at 3460 South Cari Adam Court, New Berlin, Wisconsin ("Airport Service") because of failure to comply with Chapter 100-53-1-a-b or -c of the insurance, bonding, and surety requirements of the Milwaukee Code or Ordinances.
