WHEREAS, *Thelma Sias was named vice president – local affairs for WEC Energy Group in June 2015 and was charged with the responsibility of building and enhancing long-term relationships with community leaders and local governments, directing activities to monitor community concerns and to negotiate with local governments, and under her leadership, Local Affairs very successfully addressed the service needs of We Energies municipal customers and school districts; and*
