There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

The Vivarium's license for live music is up for renewal, scheduled for a hearing before the Common Council's Licenses Committee on May 20th. During the renewal process, there is an opportunity to file objections to the business for complaints such as these. Would you like me to file an objection for you? If you do file an objection, I highly recommend you attend the May 20th hearing and speak about your experience, if possible.

Additionally, Alderman Brower plans to schedule a community meeting regarding the Vivarium before this May 20th meeting. This would give you and others in the area an opportunity to speak about issues you've had with the Alderman, the business, and other community members. The date has not yet been scheduled, but I can notify you when we have the details finalized, if you would like me to.

Subject: Vivarium Vibrations and Thumping Noise

Dear Mr. Cooney:

This is in response to your solicitation of comments about noise emanating from and further, I believe the request for alcohol licensing, at the Vivarium on Farwell Ave.

I live directly across from the entrance to the Vivarium.

I am hearing impaired, but I do not always wear my hearing aids in my condo which overlooks Farwell Ave. and is on the

Nevertheless, on Friday February 21 at approximately 9:00 pm I felt vibrations and thumping bass while sitting in my living room. I was wearing my hearing aids at the time but even after I removed them, I felt these unpleasant disturbances. Even after I removed my hearing aids I could hear and feel the disturbance for 30-60 minutes. It was incessant and intense enough to interfere with the television programs I was trying to watch—and even after I turned up the volume of the tv to mask the sound from the Vivarium.

It disturbed the peace that I have a right to expect in my home. This residential building has seniority on this street

It is now clear to me that the thumping commotion and steady vibrations I have heard in my living room on previous occasions (perhaps a dozen times over the past few months) did not, as I had presumed, come from residents in my building, but from the commotion that emanates from the

Vivarium in disregard for the rights of residents. The "music" last Friday was so loud there was no doubt where it was emanating from.

I ask the city to prohibit Vivarium noise disturbances and everything that facilitates them: that includes alcohol sales and consumption on the premises of the Vivarium. Once and for all.

Examples of occurrences -

Monday, October 7th – band could be heard during sound check – pounding drums and deep bass- at 6:00pm, Pabst Theather Group number was called and complaint left. Show began at approximately 9:00 pm and could be heard in it's entirety until approximately 11PM. Again, pounding drums and deep bass that interrupts TV viewing and going to sleep. The band's bus was also parked on Farwell Ave and was running a good portion of the evening.

Thursday, Oct 10th – band began around 8:30 or 9:00 PM. Fairly quiet at first, low bass hum; volume escalated at end of show, perhaps last 20 minutes was pretty loud – sound could be heard over comfortable TV volume. Show ended 10:55pm.

Tuesday, Oct 22^{nd} – Quarters of Change show – 90 minutes (approximately 9-10:30 pm) of booming bass and pounding drums, competing with the sound from our television.

Friday, Nov 15 — band tour bus/truck out in the street running, engine running for duration of show, until band loaded out.

Sunday, Nov 17 – Band and crew loading equipment into truck at midnight. Very loud.

Sunday, Dec 1^{st} – Heard sound check between 5 and 6:30, Bands played 8:30 – 10:45; thumping bass and drums for the duration.

Friday, Dec 6th – contact snare drum and thumping bass noise, starting at 8:50 pm, going until

This is a formal complaint against The Pabst Theater Group (PTG) and its music establishment The Vivarium. The club has been open for little over a year now, and neighbors have been in talks with PTG and our Alderman to mitigate noise. While somewhat successful, further complaints/discussions about noise levels have sadly made no difference. I fear the PTG and Vivarium no longer have any interest/intention of changing their business model to address concerns of their neighbors.


We're not talking about dangerous levels of sound, and it's not even what the police would measure and intervene. It is, however, a nuisance to everyday life at home. Image a vehicle

parked at the curb in front of your house, with a booming stereo system, from roughly $8:30\,\mathrm{pm}$ $-11:00\,\mathrm{pm}$.

I know of no other PTG establishment located in such a residential neighborhood, and I'm willing to bet no other PTG venue has a schedule as packed. There are an abundance of condominiums and apartments surrounding the Vivarium in all directions. I don't want to hear thumping bass and pounding drums every night while trying to enjoy an evening at home.

The Vivarium has booked a show for just about every night of the calendar during October, November& December 2024, so neighbors have much to be concerned about. The Pabst Theater Group and Vivarium need to get serious about becoming responsible neighbors and either turn down the volume, or make big improvements for soundproofing to the club. During a community meeting shortly before they opened, the PTG espoused to improve the neighborhood with their presences believe they have made living here were.

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place on 5/20/2025 at 2:00 PM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel — Channel 25 on Spectrum Cable — or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
