I have installed a new 6 foot wooden fence to replace the 25 year old wooden fence that was broken down due to people breaking into my yard. It extends from my garage to the neighbors property line at 2662 North Grant Blvd.

I need to install a new 6 foot privacy wooden fence between my house and 2662 North Grant Blvd. The fence will be from my property line and measure 4feet high with 2 feet lattice at the top; a treillage fence. The fence will extend from the back fence to the front of the house. Approximately 75 to 100 feet in length. The whole fence will be stained.

I am also proposing to install a 12 x 12 slab of concrete for my dog kennel to be placed on. This will be installed at the back end of my yard adjacent from 2662 North Grant Blvd garage on my property line and adjacent to the privacy fence to be installed between our homes.

I am also proposing to install a 15 x 15 slab of concrete for my patio that will be adjacent between the fence between our homes on my property side. This slab will be about 50 feet from the dog kennel.

My husband and I are 66 years of age and it is somewhat challenging p keeping a full yard of grass, front and back.
