Dear Mr. Jordan:

Our office has received your claim relating to the towing and ultimate recycling of your 1979

Buick Regal. You indicate that your vehicle was towed and destroyed, but you were incarcerated and unable to retrieve it. You are asking for \$1,800.00, which you claim is the value of the vehicle.

Our investigation reveals that your car was ticketed and towed for being illegally parked and snowbound on January 10, 2001. On January 11, 2001 a letter was sent to you at 3355 North 13th Street, advising you that the car had been towed, that you had 22 days from the day it was towed to pick it up, and indicating where you could pick it up. The car was not retrieved and a second letter was sent to you on January 17, 2001, indicating that if the car was not retrieved by February 1, 2001, it would be recycled. You did not retrieve your vehicle on February 1, 2001 and it was recycled on February 2, 2001. Notice was properly given and therefore we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202.
