

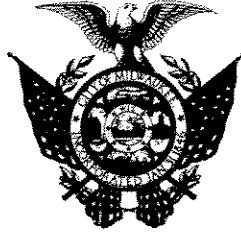

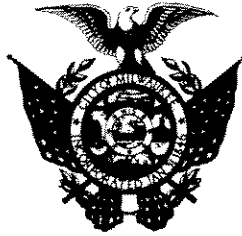

Re: Report of the Renewal application of Shamshad Hussain for a Class "A" Malt license for the premises located at 935 West Greenfield Avenue, in the City and County of Milwaukee, Wisconsin ("A 1 Pantry").

**FINDINGS OF FACT**

1. Shamshad Hussain (hereinafter the "Licensee") is the holder of a Class "A" Malt license for the premises located at 935 West Greenfield Avenue, in the City and County of Milwaukee, Wisconsin ("A 1 Pantry"). Said license expired at midnight, February 26, 2005.
2. An untimely application to renew said license was filed with the Office of the City Clerk on February 28, 2005.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. There was a Milwaukee Police Department report dated March 1, 2005, which could form the basis for nonrenewal or suspension of the license.
4. On March 11, 2005 the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of police objections that could form the basis for suspension or nonrenewal of the license of the Licensee. A copy of the police report was included. The matter was scheduled for a hearing on the police objections on March 22, 2005 at 10:30 a.m. in Room 301B of the third floor of City Hall. At said date, time and place, the licensee appeared and admitted receipt of the notice and police report. The applicant was not represented by counsel.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:

- A. On April 13, 2001 at 9:42 p.m., an underage Milwaukee Police Department police aide entered the licensed premises located 935 West Greenfield Avenue in the City and County of Milwaukee, Wisconsin ("A 1 Pantry") under the direction of Milwaukee police officers. The aide was able to purchase a six pack of Tecate beer from a clerk, one Erum Hussain. Shamshad Hussain was cited for sale to an underage person, licensee responsibility. That case was dismissed on July 23, 2001 without prejudice. The clerk, Erum Hussain, was found guilty of sale to an underage person on July 23, 2001 and fined \$100.00.
  
- B. On February 26, 2004 at 6:38 p.m. an underage Milwaukee Police Department police aide entered the licensed premises located 935 West Greenfield Avenue in the City and County of Milwaukee, Wisconsin ("A 1 Pantry") under the direction of Milwaukee police officers. The aide was able to purchase a twelve ounce of Olde English malt liquor from the clerk, Dilshad Hussain, son of the licensee, Shamshad Hussain. The licensee was cited for sale to an underage person, licensee responsibility. On April 20, 2004 the licensee was fined \$100.00. The clerk, Dilshad Hussain was also cited for sale to an underage person on April 20, 2004 and found guilty and fined \$100.00.
  
- C. On June 2, 2004 at 8:15 p.m. an underage Milwaukee Police Department police aide entered the licensed premises located 935 West Greenfield Avenue in the City and County of Milwaukee, Wisconsin ("A 1 Pantry") under the direction of Milwaukee police officers. The aide was able to purchase a six pack of twelve ounce bottles of Miller Genuine Draft beer from the clerk, Shahab Hussain. Shahab Hussain was cited for sale to an underage person and on July 20, 2004 was found guilty and fined \$100.00.

#### CONCLUSIONS OF LAW

- 1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
  
- 2. Based upon the above facts found, the Committee concludes that the licensee, Shamshad Hussain for a Class "A" Malt license for the licensed premises at 935 West Greenfield Avenue in the City and County of Milwaukee, Wisconsin ("A 1 Pantry") has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes to allow renewal of his Class "A" Malt license without undergoing a ten (10) day suspension. The Committee finds the police report to be true.


3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Utilities and Licenses Committee that the full Common Council of the City of Milwaukee should exercise its discretion to renew the Class "A" Malt license of Shamshad Hussain for the premises at 935 West Greenfield Avenue in the City and County of Milwaukee, Wisconsin ("A 1 Pantry") with a ten (10) day suspension.

#### RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes recommends that the Class "A" Malt license held by Shamshad Hussain for the premises at 935 West Greenfield Avenue in the City and County of Milwaukee, Wisconsin ("A 1 Pantry") be renewed with a ten (10) day suspension.

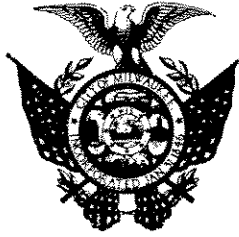

FINDINGS OF FACT

1. Elliott D. Edwards (hereinafter the "Licensee") is the holder of a Class "D" Bartender License in the City and County of Milwaukee, Wisconsin. Said license expired at midnight, December 31, 2004.
2. An application to renew said license was untimely filed with the Office of the City Clerk on March 2, 2005.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On March 3, 2005, the Milwaukee Police Department responded with a police report that could form a basis for non-renewal or suspension of said license.
4. On March 11, 2005, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report on March 22, 2005, commencing at 1:30 p.m. in Room 301B of City Hall. At said date, time and place, the licensee did appear but he not represented by counsel.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:

- A. On March 11, 1991, the license applicant was charged with carrying a concealed weapon. On June 25, 1992 he was found guilty and sentenced to 90 days in jail.
- B. On February 11, 1992, the license applicant was charged with possession of a controlled substance and carrying a concealed weapon. The charge of possession of a controlled substance was dismissed. The applicant was found guilty of carrying a concealed weapon on June 25, 1992 and sentenced to 90 days in jail.
- C. On October 8, 1993, the license applicant was charged with carrying a concealed weapon. On December 8, 1992 he was found guilty and fined.
- D. On October 27, 1997, the license applicant was issued a citation for resisting/obstructing an officer. On December 19, 1997 he was found guilty and fined \$111.10.
- E. On November 17, 1997 at 1:53 a.m., the license applicant was stopped and arrested for operating an auto while intoxicated (first offense) at 4700 West Burleigh Street in the City and County of Milwaukee, Wisconsin. On November 18, 1997 he was found guilty and fined \$672.50 and incurred a 6-month revocation of his driver's license.
- F. On December 18, 1998, the license applicant was arrested for carrying a concealed weapon. On June 11, 1999 he was found guilty and sentenced to 30 days in the House of Correction.
- G. On July 17, 2002, the license applicant was stopped and arrested for operating an auto while intoxicated (second offense). On March 7, 2003 he was found guilty and fined \$874.00 and ordered to 30 days in jail and incurred a one-year revocation of his driver's license.
- H. On June 11, 2003 at 1:30 a.m., the license applicant was cited for assault and battery at 3600 West Marion Street. On October 17, 2003 he was found guilty and fined \$336.00.
- I. On July 28, 2003 the license applicant was arrested for battery, domestic-violence related. On July 9, 2004 he was found guilty to an amended charge of domestic-violence related disorderly conduct and fined \$200.00.
- J. March 17, 2004 at 12:42 a.m., the license applicant was cited for disorderly conduct in the area of 4747 North Hopkins Street. 4747 North Hopkins Street is the location of a tavern known as "Ealy's" and is the tavern wherein the licensee works. The licensee claims that he was not on duty at the time of this incident. On May 7, 2004 he was found guilty of disorderly conduct in the Milwaukee Municipal Court and fined \$167.00.

- K. On March 17, 2004 at 1:40 a.m., the license applicant was cited for disorderly conduct at 4747 North Hopkins Street, Milwaukee, Wisconsin ("Ealy's"). On May 7, 2004 he was found guilty of disorderly conduct in the Milwaukee Municipal Court and fined \$167.00. Again, the license applicant claimed he was not on duty at the time of this incident.
- L. On March 17, 2004 at 1:52 a.m., the license applicant was cited for resisting/obstructing an officer at 4747 North Hopkins Street, Milwaukee, Wisconsin ("Ealy's"). On May 7, 2004 he was found guilty of obstructing/resisting an officer in the Milwaukee Municipal Court and fined \$167.00. Again, the license applicant claimed he was not on duty at the time of this incident.

#### CONCLUSIONS OF LAW


1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based upon the above facts found, the Committee recommends that the Class "D" bartender licensee of Elliott D. Edwards be renewed with a ninety (90) day suspension based upon a police report.

#### RECOMMENDATION


#### CONCLUSIONS OF LAW

2. Based upon the above facts found, the Committee recommends that the Class "D" bartender licensee of Alvin J. Robinson be denied based upon nonappearance.

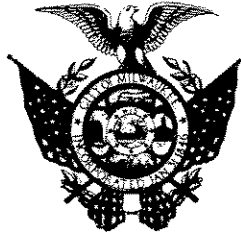


