PLEASE NOTE: A zoning change is being considered for the property within the boundary shown on the map on the reverse side of this notice. If your property is not within the zoning boundary, then you are receiving this notice because your property address is within 200 feet.

DEAR PERSON OF INTEREST:

The Common Council has referred File No. 220627 to the City Plan Commission (CPC) for recommendation. This file relates to the First Amendment to the Detailed Planned Development (DPD) known as River House to allow changes to the previously approved Phase 2 multi-family residential development located at 1801-1881 North Water Street, on the west side of North Water Street, north of East Pearson Street extended, in the 3rd Aldermanic District.

A 2-Phase DPD was approved in 2015 for 1775-1881 N. Water Street to allow up to 450 residential units in 4 buildings. The first phase, which includes 243 units in 2 buildings, is complete. The applicant and owner, Water Street Realty Partners LLC, is ready to move forward with Phase 2 of the development and is requesting an amendment to DPD to allow an additional 15 units for a total of 222 units in the final 2 buildings. The building designs will also be approved as part of the file. A new segment of the Riverwalk and associated pedestrian connections were approved in 2015. The previously approved Riverwalk design within Phase 2 remains substantially unchanged and will be constructed along with the final 2 residential buildings. **Please refer to the reverse side of this notice for map details.**


