

Re: Report of the renewal application of Ivory Elim for a Class "B" Tavern and Public Entertainment Premises license for the premises located at 3501 North 6th Street in the City and County of Milwaukee, Wisconsin ("Elim's Lounge").

FINDINGS OF FACT

1. Ivory Elim (hereinafter the "Licensee") is the holder of Class "B" Tavern and Public Entertainment Premises license for the premises located at 3501 North 6th Street in the City and County of Milwaukee, Wisconsin ("Elim's Lounge"). Said licenses expire at midnight, November 1, 2014.
2. An application to renew said licenses was timely filed with the office of the City Clerk on August 21, 2014.
3. Pursuant to Chapters 90 and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department responded with a report that could form the basis of non-renewal or suspension of these licenses on August 21, 2014.
4. On October 8, 2014 the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on October 20, 2014, commencing at 9:15 a.m. in Room 301B of City Hall. At said date, time and place, the Licensee appeared and was represented by Attorney Roy B. Evans.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On April 6, 2013 at 1:05 a.m. Milwaukee officers were dispatched to 3501 North 6th Street for a trouble with subject complaint. The investigation revealed that a fight had broken out inside the bar and by the time the police arrived the fight was over and a number of patrons had left the bar. It appeared to police that the bar might have been over capacity. Officers spoke with Markevan Love who was bartending and Love was unable to provide police his bartender's license. An officer spoke with the licensee Ivory Elim, who agreed to close the bar early for the night.



- B. On January 1, 2014 the licensee was issued a citation at 3501 North 6th Street in the City of Milwaukee for licensed establishment-exceeding occupy limit and was found guilty on April 7, 2014 and fined \$1300.00.
- C. On January 12, 2014 Milwaukee police met with the licensee at Milwaukee Police District 5 to discuss over capacity issues at Elim's Lounge (3501 North 6th Street). During this meeting the licensee indicated he understood the issues discussed with police and that he wants to cooperate with the police in the future.
- C. On April 13, 2014 Milwaukee police went to Elim's Lounge (3501 North 6th Street) to check on an anonymous complaint that there were underage patrons at the business drinking. Officers discovered one patron at the bar that had not yet attained the legal drinking age of 21. This patron was cited. No additional citations or reports were written.
- E. On August 8, 2014, Milwaukee police responded to a shooting complaint at 3501 North 6th Street (Elim's Lounge). The investigation revealed there had been a fight inside the business. While being escorted from the business by security, one of the combatants ran to a car and returned to the bar with a gun, shooting two people. A police incident report was filed.
- F. Attorney Roy B. Evans stated that the underage patron gained entry with a fake ID. When police arrived, the patron had already given the ID to another patron. There was an incident with overcrowding based on a miscalculation. He stated the applicant is paying off the fine and has discussed capacity issues with the police department. He further states the applicant has reviewed the shooting incident with staff. They have determined that security protocol was followed. There was a pat down at the door and no weapons were inside the establishment. When an argument began, security attempted to dissipate the situation and escorted individuals outside. One of the individuals left to retrieve a gun. Security personnel were inside and outside. Staff inside kept additional individuals from joining the incident. Staff were stationed outside to keep the incident from escalating.
- G. Alderwoman Coggs stated that steps taken the evening of the incident may not have been enough. There are a number of additional steps that can be taken to keep an establishment secure. She suggested security procedures be re-evaluated and the applicant can speak with the police department for suggestions.

CONCLUSIONS OF LAW


1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapters 90 and 108 of the Milwaukee Code of Ordinances.
2. Based upon the above facts found, the Committee concludes that the Licensee, Ivory Elim, has not met the criteria of Chapters 90 and 108 of the Milwaukee Code of Ordinances or Chapter 125 of the Wisconsin Statutes to allow renewal of his Class "B" Tavern and Public Entertainment Premises licenses without undergoing a ten (10) day suspension of said licenses based upon the police report. The Committee finds the police report, as stated above, to be true.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern and Public Entertainment Premises licenses for the premises located at 3501 North 6th Street in the City and County of Milwaukee, Wisconsin ("Elim's Lounge") with a ten (10) day suspension based upon the police report.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes and one (1) excused recommends that the Class "B" Tavern and Public Entertainment Premises licenses be renewed with a ten (10) day suspension based on the police report.

Said suspension is to be in effect between 12:01 a.m. on November 2, 2014 through 11:59 p.m., November 11, 2014.

FINDINGS OF FACT

1. Man F. Zhang (hereinafter the "Licensee") is the holder of a Class "B" Tavern License for the licensed premise at 200 West Wisconsin Avenue in the City and County of Milwaukee, Wisconsin ("Kiku"). Said license expires on October 28, 2014.
2. An application to renew said licenses was filed with the Office of the City Clerk on August 22, 2014.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances, the matter was referred to the Milwaukee Police Department for investigation. On September 16, 2014, the Milwaukee Police Department responded with a police report which could form the basis of nonrenewal, suspension for revocation of this Licensee.
4. On October 8, 2014, the City Clerk's Office provided notice to the Licensee, pursuant to Chapter 90 of the Milwaukee Code of Ordinances of the police report that could form the basis of nonrenewal or suspension of this Licensee. The Licensee was provided a copy of the police report with the notice of hearing. The matter was scheduled for hearing on October 20, 2014 at 9:00 a.m. The Licensee did not appear for a second time and was not represented by counsel.
5. Based upon the sworn testimony heard and the evidence received at the hearings, the Committee finds the following:
 - A. A notice of the hearing as well as a copy of the police report was sent to Man F. Zhang at 200 West Wisconsin, Milwaukee, Wisconsin 53203 on October 8, 2014 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. The address of 200 West Wisconsin Avenue, Milwaukee, Wisconsin 53203 is the address given by the Licensee on his application. The envelope was not returned to the License Division by the United States Postal Service. The Licensee failed to appear at the hearing on October 20, 2014. The envelope was not returned to the License Division by the United States Postal Service.



CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 90 of the Milwaukee Code of Ordinances.
2. Based upon the above facts found, the Committee concludes that the Licensee, Man F. Zhang, Agent for "Kiku, LLC" d/b/a Kiku for the premise located at 200 West Wisconsin Avenue, in the City and County of Milwaukee, Wisconsin has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of his Class "B" Tavern License due to a second nonappearance.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its discretion to not renew the Class "B" Tavern License for the premises located at 200 West Wisconsin Avenue in the City and County of Milwaukee, Wisconsin ("Kiku") based upon a second nonappearance.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of five (5) ayes and zero (0) noes, recommends that the Class "B" Tavern License for the premises located at 200 West Wisconsin Avenue in the City and County of Milwaukee, Wisconsin not be renewed based on a second nonappearance.



The investigation revealed two males robbed an employee and another patron while they were standing outside in front of Lorenzo's bar. Both suspects were armed with guns and obtained property before fleeing the area. Police spoke with the bartender Jimmie Harris, who stated he was inside and didn't observe the incident. Lorenzo's does not have video surveillance inside or outside the bar.
- B. On April 18, 2013, the licensee received a citation for public entertainment premise-license required and was found guilty on November 18, 2013 and fined \$689.00.
- C. On December 14, 2013 Milwaukee police responded to a battery complaint at 9403 West Silver Spring Drive #8. The caller stated he had been at Lorenzo's tavern (1218 West Cherry Street) earlier in the morning and another patron had punched him in the face. The caller received stitches at Mt. Sinai Hospital. Milwaukee police filed an incident report.'
- D. On January 18, 2014 Milwaukee police responded to a fight at 1206 West Cherry Street. The investigation revealed that a shooting had taken place in front of the tavern located at 1218 West Cherry Street (Lorenzo's). Witnesses told police that an unknown person began shooting at everyone in front of the business with an AK-47. The windows of a vehicle parked outside of the business were damaged as well as the victim being struck multiple times by gunfire. Milwaukee police filed an incident report.
- E. On February 22, 2014 Milwaukee police conducted a traffic stop of a vehicle that was leaving the area of the bar. The driver of the vehicle told officers he and his friends had just left the tavern and observed a fight occurring outside the business. The driver told officers that one or two of the subjects involved in the fight possessed firearms. The officers involved in the traffic stop then went to the business and were told by the applicant that everything was fine.
- F. On February 23, 2014 Milwaukee police responded to a battery-cutting at St. Joseph's Hospital. The victim told police she had been at Lorenzo's (1218 West Cherry Street) around 12:00 a.m. when a fight broke out inside the business. The victim decided to leave the business in order to avoid the fight. The victim later noticed she had a small cut on the right side of her abdomen, but does not where or when she received the injury. A Milwaukee police incident report was filed.
- G. On Monday April 28, 2014 Milwaukee police conducted an investigation at 1218 West Cherry Street (Lorenzo's) based on information that the business was open in violation of the plan of operation, which indicated that the business should be closed on Monday. Officers found the business to be open, with several patrons eating and drinking on the premise as well as a lit "Open" sign on the west side of the business. The Class "B" License displayed at the business includes hours of operation Sunday, Tuesday through Thursday, Friday and Saturday but does not include hours of operation for Mondays. The applicant received two citations and a warning for a food dealer's violation.
- H. The licensee stated the shooting on January 18, 2014 occurred after a party. He knows the majority of his patrons and states there was no fight or argument in the establishment. In the incident where a woman had been cut, she got into an argument with her partner. The licensee states there was no physical altercation in the bar. Since the incident, the

woman has frequently tried to enter the establishment, but has not been allowed to. After the last incident, he installed eight cameras. Since the cameras have been installed, there have been no issues. He has also hired another security guard. Outstanding tickets have been paid. He stated that there was a misunderstanding over being open on Mondays. He thought he requested the hours and that they were approved on his renewal application last year.

CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapters 90 and 108 of the Milwaukee Code of Ordinances.
2. Based upon the above facts found, the Committee concludes that the Licensee, Terry D. Clincy, has not met the criteria of Chapters 90 and 108 of the Milwaukee Code of Ordinances or Chapter 125 of the Wisconsin Statutes to allow renewal of his Class "B" Tavern and Public Entertainment Premises licenses without undergoing a ten (10) day suspension of said licenses based upon the police report. The Committee finds the police report, as stated above, to be true.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern and Public Entertainment Premises licenses for the premises located at 1218 West Cherry Street in the City and County of Milwaukee, Wisconsin ("Lorenzo's") with a ten (10) day suspension based upon the police report.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes and one (1) excused, recommends that the Class "B" Tavern and Public Entertainment Premises licenses be renewed with a ten (10) day suspension based on the police report.

Said suspension is to be in effect between 12:01 a.m. on November 23, 2014 through 11:59 p.m., December 2, 2014.
