2. On 08/14/20 at 12:52am, Milwaukee Police were dispatched to 1227 W. Oklahoma Avenue for a subject with gun complaint. Investigation revealed that a subject entered the establishment, purchased an ice cream, and left the store. Nine minutes later, the subject re-enters the store and wants a refund because the ice cream melted. An argument ensues and the subject leaves the store only to come back inside with another subject who has a firearm in his

- 3. On 01/17/21 at 6:34pm, Milwaukee Police were dispatched to 1227 W. Oklahoma Ave for a fight complaint. Police spoke with the victim who stated that he had pain to the side of his head. The other parties involved were not on scene upon police arrival. The victim stated that he fought with 2 subjects he just met at a party inside the store. Suspect #1 struck him with an unknown blunt object, then suspect #2 enter the store striking him with closed fists. The suspects involved left in an unknown auto. The victim was vague with police of the particulars of the incident. Police observed no visible injuries and the victim was transported by ambulance to the hospital for further evaluation. Police attempted to review video but the store clerk stated that the owner only has access to the video, and he would be at work in the morning.

#### INITIAL INVESTIGATION

This report is written by PO Thomas BRUMMOND assigned to District #6 (3006 S 27th Street), Early Power shift, Milwaukee Police Department.

I was working in the Patrol Bureau assigned to Squad #6255 (with partner PO Charles JUMES PS #024608) SECTOR 650.

I was in full Police issued uniform with my outer worn ballistic vest with name plate attached to the right side of my vest and a sewn on Milwaukee Police Department badge on my left part of my carrier.

I was wearing and operating my Department issued body worn Axon Flex 2 camera with the battery pack attached to my vest and the

camera mount on my left shoulder. Camera #X83065572 /MODEL AX1006) with battery pack #X84103810/ MODEL #AX1005)

I was operating vehicle #004, which is assigned to Early Power shift.

On Sunday, January 17th, 2021, I was assigned to Squad 6255 along with my partner (P.O. BRUMMOND). At 6:34PM, we were dispatched to investigate a fight at the AA Mart located at the address of 1227 W Oklahoma Ave. It should be noted that throughout the duration of this assignment I was equipped with my Axon body worn camera, which was both operational and functional.

#### Scene:

The AA Mart is located on the southeast corner of S 13th St/W Oklahoma Ave. On the northside of the gas station is the main entrance off of W Oklahoma Ave. On the southwest corner of the gas station on the inside of the building was a display containing various items that were on the floor. On the very west side of the gas station is where the cashier is located. On the floor to the east of the cashier was broken glass that appeared to be from the outer portion of a candle. This glass was most cleaned up by gas station employees at the time of my arrival.

## Interview of Randall T GRIFFIN (B/M 11/19/1978):

GRIFFIN approached me and informed me that he was the victim of the incident that occurred within the gas station. GRIFFIN stated that he was at a party in the area of S 19th St/W Greenfield Ave. GRIFFIN was unsure of the address of the residence he was at for the party. GRIFFIN informed me that he wasn't feeling well and he wanted a ride to the VA Medical Hospital. GRIFFIN informed me that four unknown subjects at the party offered to give him a ride.

GRIFFIN stated that he then entered the vehicle with the four subjects. I asked GRIFFIN what type of vehicle it was and he informed me that he wasn't sure because he just "hopped in." GRIFFIN informed me that there were two female subjects in the rear of the vehicle with him. GRIFFIN stated that he was seated in the rear of the vehicle behind the driver's seat. GRIFFIN informed me that suspect 1 was seated in the front, passenger seat and that suspect 2 was seated in the driver's seat.

It should be noted that although GRIFFIN was cooperative, he was somewhat vague with his answers and appeared to not want police assistance. GRIFFIN informed me that while enroute to the VA Medical Center suspect 1 pulled the vehicle east facing in the northwest side of the gas station at gas pump #5. GRIFFIN informed me that at that point an argument occurred within the vehicle. GRIFFIN stated that he then began to fear for his safety, exited the vehicle and ran inside of the gas station.

GRIFFIN informed me that once he entered the gas station he closed the gas station door and began to hold it shut so suspect 1 was unable to enter the gas station. GRIFFIN stated that moments later he turned towards the cashier and instructed the cashier to call the police. GRIFFIN informed me that while he was facing west and looking away from the main entrance suspect 1 entered the store. GRIFFIN stated, "That's when I had my back turned and she came on me." I asked that GRIFFIN elaborate in regards to how he was assaulted by suspect 1. GRIFFIN stated, "Dude, I don't know. She grabbed something and hit me on the head with it." GRIFFIN stated that suspect 1 struck him twice to the right side of the head with an unknown, glass object.

GRIFFIN informed me that he was able to "fend" suspect 1 off of him. GRIFFIN stated that at that time suspect 2 entered the gas station. GRIFFIN stated that suspect 2 then struck him to the right side of the head numerous times with a closed fist. GRIFFIN informed me that suspect 1 and suspect 2 then exited the gas station, entered the vehicle and left the scene.

#### Tasks/Follow-up:

GRIFFIN did not consent for suspect 1 to intentionally arm herself with an unknown glass object and strike him twice to the right side of the head with that object causing pain. GRIFFIN also did not consent for suspect 2 to intentionally strike him numerous times with a closed fist to the right side of the head also causing pain.

I examined the area of the head that GRIFFIN was struck but observed no visible injury. GRIFFIN did however inform me that he did have pain due to the assault. GRIFFIN was advised as to his rights as a victim. GRIFFIN was conveyed to the VA Medical Center by Bell 413.

P.O. BRUMMOND spoke to the cashier at the store that was present when the incident occurred. P.O. BRUMMOND was advised by the cashier that they do have working video surveillance, however, only the owner can view it. Follow-up will be conducted when time permits to view the video surveillance.

#### LICENSE PREMISE REPORT

This report is written by Police Officer Daniel Drewek assigned to District 6 Early Shift.

On 1/30/21, at 4:05 pm, my partner Police Officer Ryan Lafond, and I, while on squad 6230, were dispatched to 1227 W, Oklahoma Ave (Petromart) for a property damage complaint.

#### Victim interview:

Upon arrival, I spoke with the caller, Tiufiq Mohammed (w/m, 3/16/89) who said a subject earlier came into the store and went in the bathroom and became upset when he was asked to leave. Tuifiq said the subject has came into the location in the past and has stolen items. Tuifiq said he escorted the subject outside and he flipped over the garbage can and spill it on the ground by the gas pumps. Tiufiq said the subject picked up an item, later determined to be a small glass bottle of Patron, and threw it at the window on the north wall causing damage. Tiufiq showed me the camera footage regarding the incident. He did not know how to record the video but was able to play it for me. I was able to play the video and record it on my body camera. The time on the videos shows 5:06 pm but the time is actually 1 hour and 12 minutes ahead of real time. The actual incident occurred around 3:54 pm (1/30/21). After the suspect throws the bottle at the window he walks east on W. Oklahoma on the sidewalk and out of camera view.

#### Suspect description:

Hispanic male, 25-30 years, 5"04', 140#, wearing a grey hooded sweatshirt with a zipper. Tiufiq said the hood was pulled over his head and he had a facemask on.

#### Damages:

Tiufiq estimated the damages to be about \$250. He did not the insurance company. I used my body camera to capture the damages to the window.

A property damage report was filed under the same case number.

Tiufiq was issued a PV-17 and a community contact card.

Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

# Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
