2. On 11/21/18 at 2:05am, Milwaukee Police conducted a tavern check at 3261 S. 13th Street (El Tucanazo). Upon entering the establishment the officers observed 6 subjects inside (4 sitting around the bar with open beer bottles, 1 behind the bar, and one working in the back area). The person behind the bar, who was intoxicated, told the people inside that everything was alright because the tavern does not have to close until 2:30am. Officers informed the person that she was wrong and that the tavern should have closed at 2:00am (in actuality, the hours of operation on that particular day was 11:00pm according to the license). The person behind the bar then became argumentative with officers and said the people inside were employees, until one of the people sitting at the bar stated that she was not an employee. The applicant was informed of the violation and issued a citation #19009560. The citation was dismissed on 02/27/19.

3. On 09/22/2019 at 3:41am officers were dispatched to a Noise Nuisance call at El Tucanazo Taqueria Y Mariscos, 3261S 13th St. When the officer arrived they could hear music coming from the restaurant. The officers found the door locked. As they knocked they observed a female turn off the lights and walk to the back area, ignoring the officers. On 09/23/2019 the officers went to the business to speak with the applicant. An employee called him and he responded to the scene. He stated he did not know about the incident and would attempt to get to the bottom of it. the applicant was mailed a citation for Noise Nuisance.

4. On 02/16/2020 at 2:23am officers were dispatched to a Battery complaint at El Tucanazo Taqueria Y Mariscos, 3261S 13th St. When the officer arrived at the business it was closed. The officers were then advised the victim had gone to the hospital. The victim stated he arrived at the bar at 1:30am, had two beers and was waiting for food. He stated he was sitting at the bar when another customer hit him in the head with a gun. The victim stated the owner told him to hide, because the subject might kill him. He said she also told him to not call the police. The officers conducted follow up and spoke with the bartender, who stated the subjects were sitting at the bar and got into an argument. The argument escalated and the subject hit the victim with a gun. The bartender denied telling the victim to hide and to not call the police. A check revealed the business hours in LIRA are listed at 11:00am to 11:00pm.
5. On 03/25/2020 at 5:32pm officers were dispatched to check the business at 3261 S 13th St. The caller stated the business was serving patron inside and vehicles were parked outside for 20 minutes. The officers spoke with the applicant, who stated he had 5 take-out orders all day and the only person inside was his delivery driver. The officer did not observe any customers in the store and the chairs were on the tables. The applicant was reminded to have patrons who order food inside to wait outside until the food is ready.

This report is being written by P.O. Christopher **JACKSON** assigned to District Six, Late Power Shift.

It should be noted that during my tour of duty I was in full duty uniform with an axon body camera affixed with a headband. Also driving and operating a marked police squad with MVDR ability.

On Sunday, September 22, 2019 I was notified by P.O. Paul **GRACZYK** of a call for service he responded to. P.O. **GRACZYK** was dispatched to 3261 S. 13th St. in the City and County of Milwaukee for business known as El Tucanazo Taqueria Y Mariscos for a Noise Nuisance complaint. (CAD Call# 192650371)

P.O. **GRACZYK** was assigned to Squad 6341 and responded along with Squad 6330, P.O. Benjamin **DELANEY**. Upon their arrival at 3:41am they could hear music coming inside the restaurant that exceeded 50 feet away. The front door to the restaurant was locked but officers could see at least one Hispanic female inside. After officers knocked on the door the Hispanic female then turned off the lights and walked towards the back area disregarding officers. Officers then being unable to make contact with anyone, informed me to conduct follow up regarding the call and make contact with the listed agent.

It should be noted that after checking information for the restaurant, the plan of operation states that it should be closed at 11:30pm on that Saturday night. Also related to the original caller the cad report reads: caller states restaurant next to his house is playing loud music. Caller states this is an ongoing issue.

On Monday, September 23, 2019 I conducted follow regarding the cad call. I first attempted to contact the listed agent Francisco J. **GONZALEZ** (M/W 10-06-81) over the phone. I attempted calling several numbers listed under the agent's information located in the (L.I.R.A.) system along with the restaurants public listed number. I either received voicemail message that the mailbox was full or a continuous ringing to the full mailbox. At approximately 8:49pm I arrived to the restaurant and was able to have an employee contact **GONZALEZ** to meet me at the restaurant. **GONZALEZ** arrived approximately 15 minutes later and I informed him of the Noise Nuisance violation. **GONZALEZ** stated that he was not aware of the incident and understands that he will be issued a citation regarding the violation. He also stated that he will try to get to the bottom of the issue and take care of it. **GONZALEZ** did confirm his mailing address and was informed he will be issued the citation by mail. I also provided **GONZALEZ** with a PF-6 Community Contact card with information on how to contact me if need be.

P.O. **GRACZYK** issued the Noise Nuisance citation #068272BC3K and it was mailed to his address.

This report is written by PO Jordan HERRMANN assigned to District Six, Late Shift.

On Sunday, February 16, 2020 at 2:23am, Squad 6330 (myself) and Squad 6367 (PO SHEREMETA and PO STURMA), were dispatched to 3261 S. 13th St, El Tucanazo Taqueria Y Mariscos Bar, which is in the City and County of Milwaukee, for a battery complaint.

Officers first responded to the bar which appeared to be closed. There were no lights on and nobody answered the door when officers knocked on the door.

Officers received a updated that the victim, Felipe SANCHEZ-HERNANDEZ (M/W, 10-31-91) went to St. Francis Hospital. Officers spoke to SANCHEZ-HERNANDEZ who stated he arrived at the bar at approximately 1:30am. SANCHEZ-HERNANDEZ stated he had two beers and was waiting for food that he ordered. SANCHEZ-HERNANDEZ stated while he was sitting down at the bar another customer struck him in the forehead with a handgun. SANCHEZ-HERNANDEZ stated the owner/bartender said to him, "you better hide they are probably going to try and kill you." SANCHEZ-HERNANDEZ also stated the owner told him not to call the police and told him to say the incident did not happen inside of the bar because she could get shut down.

Later on Sunday, February 16, 2020, Squad 6163 (PO Brian BISCOBING) was able to speak to the owner/bartender, Tatiana FLORES. PO BISCOBING stated during his interview which took place at approximately 12:00pm, FLORES appeared to be slightly intoxicated. FLORES told PO BISCOBING a similar story that SANCHEZ-HERNANDEZ and the suspect were sitting next to each other having a conversation. At one point the conversation turned into an argument where both males stood up. The suspect then hit SANCHEZ-HERNANDEZ in the head with a gun before the two males were separated. FLORES stated both males were heavily intoxicated. FLORES stated she never told SANCHEZ-HERNANDEZ to hide and she never told him that he should not call the police. However, **FLORES could not give a reason why she did not call the police when the incident occurred.** FLORES was able to email PO BISCOBING a copy of the surveillance camera that captured the incident.

According to a City of Milwaukee License Search the tavern's hours of operation for Sunday's are suppose to be 11:00am to 11:00pm. So this incident occurred after the taverns Hours of Operation.

The hearing before the Licenses Committee will take place virtually on 7/10/2020 at 2:20 PM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first, and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
