

## Wisconsin Native Vote Milwaukee Mural Artist Contract 2022

**Client:** Wisconsin Conservation Voices/Wisconsin Native Vote.  
**Artist:** Christopher Sweet  
**Purpose:** Milwaukee has the largest population of Native Americans in Wisconsin and Wisconsin Native Vote is working to get voters to the polls.  
**Goal:** To produce a mural that will garner the attention of Milwaukee's Native American population to the polls.  
**Timeline:** September 2022.  
**Location:** Gerald L. Ignace Indian Health Center, 930 West Historic Mitchell St. North Wall facing GLIHC's Parking lot

**Dimensions:** (12) Twelve-feet high by (15) fifteen-feet wide.

**Compensation:** The Client will pay the Artist Christopher Sweet \$7,000.00 for the art; \$3,500 for artwork already completed at once; and the remaining \$3,500.00 upon completion. The artist shall be reimbursed for all art supplies, including marine grade plywood and additional materials needed to complete the project.

It is further agreed that:

The responsibilities of the Client are as follows:

1. Supply any necessary or reasonable support for the Artist during completion of the project included but not limited to marketing, public viewing, assistants in securing scaffolding/lifts.
2. Prepare the area to make the space ready for the Artist to work, included but not limited to such items as dumpsters.
3. Pay the Artist above stated compensation within 30 days following completion.

The responsibilities of the Artist are as follows:

1. Complete the project in a timely manner.
2. As the work will be on panels, the Artist will be responsible for sealant.

It is further agreed that:

1. The Client and Artist shall share all rights to completed work to use at their discretion.
2. Where appropriate the Artist will be acknowledged in publications and promotions.
3. The Artist is encouraged to write a descriptor to be used by the Client when promoting the Mural.
4. The Artist shall maintain appropriate Workers Compensation/Personal Liability Insurance and shall indemnify and hold harmless the Client relating to the same.
5. The Artist has creation judgement to make aesthetic judgements within the bounds of the accepted design. All efforts will be made to inform a designee of the Client of any relevant or significant artistic choices.
6. The Artist will warranty the mural for a period of (2) two years for paint defects, such as fading, peeling, etc., and provide a complete list of paint colors used for any touch-ups or graffiti mitigation required post completion.

All parties accept the terms of this contract.
