This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 09/22/2020 officers conducted a Safety and Security meeting at The Hampton Inn, 1200 W. College Av. The applicant stated the door lock at 11:00pm and you need a key to enter. The property does not have exterior security cameras but did update the parking lot lighting. The hotel does not have on sight security but does have a roving patrol. The applicant stated he has noticed an increase in loitering since the start of the quarantine. The applicant was given the district phone numbers and advised to call with any issues.

- On 01/01/21 at 1:46pm, Milwaukee Police were flagged down for an auto theft at 1200 W.
 College Avenue. Investigation revealed that the victim, who was a guest of the hotel, gave his
 vehicle keys to his mother-in-law and she took the vehicle without his consent. A report was
 filed.
- 3. On 01/01/21 at 10:53pm, Milwaukee Police were dispatched to 1200 W. College Avenue for a trouble with subject complaint. Investigation revealed that a subject was in a room and was not a registered guest. The male was conveyed to a hospital and no violations were made by the business.
- 4. On 01/06/21 at 6:22pm, Milwaukee Police were dispatched to 1200 W. College Avenue for a property pick-up. Upon arrival, officers interviewed the manager who stated that a subject had

property inside a room but had a balance due regarding his stay. The caller was advised and said he would pick up the property later. No violations made by the business.

- 5. On 01/07/21 at 17:37, Milwaukee Police conducted a Safety and Security meeting at The Hampton Inn, 1200 W. College Avenue. No violations were found.

- 8. On 05/22/2022 at 6:02am officers were dispatched to an Auto Theft at Hampton Inn, 1200 W. College Av. The caller stated his rental Hyundai was stolen overnight. The officers spoke with the night clerk, who stated there were no cameras covering the parking lot.

- 9. On 02/25/23 at 7:54p.m., Milwaukee Police were dispatched to a Trouble with Subject at 1200 W. College Av. Investigation revealed guest were complaining about other guests' behavior in the pool area. The guests agreed to go back to their room. The employee was cooperative with the investigation.
- 10. On 02/26/23 at 12:04a.m., Milwaukee Police were dispatched to a Trouble with Subject at 1200 W. College. Investigation revealed an intoxicated guest got locked out of their room. The officer assisted the guest in gaining access to their room.
- 11. On 03/03/23 at 11:25a.m., Milwaukee Police were dispatched to a Trouble with Subject at 1200 W College Av. Investigation revealed a guest, who had been arrested earlier in the week, had left behind drug paraphernalia and the hotel staff did not feel safe to dispose of them.

Investigation revealed an intoxicated subject was sitting in front of the hotel with their car stereo blasting. The subject was advised they could not drive due to their level of intoxication and after arguing with officers, was arrested and conveyed to the District.

- 15. On 05/28/23 at 2:21a.m., Milwaukee Police were dispatched to a Trouble with Subject at 1200 W. College Av. Investigation revealed an intoxicated subject was attempting to start the hotel shuttle with a set of keys that did not belong to the shuttle. The subject was gone on police arrival.

Investigation revealed an elderly citizen was confused and asking for a guest that was not staying at the hotel. Along with hotel staff the officers were able to assist the citizen. - 17. On 07/15/23 at 4:42p.m., Milwaukee Police were dispatched to a Subject with Weapon at 1200 W. College Av. Investigation revealed guests were in line while checking in and began to argue with one another. One guest pepper sprayed another guest, and all parties left prior to police arrival. The employee was cooperative with the investigation.
- 18.On 11/19/23 at 9:36p.m., Milwaukee Police were dispatched to a Trouble with Subject at 1200 W. College Ave. Investigation revealed a guest was smoking in the room and their dogs had had left urine and feces on the floor. The guest was asked to leave multiple times by staff, however, refused. The officer was eventually able to persuade the guest to leave with no further incident.

Upon arrival, I met with the caller/manager, Joseph G BUMP, M/W, 07-30-67, who had complaints regarding guests who had been in the pool area; "Twerking." According to BUMP, guests complained about the behavior. BUMP stated he had confronted the guests (Room 329) at the pool area, at which time they stated they would leave. I made contact with the occupants of Room 329, who stated they meant leave as in the pool area and return to their room. BUMP scolded the occupants for "Twerking" in his hotel room but allowed them to stay if no further problems occurred. The occupants appeared cooperative.

All employees involved in the investigation were cooperative. I observed the license information displayed (0000534) for the hotel to be expired 12/13/2022 and BUMP did not know where or if there was an updated license. I also observed a Certificate of Occupancy issued October 28, 2015, also displayed.

This report is written by P.O. Juan L GARCIA (PS#024604), assigned to Squad # 6350, District Six, Late Shift and equipped with body worn camera.

On Sunday February 26, 2023, at approximately 12:04 AM, I was dispatched to the address of 1200 W College Av (Hampton Inn Milwaukee-Airport), which is located in the City/County of Milwaukee for a trouble with subject complaint.

Upon arrival to the above listed (12:35 AM), I observed the subject who the hotel staff had called in, sitting in the hotel cafeteria area drinking a coffee ad talking with an unknown white male. The subject was later identified by his WI ID as Levi KING (B/M, 02/19/81).

Mr. KING was cooperative and admitted to being intoxicated. Mr. KING advised me that he was staying at the hotel and that his wife was in Room 317. I observed Mr. KING to have no t-shirt, no socks, however, he was wearing a black hooded sweatshirt and red swimming trunks. Mr. KING stated he was sorry and just wanted to get back into his room.

Mr. KING was able to provide the information of his wife/and the person staying in Room 317. Manager at the hotel confirmed that the person's name provided by Mr. KING did match their records, but that Mr. KING was not listed in the room. Manager advised us that they had knocked numerous times and called the person listed in that room with no answer.

I was provided a room key and took the elevator with Mr. KING to the 3rd floor in an attempt to make contact with his wife. I knocked at the door of Room 317, and no one answered. I could hear that the television was on. I used the room the key that was provided to me and entered the room. As I opened the door, I observed in the bed closest to the door a white female sleeping. I attempted to wake up the subject but only got mumbles and humming. I observed that there were food bags and empty alcohol containers throughout the room. I was able to identify the female sleeping as Jennifer L ARROYO-COTTON (W/F, 05/09/76) through her WI ID. I observed ARROYO-COTTON to be breathing as her chest would rise and would move her head when talking to her.

I did not observe any signs of physical abuse on ARROYO-COTTON.

I also found inside the room, Mr. KING's personal belongings which included his wallet and WI ID.

Mr. KING was allowed to go back inside his room and was advised to let his wife sleep and that he can't be walking around the hotel lobby. Mr. KING agreed and went inside his room to sleep.

It was determined through my investigation that ARROYO-COTTON had passed out from her alcohol consumption and when Mr. KING exited the room for unknown reasons he was locked out. Mr. KING not being registered in the room; the hotel staff would not provide Mr. KING with a hotel key.

No one was injured or hurt during incident.
