2. On 4-18-2005 at 2:11am, Milwaukee police were sent to a fight at 2106 W National Ave. Upon investigation, it was learned that a fight started between 3 patrons of the El Jalapeno tavern. Two were treated at Froedtert Hospital for stab wounds. One received 35 stitches to his stomach and left side of his face and one other received 4 stitches to his left side of his face and required surgery for a large laceration to his stomach.

- 3. On 03/18/09 at 8:25 am, Milwaukee police were dispatched to 2106 W National for a Burglary complaint. Investigation revealed an entry did occur with cash being removed from the video games and jukebox. A report was filed.
- 4. On 04/26/09 at 11:49 am, Milwaukee police were dispatched to 2106 W National for a Subject With Gun complaint. Investigation revealed a male entered the business with the lower portion of his face concealed pointing a gun demanding money from the clerk. The clerk failed to comply and the suspect became angry and whiling fleeing the premise, kicked out the plexiglass window of the front door. Nothing was obtained and no injuries were reported.

- 5. On 05/08/2009 at 4:38am, Milwaukee police were dispatched to 2106 W National (El Jalapeno Restaurant) for a Battery complaint. Additionally, officers were unable to locate a sign indicating the business's maximum capacity. - 8. On 12/03/11 at 3:11 am, Milwaukee police investigated a Battery complaint that occurred at 2106 W National Avenue. Police spoke to the victim who stated that a known subject punched him in the face while he was inside the El Jalapeno Restaurant. The suspect was still on scene and was issued a citation and later observed by officers leaving in a truck with friends. Around 4:05 am, a shooting occurred in front of the restaurant with the victim of the earlier battery being the suspect and victim of the shooting being the suspect from the earlier battery.
- 9. On 04/08/12 at 3:08 am, Milwaukee police responded to a Fight complaint at 2106 W National Avenue. Investigation revealed that a fight started inside the restaurant with two males fighting and as the fight intensified, more patrons became involved. Officers spoke with Whesley Rios, who works as a security guard for the restaurant and obtained his statement regarding the incident. Police also spoke with the manager Everardo Gutierrez-Garnica regarding the incident. He stated his brother Angel Gutierrez-Garnica was out of the country for a family medical emergency and was unable to be contacted. Police observed security cameras mounted in the restaurant, but when officers asked to view the video of the fight, were told by Everardo that he didn't have a key to locked video room located in the basement. Police issued several citations to patrons involved in the fight.

- 19. The applicant is on probation for Item # 18. Email notification to the Wisconsin Department of Corrections on 05/29/2019 requesting they provide information to the License Division regarding the probation/parole status and the end date of the status.
- 20. On 03/17/2019 officers were dispatched to a Trouble with Subject complaint at El Jalapeno, 2106 W. National Av. The applicant was the caller and he stated he has security on Friday and Saturday night due to the high amount of customers. The officers broke up several fights and issued a citation for a battery that occurred.

- 21. On 11/18/2019 officers were dispatched to a Fight at 2106 W. National Av. The caller stated it appeared other patrons wanted to fight him. The applicant stated several males began to argue and he asked them to leave the business. The subjects left and the applicant had no further information.
- 22. On 03/01/2020 officers investigated a Shooting at 1500 W. Scott St. The investigation revealed the shooting may have been related to a Trouble with Subject that occurred earlier in the night at Taqueria El Jalapeno, 2106 W. National Av. The officers spoke with the applicant, who stated at about 3:20am there were two groups arguing in the restaurant. He had his security escort one group out and kept the other group inside for 15-20 minutes. After that time the second group left in two separate cars. The applicant provided video of what happened inside the restaurant.

- 23. On 12/11/20 at 2:42am, officers were dispatched to a Shooting complaint at El Jalapeno, 2106 W. National. Officers were met by the agent and advised an argument broke out inside the restaurant that escalated into a physical fight outside. Officers were advised that he eventually heard multiple shots fired outside. Officers located a victim with a gunshot wound to the leg. Officers located multiple casings in the area and observed video surveillance of the incident. The agent was cooperative with the investigation.
- 24. On 01/15/21 at 1:00pm, officers conducted a meeting with the agent regarding several latenight incidents that occurred at El Jalapeno, 2106 W. National Av. The agent was advised of the necessity to develop a safety plan for Covid-19 with the Health Department, Officers further advised that despite security personnel, there are still ongoing issues, therefore, a

reevaluation of the security plan may be needed. The agent was encouraged to call police when incidents arise.

25. On 08/20/21 at 3:10am, officers were dispatched to a subject with a gun at El Jalapeno, 2106 W. National Av. Officers spoke to the waitress who stated patrons were arguing with one another and it began to escalate. The caller stated she asked the patrons to leave; one cooperated and there was no further incident. The employee was cooperative with the investigation.

- 26. On 10/20/23 at 2:38a.m., Milwaukee Police were dispatched to a Subject with Gun at 2106 W. National Ave. On arrival officers observed patrons inside the business lock the door to the business. The agent was on scene and immediately unlocked the door and stated they did not need police services. Officers interviewed the caller who stated they were in a verbal argument with another patron inside the establishment, who followed them outside and displayed a firearm, before fleeing. The caller was intoxicated and uncooperative with officers and stated they did not want police services. The agent stated they did not have working exterior cameras.
- 27. On 12/02/23 at 1:17a.m., Milwaukee Police were dispatched to a Subject with Gun at 2106 W. National Ave. Investigation revealed a patron entered the restaurant and was asked by security to place their firearm in their vehicle before entering. The subject complied, and their vehicle was later broken into and the firearm was stolen. The agent was on scene and stated they did not have exterior cameras. Both the agent and the security guard were cooperative with the investigation.
- 28. On 06/06/24 at 2:45a.m., Milwaukee Police were dispatched to a Fight, which later was updated to Shots Fired at 2106 W. National Ave. On arrival officers observed a large crowd coming out of the restaurant, running away in different directions. A subject was interviewed who stated they observed security guards battering a patron and when the subject attempted to break it up, they were kicked and punched by the security guard. The interviewee further stated while subjects were running away, someone fired two shots into the air. The 911 dispatcher also heard the gunshots. The agent was on scene and uncooperative with the investigation, stating they did not see anything and the security guard was no longer employed and would only provide a first name for them.
- 29. On 06/07/24 at 3:34a.m., Milwaukee Police were dispatched to a Shots Fired at 2100 W. National Ave. The caller stated a female was struck by a male and screaming they were raped. The caller further stated a large group was outside and heard someone state they were shot. On arrival officers observed a large group outside of 2106 W. National Ave. Patrons denied seeing anything and stated they heard shots fired but they were a few blocks away. Officers did not locate anyone shot, nor did they locate and casings. A potential victim initially advised officers this all occurred after leaving the restaurant and they had a gun pointed at them, however, then stated they were drunk and did not wish to be a victim. Officers were approached by another patron who stated they came to there to drink because they were advised the restaurant sells alcohol after hours. The patron stated they ordered shots and paid cash for them, however, when squads arrived the waitress grabbed the shots to presumably hide them and returned the cash. The agent was on scene and stated nothing occurred inside the business and none of the subject had been inside.

30. On 06/19/24 at 3:07a.m., Milwaukee Police conducted an Undercover Operation at 2106 W. National Ave., in an attempt to purchase alcohol after hours. The officers ordered and were served two alcoholic beverages in grey plastic cups. The undercover officers stated when uniform officers were approaching the business, the agent advised the waitress to remove the alcoholic beverages. At 3:13a.m., uniform officers entered the business and observed 11 patrons inside the business and advised the agent the business was operating outside of their plan of operation which allowed them to be open until 3:00a.m. The agent stated they thought it was until 4:00a.m. everyday, which the officers referred the agent to review their license on the wall. The officers further observed security personnel inside, however, they left when they saw officers. The agent was cited for the violation.

- 31. On 06/23/24 at 2:45a.m., Milwaukee Police were dispatched to a Shooting at 2106 W. National Ave. Investigation revealed two victims were shot as they were driving past the restaurant. They stated they were enroute to the restaurant when shots were fired at their vehicle and realized they had been shot. Two employees were interviewed who stated they heard the shots, but did not see anything. One employee did not know how to work video surveillance, however, did allow officers to remove the system in order to obtain video.
- 32. On 07/27/24, Milwaukee Police conducted an Underage Tavern Enforcement Initiative. At 8:15p.m., a minor Police Aide along with a Police Officer, entered 2106 W. National Ave. The Police Aide ordered and was served a bottle of Miller Lite and did obtain a receipt. The employee was interviewed regarding the sale, however, denied the transaction. The agent arrived on scene and was advised about the violation. The agent stated employees are instructed not to sell alcohol unless the agent was on scene. The employee was cited for the violation.

- 33. On 04/26/25, at 2:20 a.m., officers were dispatched to a Battery in Progress complaint. An employee engaged in physical fight with a customer, they believed was attempting to leave the business without paying their bill. Security camera footage showed a scuffle in front of the business.
- 34. On 06/27/25, at 12:17 a.m., officers were dispatched to a Battery complaint. An employee was attempting to escort a disorderly subject out of the business when they were slapped by that subject.

- 35. On 07/03/25, at 4:15 a.m., officers on patrol observed the business open and operating with approximately 10 customers waiting in line. A license premise check was conducted and the listed owner/agent was found on scene. A check of the license showed the hours of operations to be 6:00 A.M. to 1:30 A.M. The agent was apologetic and stated they lost track of time. The agent was advised he would need to close.
- 36. On 07/25/25 at 2:51 a.m., officers conducted a License Premise check. Several customers were observed in the business after regulated operating hours. This report is typed by PO Roberto SANCHEZ, assigned to District Two, Late Shift.

On April 26th, 2025, at approximately 2:20am, Squad 2390 (PO Victor HERNANDEZ and I) were dispatched to a battery in progress at 2106 W. National Ave. which is located in the City and County of Milwaukee.

Upon arrival we observed the location to be El Jalapeno Restaurant. We initially did not observe any fight in progress upon arrival and after calling our initial caller we were informed they were at a nearby gas station.

PO Victor began to speak with the owner of the Restaurant who was identified as GUTIERREZ-GARNICA, Angel (W/M DOB 06-08-1971).

I was met with the victim/caller who identified herself as Reanna DENNIS (w/f 02/24/1999). DENNIS was accompanied by her friends who were identified as GOSLIN, Cheyenne (W/F DOB 09-16-1999), GALLEGOS, Nina R. (H/F DOB 01-03-2004), SMITH, Jacob (B/M 12-03-2004). This group had sat down and ate at El Jalapeno restaurant around 01:00 am.

DENNIS appeared to have abrasions on her face and after further observing her injuries it appeared she had her front three teeth chipped. Due to her injuries medical was dispatched.

I began to speak ALEXANDER who appeared to be visibly shaken and angry. ALEXANDER stated there was confusion with their group and the owner of the restaurant. ALEXANDER stated the group had divided the bill three ways amongst their party and after the bill was delivered to them she had began to feel "ill" and went to her car with her boyfriend SMITH.

GOSLIN stated she received the bill and was asked if the other party was going to pay the bill. GOSLIN then went outside while DENNIS remained in the restaurant playing their slot video machine. GOSLIN observed the waitress from the restaurant confront ALEXANDER about not paying the bill. GOSLIN informed the waitress that she has the bill and their portion of it was going to be paid.

SMITH stated he did not see who attacked DENNIS but stated when he observed the injuries to her face he got on the defensive. SMITH stated he "defended" himself against the people from the restaurant. SMITH stated he heard GUTIERREZ-GARNICA state DENNIS had fell.

I spoke to DENNIS while she was in the ambulance to try and get a better description of her attacker. DENNIS initially stated her attacker was a "bald headed mexican guy that was accompanied by a unknown hispanic female". DENNIS originally stated she had a picture of her attacker on her phone but at this time her phone was dead.

PO Victor HERNANDEZ spoke to GUTIERREZ-GARNICA who stated he did not strike DENNIS and that the injuries she received were caused by her falling as she was walking towards her vehicle. GUTIERREZ-GARNICA stated he believed the group was trying to "skip" on the bill. GUTIERREZ-GARNICA was willing to share footage of the incident. I observed a small portion of camera footage which only depicted a scuffle in front of the restaurant involving SMITH striking GUTIERREZ-GARNICA and then people attempting to separate the parties. I did not observe any physical markings on the hands of GUTIERREZ-GARNICA while I was interviewing him.

On Thursday, July 3rd, 2025, I (Passenger), along with my partner P.O. Anthony LLOYD, were assigned to Squad 2320, Vehicle 237, which is a marked Milwaukee Police Department squad Ford Explorer equipped with red and blue lights, audible sirens, and Axon video capabilities. My partner and I were wearing Milwaukee Police Department uniforms with our names and badges affixed to our outermost garments and equipped with Axon body worn cameras.

At approximately 4:15 AM, my partner and I were on patrol traveling East on W National Ave. When we were approaching the intersection of S 21st street and W National Ave, we noticed that the restaurant "El Jalapeno" located at 2106 W National Ave (in the City and County of Milwaukee) was still open and had approximately 10 subjects inside waiting for food. My partner pulled over and we conducted a license premise check on the establishment.

Upon entering the establishment, we were approached by the business agent, Angel GUITIERREZ-GARNICA (W/M 06/28/1971), who stated he was sorry and was just about to close. We asked to see his licenses, he cooperated and showed us where they were. The licenses were framed and on display on the eastern wall. All license are valid, however, the food dealer license and public entertainment license clearly list the establishments operating hours, which are 6:00 AM to 1:30 AM. I asked GUITIERREZ-GARNICA if he knew that the establishment was supposed to close at 1:30 AM, to which he stated that he knew. I asked GUITIERREZ-GARNICA why they were still open and serving food almost 3 hours after they was supposed to close, to which he replied, customers kept coming in and he lost track of time. I instructed GUITIERREZ-GARNICA to shut down, to which he did. I then informed and advised GUITIERREZ-GARNICA of the possible consequences of violating his license agreement with the City.

All customers left the premise without incident.
