

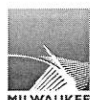
Following consideration of the report of the Public Works Committee, the Common Council voted to deny your Public Passenger Vehicle Driver's license based upon your nonappearance.


