4. On 08/06/2020 officers, on routine patrol, observed a large group of people outside of Court MVP Sports Bar, arguing. As the officers approached on foot they heard 6 gunshots and observed people running. No one stopped to talk with the officers and no damage was found. The officers located 6 shell casings on the sidewalk by the corner of the tavern. The officers spoke with the applicant, who stated there was no fight inside and he did not think the shots were related to his patrons. He has cameras but could not access them at this time.

5. On 05/29/21 at 10:17pm, Milwaukee Police were dispatched to 5700 W. Fond Du Lac Avenue for a shots fired complaint. Investigation revealed that a subject who was not allowed into the tavern went to his vehicle, retrieved a handgun, and fired multiple shots into the air. the surveillance system, which might have captured the incident, was not functioning properly and the employees and applicant were cooperative with the investigation.

6. On 02/22/22 at 11:00pm, a subject reported that he had a firearm stolen from his vehicle while it was parked at 5700 W. Fond Du Lac Avenue.
7. On 03/06/22 at 1:30am, a subject reported that she had two firearms stolen from her vehicle while it was parked at 5700 W. Fond Du Lac Avenue.
8. On 03/27/22 at 11:42pm, Milwaukee Police officers, while on patrol, observed a large fight in the parking lot of 5700 W. Fond Du Lac Avenue. After the crowd was dispersed, officers found that the fight stemmed from an argument inside the tavern and one person was arrested.

On Friday July 22nd 2022 at 12:56 A.M, Squad 7430 (Juliana NAILEN and I) were dispatched to assist ~~Squad 7350 (PO Hugo AVILES and PO Lorenzo MAHONES) for a Shooting complaint to the address of~~ 5700 W. Fond Du Lac Ave, which is located in the City and County of Milwaukee, Wisconsin.

During the investigation, I was tasked with speaking with the manager of the Court MVP Sports Bar and Grill (5700 W. Fond Du Lac Ave). I made contact with the Manager who verbally identified himself as Thomas MCNEAL (B/M 03-07-1957). MCNEAL stated he was working inside the bar when he heard approximately 3 gunshots. MCNEAL stated his instant reaction was to see if everyone inside the bar was ok. MCNEAL stated he then noticed that the shots fired he heard came from outside. MCNEAL stated he did not see what happened as he was inside of the bar.

MCNEAL stated he did have video footage of the incident. MCNEAL walked me to the second floor of the bar where he has the computer that controls all of the exterior cameras. I reviewed the footage with MCNEAL and passed it along to CIB.

Video surveillance observations:

While reviewing the footage, I observed a Gray SUV moving slowly Westbound on W. Vance PL, towards W. Fond Du Lac Ave. I also observed one of the victim's leave the Court MVP Sports bar and started walking Eastbound on W. Vance PL. The Gray SUV then drove past the victim and I observed muzzle flashes coming from inside the gray SUV. The victim dropped to the ground. A second victim who was standing with a group of people was also shot. The Gray SUV fled Eastbound on W. Fond Du Lac Ave, from W. Vance PL.

Both victims were pronounced deceased.

MCNEAL was very cooperative with myself. MCNEAL stood by and waited for the Forensic Investigator to arrive on scene to download the video surveillance from his computer system.


