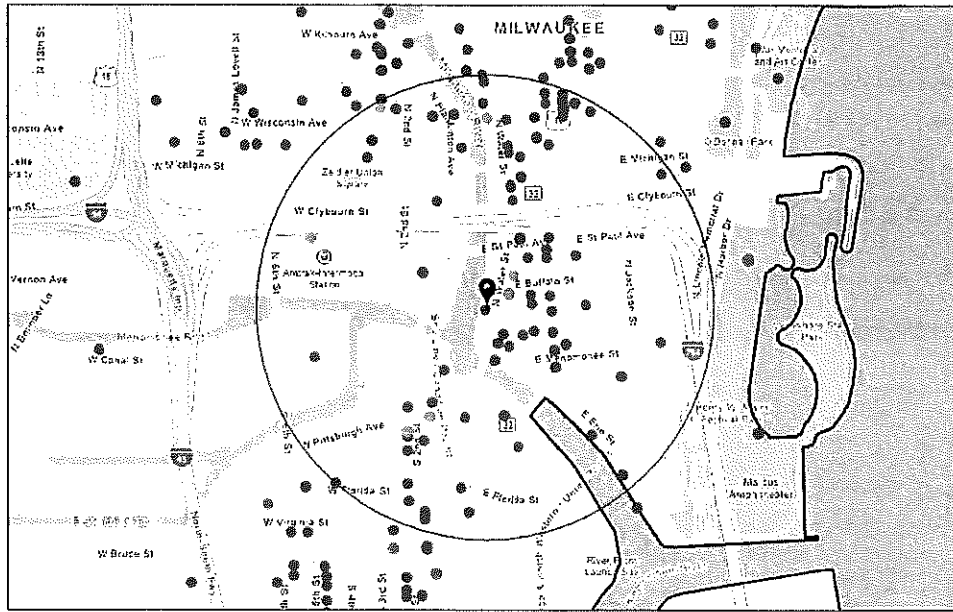
The location is finishing renovations and cameras are installed in the interior but not operational yet. The exterior of the building has its own outside cameras installed by the building owner.


