

Presentence report reviewed. Statements made as to sentencing.

The Court sentenced the defendant to a MAXIMUM TERM OF IMPRISONMENT of 15 YEARS, with credit for 160 DAYS time served; the INITIAL TERM OF CONFINEMENT in the Wisconsin State Prison System is TEN YEARS; the MAXIMUM TERM OF EXTENDED SUPERVISION is FIVE YEARS. The defendant is not eligible for the Challenge Incarceration Program or the Earned Release Program. The Court finds that a Risk Reduction Sentence is not appropriate.

The Court imposed the following conditions of extended supervision:

- no new law violations rising to the level of probable cause
- cooperate with probation officer
- no weapons
- Obtain an AODA assessment
- Maintain absolute sobriety with random urine screens at discretion of probation officer
- no contact with drug dealers, users or drug houses
- no direct or third party contact with Iram N. or family
- Obtain/maintain full-time employment
- report as sexual offender for life
- obtain sexual offender assessment and participate in treatment and programming
- pay restitution in order as follows: first to Iram N. of \$150.00, second to Department of Justice Crime Victim Compensation of \$2,744.50 and third to Milwaukee County District Attorney's Office of \$97.50. To be taken out of bail which was previously posted and is on deposit.
- Provide a DNA sample and pay surcharge. To be taken out of bail which was previously posted and is on deposit.
- Pay all remaining costs, surcharges and assessments. To be taken out of bail which was previously posted and is on deposit. *The remainder of bail money, if any, shall be returned to the person who posted it.
