On December 29, 2007 my car was towed by the City of Milwaukee Police. It was towed and impounded to the City of Milwaukee Tow Lot at 3811 W. Lincoln Avenue until January 7, 2008. On January 7, 2008 I paid \$275.00 of towing and storage fees and reclaimed my car. Upon receiving my vehicle I notice that it was damaged and there were several personal items missing. It was so obvious to notice first that both custom backlights were completely missing, leaving only cords with the light bulbs hanging from the outside of the car. Inside the car there were 2 5inch TVs missing out of both headrests. In the trunk of the car there was a 2,000 watts amp along with an epicenter that was also missing. All of these items were apart of the car before towing and since the last time I saw my car. All of these items were also very personal to me and to know that they were stolen is unacceptable. Since January 7, 2008 the day I retrieved my car due to these wrongful actions I am unable to drive my car because of the missing back lights. Before my car was towed it was definitely drivable without damage but now I have to use other means of transportation. I am holding the City of Milwaukee Tow Lot responsible for the theft and damage that has occurred to my vehicle. I am going to take all of the necessary actions to assure that the theft and damage to my car is recognized, brought to justice and will not take place again.
